1	AN ORDINANCE relating to the King County
2	Comprehensive Plan; and amending Ordinance 263, Article 2,
3	Section 1, as amended, and K.C.C. 20.12.010 and Ordinance
4	13147, Section 30, as amended, and K.C.C. 20.18.140.

7	STATEMENT OF FACTS:
8	1. King County has adopted the 2004 King county Comprehensive Plan to
9	meet the requirements of the Washington state Growth Management Act
10	("GMA"), chapter 36.70A RCW.
11	2. The King County Code allows amendments to the Comprehensive Plan
12	once every year if those amendments are not substantive. Every four
13	years a major review of the Comprehensive Plan is allowed at which time
14	substantive amendments to the Comprehensive Plan can be considered.
15	The last major review of the Comprehensive Plan was conducted in 2004.
16	Therefore, 2006 is part of the annual cycle for which only amendments to
17	the Comprehensive Plan that are not substantive are permitted.

18	3. The GMA requires that the Comprehensive Plan and development
19	regulations be subject to continuing review and evaluation by the county.
20	4. The GMA requires that development regulations be consistent with and
21	implement the Comprehensive Plan.
22	5. The amendments to the Comprehensive Plan contained in this
23	ordinance bear a substantial relationship to, and are necessary for, the
24	public health, safety and general welfare of King County and its residents.
25	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
26	SECTION 1. Ordinance 263, Article 2, Section 1, as amended, and K.C.C.
27	20.12.010 are each hereby amended to read as follows:
28	Comprehensive Plan adopted.
29	A. Under the King County Charter, the state Constitution and the Washington state
30	Growth Management Act, chapter 36.70A RCW, the 1994 King County Comprehensive
31	Plan is adopted and declared to be the Comprehensive Plan for King County until
32	amended, repealed or superseded. King County performed its first comprehensive four-
33	cycle review of the Comprehensive Plan. As a result of the review, King County amended
34	the 1994 Comprehensive Plan through passage of the King County Comprehensive Plan
35	2000. King County performed its second comprehensive four-cycle review of the
36	Comprehensive Plan in 2004. As a result of the review, King County amended the 2000
37	Comprehensive Plan through passage of the King County Comprehensive Plan 2004. The
38	Comprehensive Plan shall be the principal planning document for the orderly physical

development of the county and shall be used to guide subarea plans, functional plans,

40	provision of public facilities and services, review of proposed incorporations and
41	annexations, development regulations and land development decisions.
42	B. The amendments to the 1994 King County Comprehensive Plan contained in
43	Appendix A to Ordinance 12061 (King County Comprehensive Plan 1995 amendments)
44	are hereby adopted.
45	C. The amendments to the 1994 King County Comprehensive Plan contained in
46	Attachment A to Ordinance 12170 are hereby adopted to comply with the Central Puget
47	Sound Growth Management Hearings Board Decision and Order in Vashon-Maury Island,
48	et. al. v. King County, Case No. 95-3-0008.
49	D. The Vashon Town Plan contained in Attachment 1 to Ordinance 12395 is
50	adopted as a subarea plan of the King County Comprehensive Plan and, as such, constitutes
51	official county policy for the geographic area of unincorporated King County defined in the
52	plan and amends the 1994 King County Comprehensive Plan Land Use Map.
53	E. The amendments to the 1994 King County Comprehensive Plan contained in
54	Appendix A to Ordinance 12501 are hereby adopted to comply with the Order of the
55	Central Puget Sound Growth Management Hearings Board in Copac-Preston Mill, Inc., et
56	al, v. King County, Case No. 96-3-0013 as amendments to the King County
57	Comprehensive Plan.
58	F. The amendments to the 1994 King County Comprehensive Plan contained in
59	Appendix A to Ordinance 12531 (King County Comprehensive Plan 1996 amendments)
60	are hereby adopted as amendments to the King County Comprehensive Plan.
61	G. The Black Diamond Urban Growth Area contained in Appendix A to Ordinance
62	12533 is hereby adopted as an amendment to the King County Comprehensive Plan.

63	H. The 1994 King County Comprehensive Plan and Comprehensive Plan Land
64	Use Map are amended to include the area shown in Appendix A of Ordinance 12535 as
65	Rural City Urban Growth Area. The language from Section 1D of Ordinance 12535 shall
66	be placed on Comprehensive Plan Land Use Map page #32 with a reference marker on the
67	area affected by Ordinance 12535.
68	I. The amendments to the 1994 King County Comprehensive Plan contained in
69	Appendix A to Ordinance 12536 (1997 Transportation Need Report) are hereby adopted as
70	amendments to the King County Comprehensive Plan.
71	J. The amendments to the 1994 King County Comprehensive Plan contained in

82	Ordinance 13339 is hereby adopted as an amendment to the 1994 King County
83	Comprehensive Plan, Technical Appendix C, and the amendments to the 1994 King
84	County Comprehensive Plan contained in Attachment B to Ordinance 13339 are hereby
85	adopted as amendments to the King County Comprehensive Plan.

86	N. The amendments to the 1994 King County Comprehensive Plan contained in
87	Attachment A to Ordinance 13672 (King County Comprehensive Plan 1999 amendments)
88	are hereby adopted as amendments to the King County Comprehensive Plan.
89	O. The 2000 Transportation Needs Report contained in Attachment A to this
90	Ordinance 13674 is hereby adopted as an amendment to the 1994 King County
91	Comprehensive Plan, Technical Appendix C.
92	P. The Fall City Subarea Plan contained in Attachment A to Ordinance 13875 is
93	adopted as a subarea plan of the King County Comprehensive Plan and, as such, constitutes
94	official county policy for the geographic area of unincorporated King County defined in the
95	plan. The Fall City Subarea Plan amends the 1994 King County Comprehensive Plan land
96	use map by revising the Rural Town boundaries of Fall City.
97	Q. The amendments to the King County Comprehensive Plan contained in
98	Attachment A to Ordinance 13875 are hereby adopted as amendments to the King County
99	Comprehensive Plan.
100	R. The Fall City area zoning amendments contained in Attachment A to Ordinance
101	13875 are adopted as the zoning control for those portions of unincorporated King County
102	defined in the attachment. Existing property-specific development standards (p-suffix
103	conditions) on parcels affected by Attachment A to Ordinance 13875 do not change except
104	as specifically provided in Attachment A to Ordinance 13875.
105	S. The amendments to the 1994 King County Comprehensive Plan Land Use Map
106	contained in Attachment A to Ordinance 13987 are hereby adopted to comply with the
107	Central Puget Sound Growth Management Hearings Board Decision and Order on

SECTION 2. Ordinance 13147, Section 30, as amended, and K.C.C. 20.18.140 are each hereby amended to read as follows:

### Provision for receipt, review of and response to the docket.

A. In accordance with RCW 36.70A.470, a docket containing written comments on suggested plan or development regulation amendments shall be coordinated by the department. The docket is the means either to suggest a change or to identify a deficiency, or both, in the Comprehensive Plan or development regulation. For the purposes of this section, "deficiency" refers to the absence of required or potentially desirable contents of the Comprehensive Plan or development regulation and does not refer to whether a development regulation addressed a project's probable specific adverse environmental impacts that could be mitigated in the project review process. Any interested party, including applicants, citizens and government agencies, may submit items to the docket.

B. All agencies of county government having responsibility for elements of the Comprehensive Plan or implementing development regulations shall provide a means by which citizens may docket written comments on the plan or on development regulations. The department shall use public participation methods identified in K.C.C. 20.18.160 to solicit public use of the docket. The department shall provide a mechanism for docketing amendments through the Internet.

222	1. All docketed comments relating to the Comprehensive Plan shall be reviewed
223	by the department and considered for an amendment to the Comprehensive Plan.

- 2. The deadline for submitting docketed comments is September 30 for consideration in the amendment cycle process for the following year.
- 3. By the first business day of December, the department shall issue an executive response to all docketed comments. Responses shall include a classification of the recommended changes as appropriate for either the annual or four-year cycle, and an executive recommendation indicating whether or not the docketed item(s) are to be included in the next year's executive recommended comprehensive plan update. If the docketed changes will not be included in the next executive transmittal, the department shall indicate the reason(s) why, and shall inform the proponent that they may petition the council during the legislative review process.
- 4. By the first business day of December, the department shall forward to the council a report including all docketed amendments and comments with an executive response. The report shall include a statement indicating that the department has complied with the notification requirements contained in this section.
- 5. Upon receipt of the docket report, the council shall ((mail written notice to)) include all proponents of docketed requests ((containing the council review process for the current year, and informing proponents that they may petition the council to consider docketed changes that were not recommended by the executive. This notice)) in the mailing list for agendas to all committee meetings in which the Comprehensive Plan will be reviewed during the next available update. At the beginning of the committee review process, the council shall ((include the)) develop a committee review schedule ((of)) with

dates for ((public hearings,)) committee meetings((;)) and any other opportunities for public
testimony ((on the current year's Comprehensive Plan update)) and for proponents to
petition the council to consider docket changes that were not recommended by the
executive and shall attach the review schedule to the agenda whenever the Comprehensive
Plan is to be reviewed.

- 6. Docketed comments relating to development regulations shall be reviewed by the appropriate county agency. Those requiring a Comprehensive Plan amendment shall be forwarded to the department and considered for an amendment to the Comprehensive Plan. Those not requiring a Comprehensive Plan amendment shall be considered by the responsible county agency for amendments to the development regulations.
- 7. The docket report shall be made available through the Internet. The department shall endeavor to make the docket report available within one week of transmittal to the council.
- C. In addition to the docket, the department shall provide opportunities for general public comments both before the docketing deadline each year, and during the executive's review periods before transmittal to the council. The opportunities may include, but are not limited to, the use of the following: comment cards, electronic or posted mail, Internet, public meetings with opportunities for discussion and feedback, printed summaries of comments received and twenty-four-hour telephone hotlines. The executive shall assure that the opportunities for public comment are provided as early as possible for each stage of the process, to assure timely opportunity for public input.

266 SECTION 3. Severability. 



### REGIONAL TRAILS NEEDS REPORT

2006-114

### Introduction

The Growth Management Act requires each jurisdiction's comprehensive plan to contain a transportation element which includes the identification of current and future transportation needs. King County's Regional Trail System is an integral part of the county's non-motorized transportation system forming a system not unlike the road system with major arterials (regional trails) connected by secondary arterials and neighborhood streets (community trails). These trails provide connections between cities, employment centers and recreational destinations and facilities. The system is provided with additional connections for non-motorized circulation by the Roadshare Program of King County's Transportation Department.

The King County Regional Trail system is one of the largest county trail systems in the country. The current system includes more than 175 miles of improved multi-purpose trails with plans for more than 100 additional miles of regional trails to accommodate walkers, cyclists, equestrians and others. The system reaches from the northern to the southern borders of the county and provides connections from urban areas in the western portion of the county to the state trail system in the eastern portion of the county that reaches to the eastern border of the state.

The regional trail system has evolved over many decades through numerous planning efforts that built upon the steady expansion of the system. These include the early <u>Urban Trail Plan</u> of 1971, <u>King County Regional Trail Plan</u> of 1992 and the 2004 <u>Regional Trail Inventory and Implementation Guidelines</u>. Regional trail elements are also found in the 1985 Open Space Plan, 1996 <u>King County Park and Open Space Plan</u> and the 2004 <u>King County Open Space Plan</u>: Parks, Trails, Natural Areas and Working Resource Lands. Trail plans may also be found in the historical community plans and master plans for individual trails.

### What is the REGIONAL TRAILS NEEDS REPORT?

The Regional trails Needs Report is a comprehensive list of recommended improvements or additions to complete and upgrade the network of regional trails serving transportation purposes the county as identified in a number of adopted county plans. This is a planning level document and in most cases further detailed study will be required to determine if projects are feasible from environmental, financial or other cost-benefit perspectives and to determine specific design requirements for each project.

### Purposes of the REGIONAL TRAILS NEEDS REPORT?

The Regional Trails Needs Report assists King County in making decisions on planning and funding regional trail improvements. It establishes an important link between the plans and the annual programming of the capital funds in the county's capital improvement budget for regional trail acquisition and development. The capital improvement program sets the program for phasing projects and programming funds.

### How to use this document

The regional trail projects included on this list are organized by individual trail, such as the Cedar River or Soos Creek Trails. This is followed by information on the location and scope of each trail project. The projects are identified by a letter and number that corresponds to the map showing the general area of the project. In some cases, where acquisitions or technical analysis have not been completed, projects are located on the map in general locations.

### Financing the Regional Trail System

The regional trail system is funded with a combination of county Real Estate Excise Tax funds, grants and partnerships with other jurisdictions. Funding forecasts are based on projections for the Real Estate Excise Tax revenues and grant funding, both of which are subject to economic and market conditions. The regional trail system is a major regional service of the county. The 2006 appropriation for trail funding is roughly \$8 million and is anticipated to be within a similar range over the life of the 6 year capital improvement budget.



Proposed Trails King County Park System Incorporated Area








