Background

The King County Drug Diversion Court (KCDDC) was implemented in August 1994, the twelfth drug court in the country. Currently, there are drug courts in every state and 3,000 nationwide. Since KCDDC's inception, 2,256 people have graduated from the program.

The KCDDC provides eligible defendants charged with felony drug and property crimes, the opportunity for drug treatment and access to other ancillary services such as mental health treatment, housing, transportation and job skills training. Eligible defendants can elect to participate in the program or proceed with traditional court processing. After choosing to participate in the program, defendants come under the court's supervision and are required to attend treatment sessions, undergo random urinalysis, and appear before the KCDDC judge on a regular basis. If defendants meet the requirements of each of the four phases of KCDDC, they graduate from the program and their charges are dismissed. If defendants fail to make progress they are terminated from the program and sentenced on their original charge. Successful participants take an average of 15 months to complete the program.

KCDDC Services

- Outpatient and residential treatment.
- Opiate Maintenance Therapy.
- A 60-day in-custody, certified treatment program at the Maleng Regional Justice Center.
- Specialized treatment for young people ages 18 to 24.
- Gender-specific and culturally-specific treatment.
- Housing transitional and permanent.
- On-site case management to assist with housing, education, employment, dental/medical and other needs.
- Transportation tickets and ORCA passes.

Benefits of King County Drug Court

- Drug Court saves incarceration costs.
- Other benefits include:
 - Reduction in public health costs.
 - Reduction in economic costs (lost productivity, unemployment, workplace accidents and absences).
 - Reduction in social welfare costs (child abuse and neglect, domestic violence).
 - Reduction in costs relating to drug use (e.g. fetal alcohol syndrome, IV drug related HIV, hepatitis C)

Profile of the Population Served by KCDDC

Overall high risk, high need offenders have a poorer prognosis for success in standard rehabilitation treatment programs and require more concentrated and sustained interventions to dislodge their entrenched maladaptive behaviors (Marlowe, 2012).

A breakdown of the characteristics of drug court participants who opted into drug court further illustrates the high risk and high need nature of the KCDDC population. *Data below includes only participants on whom data was available.
