1. Welcome

Each person present introduced themselves and stated their affiliation.

Deputy King County Executive Fred Jarrett and King County Councilmember Kathy Lambert welcomed and thanked the Public Defense Advisory Board (PDAB) members. Mr. Jarrett noted the county's record for a strong public defense system and the ability for the new structure to extend and improve the opportunities for public defense clients.

Ms. Lambert acknowledged the depth and breadth of knowledge of individual PDAB members and the PDAB as whole. She is looking forward to working with the PDAB, the Public Defender, and the Executive to make sure we are working towards the best interests of our clients.

5. Election of Chair

a. Chair / Vice Chair Elections

The floor was opened for nominations for PDAB Chair. Judge Armstrong noted the ability of any member of the PDAB to serve as Chair and recommended that the Chair be held by someone on the 3 –year term. Judge Armstrong proceeded to nominate Marc Boman. Kim Ambrose seconded the nomination. There were no other nominations and a voice vote was held. The nomination carried with a unanimous vote.

PDAB members agreed to elect a Vice Chair. Jeffery Robinson nominated John Straight. Judge Armstrong seconded the nomination. There were no other nominations and a voice vote was held. The nomination carried with a unanimous vote.

b. Bylaws

The bylaws drafted by staff were reviewed by the members with the intent to finalize once all members had an opportunity to review and recommend edits. Discussions were held about the following topics:

- ARTICLE 1 PURPOSE: Recommended edits to include "highest quality of performance and independence"
- ARTICLE 3 VOTING: Staff was requested to research whether there were any provisions in County Code against proxy votes. (Action)
- Possible insertion to clarify KCC 2.60.031 (B) "...The board through its chair shall consult with the county prosecutor, courts, and department of public defense in the performance of all of its duties except for the recommendation of candidates." Discussions included
 - recommendation for a board member to consult with courts & PAO;
 - recommendation that Chair provide the Prosecuting Attorney and the Presiding Judge with minutes from PDAB meetings

Members will provide chair and staff with requests for modifications via email and the proposed changes will be discussed at the next scheduled PDAB meeting.

6. Public Defender Recruitment

King County Human Resources Division Director Nancy Buonanno Grennan, Karras Consulting CEO Dennis Karras and Vice President Marissa Karras reviewed the recruitment schedule, announcement, and strategy with PDAB members. Edits were recommended to highlight requirements for the Public Defender:

- Commitment to protecting the constitutional rights of clients;
- Ability for innovation;
- Ability to advocate for funding and other resources.
