Proposition No. 1

Replacement of Existing Educational Programs and Operations Levy

The Board of Directors of Lake Washington School District No. 414 adopted Resolution No. 2162 concerning educational funding. This proposition authorizes the District to levy the following excess taxes, to replace an expiring levy, on all taxable property within the District, to support the District's educational programs and operations:

Statement in favor

Vote Yes! We Need Qualified Teachers to Educate Tomorrow's Workforce.

Explanatory statement

Lake Washington School District requests voter approval of an Educational Programs and Operations levy to enable the District to pay for its educational programs and services, including teaching and non-teaching staff costs (salaries), instructional materials, safety & security services, transportation, facility maintenance, special programs, activities and sports, technology systems operation, and other non-capital expenses of operating the District schools. The proposed levy will replace the District's current levy that expires in 2014. These taxes will provide approximately 22% of the general expense of operating the District.

Passage of this proposition would allow the levy of \$63,000,000 in property taxes for collection in 2015, the levy of \$64,900,000 for collection in 2016, the levy of \$66,800,000 for collection in 2017, and the levy of \$68,900,000 for collection in 2018. If authorized by the voters and based on current assessed valuation information, estimated levy rates per \$1,000 of assessed value would be \$1.85 (2015 collection); \$1.88 (2016 collection); \$1.90 (2017 collection); \$1.92 (2018 collection). The exact levy rate shall be adjusted based upon the actual assessed value of the property within the District at the time of the levy.

Statement in opposition

Union officials in the Lake Washington Schools have pressured the school board to divert levy funds from student services in order to pay teachers more. Our levy should pay for student services, not for wage increases.

In the collective bargaining agreement sought by union officials, the average state-provided wage of \$49,750 for teachers will be enhanced by 14 percent from levy and levy-matched funds. This costs roughly \$9.3 million per year which could be better used to help at-risk students or reduce class sizes. The school district leads taxpayers to believe the levy money is being used for students, yet large amounts support union priorities instead.

Levies are great for funding local priorities and unique services for our area students, but taxpayers should hold off giving the school district any more money until the school board is able to put student services above the demands of union officials.

Rebuttal of statement in opposition

This measure renews an existing levy. We depend upon these local monies to meet 22.8% of the district's annual budget because the state does not fully fund Basic Education. Explanatory statement

Lake Washington School District requests voter approval of a Capital Projects levy to enable the district to pay for improvements and upgrades of district facilities, for technology improvements, and equipment and training to meet the current and future educational programs for its students. The proposed levy will replace the District's current levy that expires in 2014 and the taxes would be deposited in the Capital Projects Fund to pay for safety and security items; replacement of aging major building systems such as roofs and heating systems; replacement computers; upgraded server and network infrastructure; instructional and assessment software; and technology support for over 28,000 staff and student computers.

Passage of this proposition would allow the levy of \$31,200,000 in property taxes for collection in 2015, the levy of \$31,500,000 for collection in 2016, the levy of \$32,000,000 for collection in 2017, and the levy of \$32,500,000 for collection in 2018. If authorized by the voters and based on current assessed valuation information, estimated levy rates per \$1,000 of assessed value would be \$0.91 (2015 collection); \$0.91 (2016 collection); \$0.91 (2017 collection); \$0.91 (2018 collection). The exact levy rate shall be adjusted based upon the actual assessed value of the property within the District at the time of the levy.

General Obligation Bonds - \$755,000,000

The Board of Directors of Lake Washington School District No. 414 adopted Resolution No. 2164 concerning this proposition for bonds. This proposition authorizes the construction and equipping of new schools (three elementary, one middle, two choice); the modernization/ replacement of schools (Kirk, Mead, Rockwell Elementary; Evergreen and Kamiakin Middle; and Juanita High); additions to schools (Lake Washington and Eastlake High); and other capital improvements; the issuance of \$755,000,000 of general obligation bonds maturing within a maximum of 20 years, and the levy of excess property taxes annually to repay the bonds, as provided in Resolution No. 2164. Explanatory statement

Lake Washington School District requests voter approval to sell \$755,000,000 in general obligation bonds to finance renovations, upgrades and new construction of school facilities, including elementary, middle and high school buildings and construct new replacement school buildings in the District. Projects include acquiring, constructing and equipping new schools to accommodate an expected increase in enrollment of 4,000 students over the next eight years including three new elementary schools, a new middle school, an East Side internationally focused secondary school, a West Side STEM (science, technology, engineering and mathematics) focused secondary school, an addition to Lake Washington High School, an addition to Eastlake High School; and modernizing and replacing (including equipping) Juanita High School, Evergreen Middle School, Kamiakin Middle School, Kirk Elementary, Mead Elementary and Rockwell Elementary. The bonds would be repaid out of annual property tax levies over a period of up to 20 years. The exact amount of such annual levies for these bonds would depend on the amount of principal paid each year and on the interest rates available at the time the bonds are sold.

Statement in opposition

We support quality facilities equitably provided to *all* our students and teachers. We oppose this bond measure because it buries us in debt, unfairly builds palaces for some, and leaves thousands in portables and substandard buildings.

The owner of a median-priced (\$424,000) home already pays \$560/year for bonds to modernize our schools. *All* of our schools could have been remodeled with this money.

Using unaudited estimates contrived to show it was cheaper to rebuild than remodel schools, LWSD needlessly demolished 20 of them instead. The district now wants *another* \$755M.

Almost \$400M is earmarked to needlessly rebuild 6 more schools newer than many of our homes. 12 substandard schools will still be left unmodernized for years.

Less than \$300M is earmarked to build new schools and additions to partially handle growth. Thousands will remain in portables for years. Over \$100M is reserved for sites and contingencies.

This bond measure will add \$750/year to a median-priced home's school taxes. Overall property tax bills will go up almost 20%. Little borrowing capacity remains for future needs.

This extravagant and inequitable proposition funds a deeply flawed facility plan! It should be *rejected*!

Requirements

To register to vote in Washington, you must be:

- · A citizen of the United States;
- A legal resident of Washington State;
- · At least 18 years old by Election Day; and
- Not under the authority of the Department of Corrections.

How to register

- Register online with the Secretary of State, www.vote.wa.gov.
- Download a registration form from the King County Elections website and return it by mail.
- Register in person at the King County Elections office or annex.

Registration deadlines

While you may register to vote at any time, there are registration deadlines prior to each election. The deadlines for the February 11, 2014, special election:

- January 13 Deadline to register to vote online or by mail, or update existing voter registration information.
- **February 3** In-person registration deadline for people not currently registered in Washington. Register in person at the Elections office in Renton or at the Voter Registration Annex in Seattle.

Keep your voter registration current

Update your registration if you have moved or changed your name, or if your signature has changed. Simply submit a new registration form to update your information.

Voting materials available in Chinese and Vietnamese

To comply with Section 203 of the Federal Voting Rights Act, King County is required to provide voting materials in Chinese and Vietnamese. To request voting materials, update your language preference or register to vote, visit www.myvote.wa.gov or call 206-296-VOTE (8683).
