Project Description: To elevate approximately a 630-foot section of NE 165th Street up to 1.85 feet in order to prevent road closer and other safety hazards due to frequent flooding for the road in the past.

Permits requested in this application: Shoreline Substantial Development permit and Grading permit

SEPA Threshold Determination was issued by King County Department of Transportation (KCDOT) on July 26, 2017. The KCDO determined that the proposal was exempt under SEPA and in accordance with WAC197-11-800(2)(viii).

Consistency with applicable County plans and regulations: This proposal will be reviewed for compliance with all applicable King County Codes, including Roads Standards, Surface water Design Manual, Zoning, Grading and Critical Areas Codes.
