09/18/2017	Inquiry	Excessive Use of Force	Complainant assaulted officers while attempting to escape arrest. He was allegedly "socked over and over in the face" by one of the deputies.	<b>Exonerated</b>	N/A
09/13/2017	Inquiry	Excessive use of Force-  Failure to report use of force as required...-  Appropriate Use of Authority	Complainant resisted arrest and was taken to the ground and handcuffed. Complainant later denied resisting arrest and alleged the deputy had no reason to use force on him.	Excessive use of Force- Failure to report use of force as required...- Appropriate Use of Authority <b>Exonerated</b> (all allegations)	N/A
09/27/2017	Inquiry	Appropriate Use of Authority-  Excessive Use of Force	Complainant fled the scene, forcing the deputy to use a taser to stop him. The complainant alleges the deputy did not have a right to stop him because he was doing nothing wrong.	<b>Exonerated</b> (both allegations)	N/A
