







Reactivated Case

Resolution

Suspended Case

Suspense Status

A case is on suspense status if it is on warrant, appeal, stay, mediation, arbitration ("Deferred Prosecution" is not a suspense status, but is treated as a resolution).

Suspense Time

Time (days) that a case is on suspense status before its resolution. If a case has more than one suspense between filing and resolution, the suspense time is the total from all suspense. Time on suspense status after resolution (e.g., appeals) is not counted.
