1. Call to Order

Chair Schindler called the meeting to order at 7:04 p.m.

Staff reviewed updates to the draft two-phase community outreach plan with the committee including the 20 proposed meetings to be held over the summer as part of phase 1. Committee members provided input and directed staff to begin scheduling the meetings. Chair Schindler noted the plan will continue to be updated as needed. Member Danenberg moved approval of the community outreach plan. Member Jackson-Williams seconded the motion. The motion carried unanimously.

6. Detailed overview of the current Council Districts

Using OFM data, the Districting Master provided a detailed overview of each Council District including information such as boundary changes since 2010, the city, unincorporated and agricultural composition of each district, racial and ethnic population composition, linguistically isolated communities, percent foreign born, percent living in poverty and whether or not the district must expand or contract based on current population estimates.
