


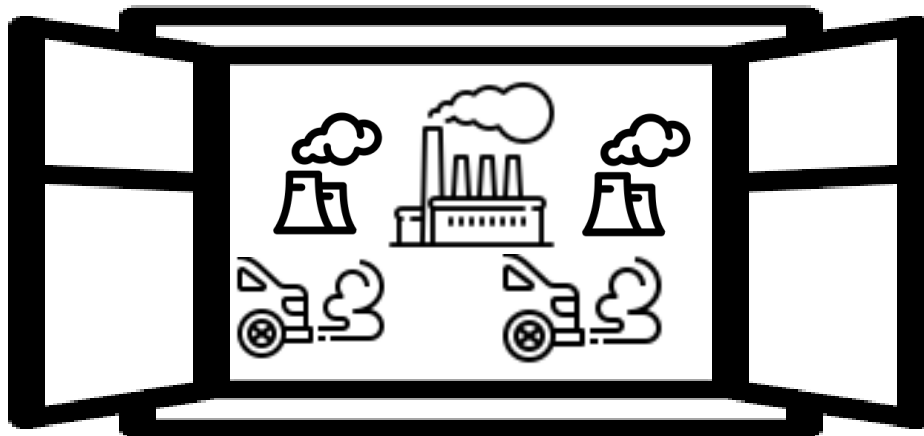


## NIMEOCHUN ENIENIN ASEPWANNIN NON IMW MI AUCHEA

# EKKEWE SAIPE MI FILTER MI TONGENI ANISI ENIENIN NON IMW AN EPWE NIMEOCH

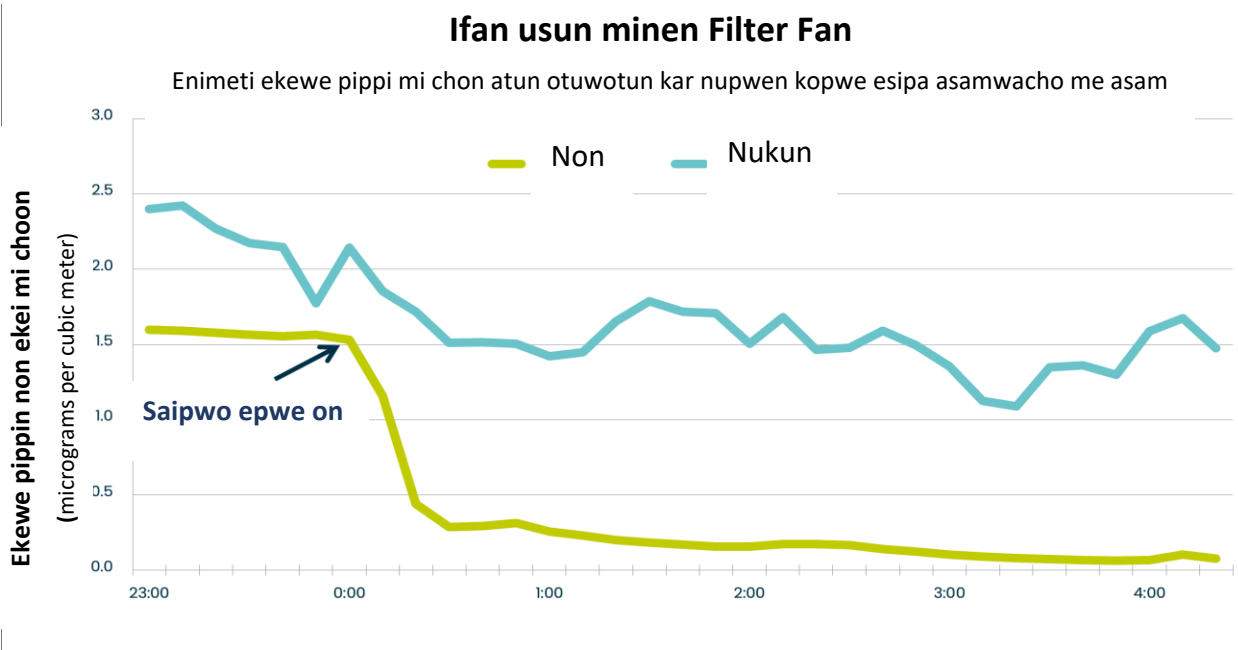
Ika ke aea ekkewe mwesinnen nimeti asepwannin non imw (ika indoor air filtration systems) mi tongeni pwe watteeno nimeochunoon enienin neimw me ekukkunaano mecheresin om kopwe semmwen.

Ew anen om kopwe nimeti enienin asepwannin non imomw nge epwe chok niwin kukkun om kopwe aea ewe box fan me ew furnace filter. Ekkei "saipse mi filter" (ika "filter fans") mi tongeni filter-ini ekkewe kukkunun nimengawen non asepwan ekkewe re kan kon nom non etuwetin watteen kkar me ekkei seni emuch, fengen me pwan menun semmwen, mold, me taas minne e kan feito seni angang fetan non imw, epwe tongeni ekisaatiw efeiengawen nimengawen enien neimw minne mi efisi semmwen.



Ekkewe filter fans re kusuraau asepwan non ewe furnace filter, taas mi mwechuno, pollen, me pwan ekkoch nimengaw pwe asepwan mi nimeoch epwe tongeni kus seni ewe saipse!

Puget Sound Clean Air Agency mi euku ukuukun pechokkunen ekkei filters iwe ra kuna pwe mi tongeni ekisaano 90% ekkewe sakkopaaten nimengawen non asepwan.

Pokiten osukosuken met ei a fis non ekkei fansoun ren kokkotun fan nang (ika climate change) me nikinikin ach angang mi angawaano ekkewe ira watteen nepononon (ika forest), watteen kkar non summer a ew mettoch mi sou fiffis iteitan.

Ekkei filter fan kits, nupwen repwe tumun ren an enienin neimw epwe nimeoch, mi tongeni anisuk an epwe nimeoch enienin non rummom non imomw nupwen an fis ekkei kkar watte.

## EUREUREN IFA USSUN AEAN EWE FILTER FAN

Ei box fan filter kit ew anen an epwe ekisaano osukosuken ekkewe etuwetun kkar watte nge mi chok niwin kukkun. Iwe nge, ekkewe box fans rese ffeer ar repwe aea ngeni MERV-13 furnace filter iwe esaamwo wes angangen cheki ika epwe wor ika esap wor efeingawan me ren ewe Underwriter's Laboratory (ewe kompenien chek mi imuuno minne ekan cheki ika epwe wor efeingawen ekkewe sakkopaaten minen aea). Ese wor ekkewe trip wire ika ekkewe minen an ekkewe box fan repwe pusin keuno ika a kon nuuno pwichir nupwen epwe wor aear murin an pacheta ewe MERV-13 furnace filter ikewe ie ewe saipe ekan kusufaanong asepan ia.

Inaamwo an ese mwo wor repot won ika mi wor osukosuk nupwen emon epwe aea ekkewe box fans mi fiti filter, ese mwo wessen wor angangen cheki ina pwata ese mwo ffat ika epwe wor ena osukosuken an epwe kon nuuno pwichikaran. Mi fakkun auchea an epwe wor angangen tumuneochun aean ewe box fan mi fiti filter ina weween ekkei pesepes mi affat faan:

- Aea ewe saipe non ewe rum ke sou nom non.
- Onomu ewe saipe nukanapen ewe rum, towaw seni etip me mettoch mi watte. Kesap onomu ewe saipe epwe kane ngeni neeni mi wor taas ia ika mi nimengaw pun ewe saipe ete achanga fetanei taas non asepan.
- Esipa meinisin asam mwacho me asam nupwen om aea ewe saipe Ewe saipe mi filter ese tongeni nimeti non asepan ika pwe nimengawen asepannin nukun mi chok niwinnong non ewe imw.
- Ren an esapw wor feingawen fiifi, kesap aea ewe saipe non bathroom ika unukkun ia e wor ia konik.

- Ekkewe filters epwe wor "MERV-rating" 13 (ekkewe 20x20x1 inis filters ir mi eoch ngeni ei box fan unit).
- Ekkewe box fans mi iei ussun aear repwe minafe seni minen non 2012 nupwen an feer sefan motaan kewe (ika motor) an epwe ekisaano feingaw ika a kon pwich ewe saipe.
- Atowaawa ewe box fan filter seni semirit.
