Sheegashadaada waxaa loo fayl gareeyey xafiiska Qiimeeyaha Degmada King ee canshuurta in la bixiyo ah **2019** sida looga baahan yahay RCW 84.36-381 to 387. Wuxuu qaadan dhower toddobaad laakiin waxaad ku heli doontaa ogeysiis muddo 5 maalmood gudahood ah oo xaqijinaya helitaanka codsigaaga.

### LAMBARADA HOOS WAXAY LA XIRIIRAAN QAYBAHA CODSIGA

Isticmaal liiska eegida hoos ku qoran si hage ah. Bixinta dhammaan dukumiintiyada loo baahan yahay waxay degdegsineysaa ansaxinta codsigaaga. Lambarka 1 iyo 2: Buuxi 2-da qaybood oo ku yaal xagga hore ee codsigan iyo ku lifaaq dukumiintiyada tilmaamaya:

Kaliya caymiska assaasiga ah ee Daryeelka Caafimaadka (Medicare) ee hoos yimaada Qodobka XVIII ee sharciga amniga bulshada ama qimaha lagu bixiyo kharashka daawada dhakhtarka uu qoray ee aan la soo celin ayaa loo oggol yahay ka dhimis caafimaadeed. Qorshaha ilkaha, qorshaha caymiska dhereadka ah, qorshaha indhaha, siyaasaddaha caymiska ee shirkadaha UMA qalmaan.

Haddii codsigaaga la ansixiyo, qimaha canshuurtaada waxaa lagu joojin qimaha suuqa sanadka koowaad ee u qalmidda.
