SUBJECT: Observations on Facilities Management Division Staffing and Human Resource Issues

Your office has requested a briefing to several departments on human resources issues we recently discussed with the Facilities Management Division's (FMD) director and deputy director. Our observations relate to staffing and job classification specific to FMD's Capital Planning and Development Section.

In November 2011, our office published a special study on FMD's capital project delivery management of maintenance, rehabilitation, and parks projects. This project was a special study completed at the request of the County Council by the Capital Projects Oversight Program within our office. The study's scope was limited and it is not an audit.

In the course of conducting this special study, we observed inconsistencies with FMD's use of the capital project manager classification series that were tangential to our study scope. We did not have the resources to analyze the issue fully. However, we believed our observations could be useful to FMD management. In sharing them with FMD and others, we wish to reiterate that they are observations for management's consideration. These observations should not be construed as audit findings and recommendations.

The following two issues were identified. First was that 17 of the 19 capital project manager positions in the Capital Planning and Development Section are classified as Level IV and two were Level II. Given that FMD projects ranged in size and complexity and half are estimated to cost less than \$300,000, we questioned the reason for the concentration at the most senior level of the job series. Secondly, we identified inconsistencies with the capital project manager IV classification description, including that the supervisory duties at the IV level were not required of FMD's senior capital project managers.
