STAFF REPORTS

KING COUNTY DEVELOPMENTAL DISABILITIES AND EARLY CHILDHOOD SUPPOORTS (DDECDS) DIVISION DIRECTOR'S REPORT

Liz Snow, DDECSD announced the next King County Interagency Coordinating Council Meeting is scheduled for October 8, 2021, from 10:00 a.m. to 12:00 p.m. and the Early Supports for Infants and Toddler (ESIT) updates.

The ESIT team recently closed a work force provider survey. Details on the survey included:

- Input from 462 providers who work with contracted ESIT.
- The purpose was to gather data to help staff to encourage, support and hold each provider, so they can thrive in their role and continue a career with ESIT.
- Over the next two months, staff will analyze the results and will share information back to ESIT agencies in 2021.

The Infant and Early Childhood Mental Health Group:

 In September, staff held a training entitled Observing as Witnessing, Clinical Observations of the Parent-Child Relationship. The purpose of this training was to support the power of observation and bearing witness when working with babies and caregivers.

Susy Stremel, DDECSD provided the following updates from the Adult Services Team:

- The Adult Services Team is working with service providers, stakeholders and system partners to provide stability and sustainability issues caused by the pandemic. One issue entails the hourly fee for services that employment provides can charge. This fee has not increased in over ten years making it difficult for employment providers to support participants in their jobs, especially now when people are returning to work and placing additional stress on job coaches.
- The Adult Services team is looking at the hourly fee for service rate and working toward making the hourly fee for service more sustainable.

• There was a recent extension of a higher rate reimbursement for employment and community inclusion providers. That rate has been extended through June of 2022.

Adult Services Team updates:

 Susy acknowledged the work folks are doing within the Employment First goal area work groups.

Holly Woo, DDECDS presented for the Community Information Outreach and Referral (CIOR) Team updates:

- Board members:
 - Three board candidate's applications have been reviewed by the executive's office and forwarded on to the county council for confirmation.
 - Board recruitment continues.
- Legislative Committee meetings:
 - The last Legislative Committee meeting was held on September 23, 2021. The committee members finalized eight potential legislative priorities.
 - Three major areas of focus:
 - Increase housing options, making sure that housing options are accessible, equitable, healthy, safe and affordable.
 - Ensure equitable access and connections to culturally relevant services and resources and community.
 - Invest in workforce development to improve family's access to Early Support for Infants and Toddler services.

The Committee members shared DDECSD honored its commitment to center the voices of people with disabilities, Black, African American, Indigenous and people of color in developing these priorities.

• Holly provided a reminder the division's virtual Legislative Forum will be held on Tuesday, November 9, 2021, from 7:00 - 8:30 p.m.

Magan Cromar, Division Director shared job opportunities within DDECSD.

- The Early Childhood Team is recruiting for a Program Manager III position. This
 position will help support language access with our early childhood work, Deaf, Hard
 of Hearing programs and supports, vision impaired programs and supports, and
 community engagement.
- The Adult Services Team is recruiting for a School-to-Work Program Manager III.

REGIONAL ADMINISTRATOR / FIELD SERVICES REPORT

Merri Snow, Washington State Department of Social and Health Services, Developmental Disabilities Administration provided the following updates:

Waiver Capacity;

- Individual and Family Services Waiver (with 2,435 people currently enrolled);
- Basic Plus waiver (4,187 people currently enrolled);
- Core Waiver (1,769 people currently enrolled);
- Children's Intensive In-Home Behavioral Supports (45 people currently enrolled); and
- Community Protection Waiver, (130 people currently enrolled).

Next month Merri will share about the Consumer Direct Employer program and will provide updates on a new service entitled, Safe In Home.

PRESENTATION - WASHINGTON STATE ABLE SAVINGS PLAN

Peter Tassoni, Washington ABLE savings provided plan highlights.

- ABLE is an acronym: Achieving Better Life Experience
- Any and all funds in an ABLE account is exempted and not counted towards the \$2,000 resource limit. (A tax-free way to grow your money)
- Contributions up to \$15,000 a year, and you don't lose any benefits from the means tested disability benefit programs,

Eligibility:

 Participants receiving Social Security benefits and meets the Social Security definition for disability.

Enrollment

The ABLE Plan is an online entity and at least a \$25 contribution.

Contributions

 Annual limit of \$15,000 per year (Family members, friends, anyone can contribute to the ABLE account).
