 - Four-page Community Summary has been translated into nine languages.
 - Soledad Carrillo, DDECSD is working on next steps.
- In 2021, over 500 Early Childhood providers participated in IECHM trainings.

Gina Solberg, DDECSD provided the following updates from the Adult Services Team:

- Employment Impact Data how the pandemic effected employment.
- Wages are not up to pre-COVID levels.
- Increase in hours worked compared to pre-COVID levels attributed to variety of factors.
- Over a quarter of clients have reported back to work during the months of February through May 2020).
- Over half of clients with low supports are still reporting to work in May 2020.
- Differences in the race/ethnicity of people reporting to work.
- Food service and retail jobs were most common.

Early Childhood Team Updates

- November Training: "Sanando las Heridas del Trauma Migratorio entre madres Latinas" is focused on Spanish speaking providers supporting Latina mothers and the intersection of immigration trauma.
- December 14, 2021, Training: "Conversations about Radical Hope and Radical Healing."

 - Core Waiver/Residential 1, 769 people
 - Children's Intensive Supportive Waiver 47 peoples

- Consumer Direct of Washington (CDWA)
 - Providers will begin in January 2022.
 - King County, Consumer Direct Care of Washington will assume all Individual Providers employer related responsibilities April 1, 2022.

 - Goal: Improve the service request process for consumers and case management staff.
 - Team: Supervisor and 4 to 6 Case Resource Manager (CRM) will cover King to Whatcom County.
 - How: CRMS will focus on financial eligibility, talk to families about services before transferring to long-term CRM.

What is the Legislative Forum?

- Opportunity to educate legislators on issues that are important to the Intellectual and Developmental Disabilities community.
- Legislative Forum's 32nd year.
- Second year presenting a virtual forum.

Where do these priorities come from?

- The Legislative Committee comprised of staff, board members, self-advocates, community members and providers.
- The Legislative Committee informs priorities.
- King County Executive's legislative relations team approves the forum's priorities.

What was different this year?

- Added educational component.
- Listening Sessions.
- Centered on people with disabilities, Black, African American, Indigenous, and People of Color.

- o Conversations began with community feedback.
- Partnered with The Arc of King County and Open Doors for Multicultural Families.

The Committee Process:

- List of actions
- Added the list of actions on how to make it better
- Legislative process provided training
- Presented priorities to the group.
 - Did we get it right? added a fourth committee meeting
 - Were we able to center the voices of BIPOC communities?
 - Did we capture our intent?
 - Does the ask need to change?

Four priorities and Eight requests

- Promote equitable access and connections to culturally relevant services and resources in the community for individual with disabilities and delays of all ages and their families
 - Increase language access.
 - Fund cultural navigation statewide.
 - Invest in a workforce reflective of communities served.
 - o Increase access to recreational, social and other community supports.
- Increase accessible, equitable, healthy, safe, and affordable housing.
- Improve access to ESIT by eliminating families out of pocket costs.
- Invest in employment to support economic recovery and build on state investments in special education.
 - o Increase rate for Employment and Day Program services.
 - Implement the recommendation identified in the state's transition collaborative January 2021 report to improve transition outcomes.
