The Chair reported on a November briefing on climate change and health, that Jeff Duchin, Public Health Officer, provided on the health impacts of climate change.

The Chair also reported on a letter that was submitted to the Washington State Patrol on the Board's behalf in response to the request from Urban Indian Health Institute. The letter requested the State Patrol improve on their work to address the Missing and Murdered Indigenous Women and Girl's Crisis.

2019 accomplishments were discussed along with a survey to Board of Health Members to identify their interests and priorities for the 2020 workplan. There will be an election for the new Chair of the Board at the February Board of Health meeting. Both Boardmember Kohl-Welles and Boardmember McDermott are interested in becoming the new Chair.
