14	justice by reco	ognizing limited access to safe a	and affordable healthcare for immigrants as
15	a systemic pro	blem affecting primarily peopl	e of color, transgender people and people
16	with disabiliti	es, and	
17	WHEF	REAS, King County owns Harb	orview Medical Center, whose primary
18	mission is to p	provide healthcare for the most	vulnerable residents of King County, and
19	does so in a nu	umber of ways including priori	izing care for those who do not speak

20 English and those who are uninsured or underinsured, and

21	WHEREAS, nearly half of all immigrants in the United States, including		
22	documented immigrants, lack health insurance and are less likely to receive preventative		
23	care, care of chronic illness, and gender affirming treatment, and		
24	WHEREAS, people without access to preventative care are more likely to require		
25	hospitalization than people with access to preventative health care, and		
26	WHEREAS, federal law does not currently allow funds to be used to provide		
27	comprehensive health care coverage to all undocumented immigrants through Medicaid,		
28	Children's Health Insurance Program, the Affordable Care Act or state-level health		
29	exchanges except in cases of emergency, and		
30	WHEREAS, Washington state has elected to expand health care access to certain,		
31	limited classes of undocumented immigrants such as people under nineteen years old,		
32	pregnant women, people seeking treatment of emergency medical conditions in a hospital		
33	setting and people seeking treatment for cancer or benign life-threatening tumors, or		
34	dialysis, and		
35	WHEREAS, King County seeks to embrace immigrants as full members of the		
36	community with a right to access culturally appropriate healthcare;		
37	NOW, THEREFORE, BE IT RESOLVED by the Board of Health of King		
38	County:		
39	A. The board of health supports the fundamental human right to access		
40	healthcare, particularly reproductive healthcare, regardless of immigration status or		
41	income.		
42	B. The board of health affirms the belief that government must serve all residents

regardless of immigrant status, ability to pay, country of origin, gender identity, sexual
orientation, race or age.

C. The board of health seeks to expand coverage and lower barriers for all lowincome immigrants who are unable to afford private insurance and unable to access
Medicaid.

D. The board of health asks Public Health - Seattle & King County and UW
Medicine to work with partners to continue to close the gaps in healthcare for immigrants
and refugees.

E. The board of health calls upon state lawmakers, the United States Congress

- 52 and the President of the United States to close gaps in healthcare access for immigrants
- 53 and refugees.
