1 A RESOLUTION adopting the 2019 work plan for the
2 King County Board of Health.

3 WHEREAS, Washington state law vests in the King County Board of Health
4 broad authority and responsibility to protect the health of the people of King County
5 through including, but not limited to, the enactment of rules and regulations, guidelines
6 and recommendations and resolutions to preserve, promote and improve the public
7 health; the prevention and control of contagious diseases; and the establishment of fees
8 for health-related licenses and permits, and

9 WHEREAS, through resolutions the King County Board of Health has adopted
10 annual work programs since 2006 to carry out its responsibilities, and

11 WHEREAS, the priorities set for the King County Board of Health in 2019
12 include: domestic violence and sexual assault prevention; marijuana health and safety;
13 environmental health justice issues; fee-setting; healthy housing; obesity and nutrition;
14 items of interest and emerging issues; and a regional approach to homelessness and
15 housing;




