



#### Reported Tuberculosis (TB) Rates 1993-2020, King County, WA




### Reported TB Cases and Rates, 1993-2020, King County, WA




# Reported TB Cases by King County Region, 2020, King County, WA




## TB Case Rate by City Relative to King County Case Rate, 2020, King County, WA




# Proportion of TB Cases by Sex, 2020, King County, WA




#### TB Case Rates by Sex, 2010-2020, King County, WA












# Proportion of TB Cases by Origin and Race/Ethnicity, 2020, King County, WA








## Proportion of TB Cases by Country of Birth, 2020, King County, WA




### Country of Birth Among Persons Reported with TB, 2010-2020, King County, WA




### Trends in TB Cases among Non-US-born persons, 1993-2020, King County, WA




# Proportion of TB Cases by Disease Site, 2020, King County, WA








## Proportion of TB Cases by Occupation in Past Year, 2020, King County, WA






## Risk Factors Among Persons Reported with TB, 2020, King County, WA




## HIV Coinfection by Age Among Persons Reported with TB, 2010-2020, King County, WA
