1 AN ORDINANCE changing the composition of task force  
2 members to serve on the emergency medical services 2014-  
3 2019 levy planning task force; and amending Ordinance  
4 15862, Section 4.

5 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

6 SECTION 1. Ordinance 15862, Section 4, is hereby amended as follows:

7 A. ~~An ((new))~~ advisory task force, to be called the emergency medical services  
8 advisory task force is hereby established with the goal of developing interjurisdictional  
9 agreement on an updated emergency medical services strategic plan and financing  
10 package for the ~~((next))~~ 2014 to 2019 levy funding period.

11 B. The ~~((emergency medical services advisory))~~ task force shall be composed of  
12 elected officials or appointed representatives of cities or fire districts and shall include:  
13 the King County executive ~~((the director of the department of public health; the manager~~  
14 ~~of the emergency medical services division; the regional medical director of the~~  
15 ~~emergency medical services division; the city of Seattle medical director; each))~~ or the  
16 executive's designee; two members of the county council or ((his or her)) either or both  
17 members' designees; ((the county auditor or his or her designee;)) one representative  
18 from each city with a population of ((50,000)) fifty thousand or greater; three  
19 representatives from King County fire districts((, of which one must represent


20 ~~unincorporated King County; four~~); and four representatives from cities with populations  
21 under ~~((50,000 ; a representative of a private ambulance company; a representative of a~~  
22 ~~regional communications center; two representatives from one or more nonpartisan civic~~  
23 ~~organizations such as the Municipal League or the League of Women Voters and a~~  
24 ~~representative of a bargaining unit providing basic or advanced life support))~~ fifty  
25 thousand. Members from cities with populations under ~~((50,000))~~ fifty thousand shall be  
26 appointed by the Suburban Cities Association in a manner reflecting geographic  
27 distribution within King County and shall not be subject to confirmation. Members from  
28 fire districts ~~((a private ambulance company, a regional communications center, one or~~  
29 ~~more nonpartisan civic organizations and a representative of a bargaining unit))~~ shall be  
30 appointed by the ~~((executive and confirmed by the council by motion))~~ King County Fire  
31 Commissioners Association and shall not be subject to confirmation. It is the intent of  
32 the council that King County staff, including but not limited to, staff for the office of  
33 performance, strategy and budget, department of public health and emergency medical  
34 services division shall participate by providing historic, operational and financial  
35 information. Staff and officials from nonrepresented cities ~~((and))~~, fire districts ~~((in~~  
36 ~~addition to the formal membership))~~ and other interested parties are encouraged to be

- 37 involved by serving on subcommittees and participating in discussions but shall not  
38 ((vote on any recommendations)) be voting members of the task force.
