### **Issues discussed**

# **Report from Other Subcommittees**

Note: The April 2018 Finance Subcommittee and EMS Advisory Task Force meetings have been moved out to May 2018 to enable the other subcommittees to complete additional work.

- ALS Subcommittee: Reviewing details of the unit allocation, including suggested enhancements, and baseline data for understanding projected demand.
- Regional Services Subcommittee: Reviewed status quo funding and status of current strategic initiatives.

### **BLS Funding and Priorities**

<u>Status Quo Funding</u>: The Subcommittee reviewed the cost of current BLS funds projected into the 2020-2025 levy period. Calculations included MIH and other BLS-specific funds (BLS Core Services, BLS QI and Training). This framework provides one 'bookend' when considering total funding for BLS agencies.

<u>Program Priorities – MIH and Others</u>: The MIH advocacy group presented the background, description and benefits for supporting a regional approach to MIH in King County, and recommended financial support that would partially cover costs.

<u>Discussion</u>: There was strong support for this service at a regional level, but continued concern regarding cost impacts and what regionalization meant. The subcommittee asked the BLS Working Group to discuss this topic at its meeting on April 24, 2018 and return with recommendations.

<u>Total BLS Funding – Allocation Methodologies</u>: Although the BLS allocation has provided funding for agencies since 1979, the formula has created challenges over the years. Changes were made to address 'hold harmless' and a lack of adequate growth, but they have not addressed the issue that AV and calls are applied only to a portion of the BLS funds (only new funds). Basic 'rebasing' numbers were presented.

#### **Discussion:**

Since rebasing would impact a select number of agencies, there was interest in mitigating this disruption. The subcommittee asked the BLS Working Group to discuss more options at its meeting on April 24, 2018 and return with recommendations.
