# 1095-B Changes

# 1095-B

The 1095-B is a tax form verifying you or your household member received Washington Apple Health (Medicaid) coverage for one or more months of the previous tax year.

Starting in the 2020 tax year, HCA will no longer mail the 1095-B forms.

Individuals with a Washington Healthplanfinder account will be able to view and print their 1095-B tax form in the Message Center of their dashboard.

# 1095-B

If an individual or household receiving MAGI Medicaid does not have a Washington Healthplanfinder account, they can request their form in the following ways:

- Call the Medical Assistance Customer Service Center (MACSC) at 1-800-562-3022 or
- Call the Health Benefit Exchange to create an account at 1-855-923-4633.

For those on a Classic program, an individual can call the MACSC number above.

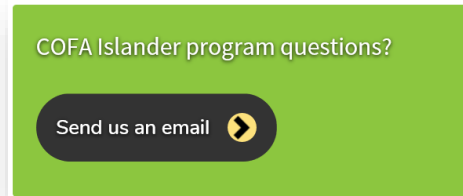
