Max Basic Food benefit amounts

- Approved for May 2022
- All Basic Food households except for those with a \$0 issuance
- Temporary increase, and it will end when COVID Emergency ends.

New Online Retailers – EBT cards

- Walmart (cash and food)
- Amazon Fresh (food only)
- NEW: Albertsons and Safeway (cash and food)

Public Health Emergency Extended

- Extended until July 15.
- No Classic Medicaid accounts will close during this time
- When PHE ends, client will need to complete an Eligibility Review at the end of their certification period
- No interview is necessary! No need to call in to complete medical Eligibility Reviews

(Post)Pandemic Time Limit Extension

- TANF households are normally limited to 60 months of TANF benefits
- During COVID, a "Time-Limit Extension" was approved
- All households active on TANF as of March 2020 or later were eligible to receive TANF benefits beyond the 60 months limit
- Now, this extension will continue through June 2023

Pandemic Emergency Assistance Fund

• One-time cash assistance to assist families with children due to the pandemic

- Households must be active on Food (state or federal), Transitional Food or TANF/SFA in the month of May
- Household income must be at or less than 75% of the FPL
- \$127 per qualifying child
- Issued automatically on EBT cards. Approval letters sent

Mid-Certification Reviews

- January 2022 June 2022: Mid-Certification Reviews are waived
- No MCR letters will go out to clients

Ukrainian Immigrants

- While we may rightfully use the term "refugee" to describe these immigrants, US immigration law does not classify them as refugees
- Three main types of Ukrainian immigrants:
 - Humanitarian Parolees (less than a year) "DT" coding in the I-94
 - Applicants for Defensive Asylum (entered the US often from a bordering country such as Mexico) – will possess court documents indicating an application for asylum has been submitted
 - **Temporary Protected Status** *Employment Authorization Document* (A12 approved, C19 applied), form I-821 (application), form I-797 (approval)

"Lawfully present Non-Qualified Aliens"

- Humanitarian Parolees (less than a year)
- Applicants for Asylum
- Those approved for Temporary Protected Status

Not eligible:

- Applicants for Temporary Protected Status (their status remains the same as it was at the time of application until application is approved)
- See WAC 388-424-0001 (3c)
