



African Americans have resisted historic and ongoing oppression, in all forms, especially the racial terrorism of lynching, racial pogroms, and police killings since our arrival upon these shores. The 1950s and 1970s in the United States was defined by actions such as sit-ins, boycotts, walk outs, strikes by Black people and white allies in the fight for justice against discrimination in all sectors of society from employment to education to housing. King County Plan-Apple Health Unwind

In King County, (according to HCA data 1/23), **we have 99,780** clients eligible due to continuous enrollment.

Statewide the following ethnicities are eligible due to continuous eligibility:

Hispanic	86,335
Black	33,195
Asian	24,016
Pacific Islanders	16,899
American Indian	15,612

What does the data show?

- Medicaid enrollment throughout the US grown to hit's highest level over 90 million people.
- Continuous eligibility allowed the most vulnerable and people of color to maintain their coverage. Uninsured rates were reduced—as we unwind these same populations will now be harmed.
- "Churn rate" was reduced.

King County Plan is being created with equity lenses. Why?

Because the conditions in which people live, work and play are determinants of equity. Equal opportunity in these areas is necessary for all people to thrive and achieve their full potential regardless of race, income or language spoken.

This unwind will affect the same populations who are judged by were they live, work & play.





King County Plan

1. Utilize the tool kits provided by the HCA & the Exchange.


2. Each Lead Organization under the Exchange (Public Health) will get a list of their residents who are partnered with a Navigator. Ensure these list are provided to each Navigator in a timely manner.

3. Public Health will be provided with a list of zip codes in King County who have the highest number of people affected each month. Data indicates these are some of the zip codes include: 98118, 98055, 98056, 98023, 98092.

4. Partner with community-based organizations in targeted zip codes. Offer enrollment events at their offices. And a small stipend \$5,000.00 to help with adding information to websites and other materials for their clients.

Continue....King County Plan

- Working with the Teen & Wellness Centers located in King County.
- Providing education to school nurses and schools about the change.
- Outreach campaign to mental health and social service agencies who are severing residents on Apple Health.
- Increasing awareness in Black, Hispanic and Asian communities through radio, ads and interviews.
