

# Free and Low-Cost Health Insurance Programs by Income Level

Eligibility for these programs is calculated using the household's income as it compares to the Federal Poverty Level (FPL).

## **Relevant Updates**

- In 2015 Molina was awarded 1<sup>st</sup> place and selected to implement Integrated Managed Care in SW Washington, Early Adopter region for Behavioral Health Integration
- Service started in April 2016, DSHS Report in September of 2017:
  - 13 showed absolute improvement, 4 declined, 2 no change
  - 10 showed greater relative improvement
  - 8 showed no difference in relative improvement
  - 1 showed lower relative improvement
- This year the Mid Adopter region of North Central WA was awarded and Molina again took 1<sup>st</sup> place, service starts January 1<sup>st</sup>, 2018
- King County is planning to move to mid adopter with service starting in 2019

## Design Elements - 2018 QHP Priorities

### Continue to offer a plan in King County

 Uncertainty about "Obamacare" has made difficult to design health plans but Molina has been able to continue and be selected in King County

### Stay Simple!

No Bronze Plan, focus on plans that drive people to use services

#### Remove Financial barriers to obtaining healthcare

- Keep Low Deductibles
- Retain and reduce Outpatient Cost shares where possible
- Retain and reduce Generic Rx Cost Shares where possible

# Benefit Highlights – Silver Plans

- Deductibles: \$525, \$2,500, \$4,950 for Silver
- Rx Deductibles: \$0, \$400, \$400
- Primary Care visit Copay: \$10,\$20,\$30
- Specialty Care visit Copay: \$30, \$60, \$75
- Mental Health and Substance Abuse: \$10, \$20, \$30

Estimated subsidized monthly premium for a Silver 200 plan is \$345 per month
