Governance Council Name:	King County Health Care for the Homeless Network (HCHN) Governance Council
Origin:	King County HCHN is partly funded by the Health Resources and Services Administration (HRSA) section 330 grant. The Governance Council is given oversight authority in compliance with federal funding.
Duties/Responsibilities:	<p>Members of the King County HCHN Governance Council consist of individuals from throughout the region with the experience, knowledge, and information to aid county leaders as they consider policies, investments and outcomes related to delivering effective health care services to people experiencing homelessness.</p> <p>In particular, the HCHN Governance Council will serve as the oversight body to carry out responsibilities in compliance with HRSA regulations.</p>
Composition:	<p>Up to eighteen (18) members and are at large with the exception of the designations:</p> <ul style="list-style-type: none">• At least three (3) positions for people who are current HCHN patients or others who are currently homeless or have other pertinent lived experience with homelessness• One (1) position for member from North King County• One (1) position for member from South King County• One (1) position for member from East King County
Term:	Members serve 4-year terms
Meetings:	Meetings of the HCHN Governance Council take place on the third Mondays of each month, 4:15-6:15pm. Meetings typically take place at the King County Chinook building (401 5th Ave, Seattle, WA 98104), but are currently held virtually. Committees of the HCHN Governance Council meeting monthly or on an as-needed basis.
Eligibility Requirements:	<p>Anyone can apply to serve on a King County council, board, or commission as long as they are willing to put in the time and commitment necessary to serve on the council. HCHN Governance Council members come from all walks of life. They are known leaders and new leaders, content experts and context experts, and reflect the diversity of stakeholder interests.</p> <p>Eligibility requirements for the HCHN Governance Council are as follows:</p> <ul style="list-style-type: none">• Resident of King County• Willingness to serve as a volunteer• Interest and/or expertise in the council's subject matter;
