# EXECUTIVE SUMMARY

### A. Fourth Quarter 2011 Highlights

This report provides fourth quarter 2011 utilization information for the 130 park-and-ride (P&R) facilities currently operating within the King County Metro Transit (Metro) service area. These park-and-rides represent a total capacity of 25,110 parking spaces. Parking capacity has decreased by 182 spaces from fourth quarter 2010. During this quarter, 18,549 spaces were used on a daily basis, resulting in a utilization rate equal to 74% of parking capacity. More than half of the 65 permanent park-and-ride lots averaged 80 percent or higher utilization rates during the fourth quarter of this year.

Overall park-and-ride usage rose by 433 vehicles in the fourth quarter of 2011, or two percent over the same quarter last year, with permanent park-and-ride lots increasing by 448 vehicles but leased park-and-ride lots, with two lots closures last quarter, lower by 15 vehicles.

The local economy continues to slowly improve, with some sectors stronger than others, sometimes mixed economic signals, and a recovery that may well extend through 2012. During the fourth quarter, the price of gasoline continued to ease after steeply climbing for much of the first five months of the year, reaching a high of \$4.10 in the middle of the second quarter. Retail gas prices began the quarter at \$3.88 per gallon and ended the quarter at \$3.53 per gallon, or nine percent lower. The quarter closed with gas prices \$0.30 per gallon, or 9% higher, than the gas price of \$3.23/gallon in December 2010.\*

Park-and-ride utilization is virtually back to the levels seen two-to-three years ago prior to the economic recession, with demand strongest among suburban commuters especially in east King County. The data continues to demonstrate strong linkages between park-and-ride usage, economic growth and the cost of fuel.

#### B. Park-and-Ride Changes

No permanent of leased park-and-ride lots open or closed this quarter.

#### C. Construction Updates and Projects of Interest

**Evergreen Point Bridge Park-and-Ride** – During the approximately two-year Eastside Transit and HOV Project construction project, a temporary Evergreen Point Bridge P&R lot of 19 stalls have been located along Evergreen Point Road on the northside of SR-520. The former permanent P&R location is being used for construction staging. When a new park-and-ride opens in 2013, the initial 50-stall capacity will be restored on the Evergreen Point Road lid over the SR-520 roadway.

**Shoreline Park-and-Ride** – Construction continues on the City of Shoreline's Aurora Corridor Project between North 185<sup>th</sup> and North 192<sup>nd</sup> Streets that affects the Shoreline P&R lot and adjoining roadways. Included in the project are a park-and-ride lot reconfiguration, Business Access and Transit (BAT) lanes, sidewalks, bus zone improvements and utilities for a relocated transit operator comfort station on North 192<sup>nd</sup> Street. Project work is scheduled to be completed at the end of February 2012.

Park-and-ride capacity has been temporarily reduced during construction from 393 to 326 spaces and will be fully restored upon completion of the project. Forty-six parking spaces in the northeast section of the lot were permanently removed to accommodate a raised plaza covering an underground stormwater treatment and storage system and are replaced along the west access road and within the park-and-ride lot. The City is covering the cost of all parking stall mitigation work, such as relocating and striping stalls.

**South Kirkland Park-and-Ride TOD Project** – A Transit Oriented Development (TOD) project is planned for the South Kirkland P&R lot. The TOD project includes expanded park-and-ride capacity with a garage, a new loop roadway through the property with improved transit access and bus zones, a signal at 108<sup>th</sup> Avenue NE and NE 38<sup>th</sup> Place, and a mixed-use housing project. Polygon Homes has been selected as the developer. The project is currently in design, and construction of the first phase – a new transit roadway and the park-and-ride garage – is scheduled to begin in Spring 2013. Replacement parking during construction is currently being sought. The next quarterly P&R report will have further project information.


**Planning related to SR520 Tolling** – Staff throughout the agency planned and developed marketing strategies for the December 29, 2011, start of SR-520 Tolling. Early monitoring reports suggest an increase in demand for bus service and park-and-ride space as well as shifts in traffic among corridors on the eastside. Park-and-ride planning continues and includes:

- Explore leasing additional park-and-ride space along key all-day cross-lake bus routes where currently eastside P&R lots fill-up by early morning and as resources permit.

Monthly park-and-ride vehicle counts are taken by Metro Service Quality supervisors and Sound Transit security staff. These monthly counts are averaged to show quarterly utilization. Trends in park-and-ride use are monitored and used when planning for new lots and changes in transit service.

# PERMANENT PARK-AND-RIDE LOTS

During fourth quarter 2011, an average 17,143 of the 22,655 available permanent parkand-ride spaces were used on a daily basis. This is 448 more vehicles or three percent above fourth quarter 2010. With net parking capacity 72 spaces greater than fourth quarter 2010, the utilization rate rose two percent (the completion of the Burien garage was offset by construction in Shoreline). The North District decreased by 122 vehicles per day (largely due to temporary commuter response to construction at Shoreline), the South District increased by 121 vehicles per day, and the East District gained 449 vehicles per day over fourth quarter 2010. Usage increases of 100 vehicles each at the expanded Brickyard Road P&R, at Eastgate P&R garage, and at Houghton P&R contributed to much of the East District's increase in usage when compared to fourth quarter 2010.


# A. Park-and-Ride Changes

The number of parking spaces at the **Kent Surface Lot at Kent Station** (lot #872.1) was reduced from 224 spaces to 119 spaces by Sound Transit effective in November. The southeast section of the surface lot was permanently closed.

Following documentation review, the property ownership of **SR 908/Kirkland Way** (permanent lot #720) is updated to that of the local jurisdiction, the City of Kirkland. In the detailed Comparison Report the category designation changes to C=City from S=State.

## LEASED PARK-AND-RIDE LOTS


Sixty-five park-and-ride lots leased from, or donated by, private property owners provide 2,455 parking spaces for King County commuters, or 10 percent of the total park-and-ride capacity. Net parking capacity was 254 spaces less than fourth quarter 2010, with the closures of 225-space Renton Boeing Lot 12 and the Burien Municipal Parking Lot in the third quarter. However, leased park-and-ride lot usage averaged only 15 fewer vehicles or one percent below fourth quarter 2010. The North District increased by 18 vehicles per day and the East District increased by 28 vehicles per day compared with fourth quarter 2010, while the South District was lower by 61 vehicles per day.

#### A. Park-and-Ride Changes

The number of parking spaces at **St Thomas Episcopal Church** of Medina (lot #520) increased from 33 spaces to 64 spaces in December. With the completion of Medina's city hall, the City vacated their temporary city hall space in the Church parking lot, and Metro was able to recapture its former P&R spaces as well as secure twelve additional spaces. Counts with the new capacity will begin first quarter 2012.
