Meeting

1. May a nonconforming structure be reconstructed within a sensitive area after it has been more than fifty percent destroyed? (K.C.C. 21.52.030, K.C.C. 21.54.030)

The issue of non-conformance within a sensitive area was first discussed by the committee. K.C.C. 21.04.615 defines a nonconforming building" as: "a building, or portion thereof, which was legally erected or altered and maintained but which, because of application of this title, no longer conforms to the regulations of the zone in which it is located as defined by this title." (emphasis added) Because the sensitive area regulations in K.C.C. 21.54 are a general provision which constitute a regulation of the zoning code, a structure located within a sensitive area may be nonconforming by reason of its location within the sensitive area alone.

With respect to conformance with sensitive areas regulations, K.C.C. 21.54 addresses the issue of preexisting structures independent of the nonconforming use provisions in K.C.C. 21.52. K.C.C. 21.54.030 provides an exemption from the setback and buffer requirements from wetlands, streams, and steep slopes for structures in existence before November 27, 1990. Therefore, regardless of the extent of destruction, a structure could be remodelled, reconstructed or replaced if in existence before November 27, 1990, and still be in conformance with the provisions of K.C.C. 21.54. As such, the provisions of K.C.C. 21.52 would not even be germane. Additionally, repair, reconstruction, or improvement of a structure within a flood hazard area is allowed consistent with the provisions of K.C.C. 21.54.180 and K.C.C. 21.54.190.
