Occasionally the employee performs trainings/presentations which may involve standing up to 2 hours at a time for up to 2 hours total in a shift.

#### Walking

Frequently on multiple surfaces that may include uneven or flat ground, concrete, carpet, gravel, rocks, vegetation, dirt, mud, grass and wet or frozen ground. Walking can occur for distances of up to ½ mile for up to 1.5 hours at a time and up to 4 hours total in a work shift. Walking most commonly occurs while performing facility walkthroughs four times a year and accident investigations.

## **Sitting**

Continuously on an office chair for up to 1.5 hours at a time for up to 5 hours total in a work shift. Most commonly occurs while performing computer duties, completing paperwork, attending meetings and driving a County vehicle. Driving County vehicles is limited to traffic conditions when traversing from

one area of the county to another (15 minutes to 2 hours). The employee can alternate sitting and standing as needed when performing computer duties.

# Climbing stairs

Health Care Provider initials if restricted\_

Rarely to occasionally for up to 3 minutes at a time while climbing up to 3 flights for up to 10 minutes total in a work shift. Most commonly occurs while performing facility walkthroughs. Elevators are available for use in most, if not all, Transit facilities.

# Climbing

Health Care Provider initials if restricted

Rarely on ladders to heights of up to 15 feet or on steep inclines to heights of 3 feet for up to 10 seconds at a time for up to 1 minute total in a work shift. Most commonly occurs when performing facility and park & ride walkthroughs and accident investigations. Approximately five instances of climbing annually.

# **Balancing**

Rarely to occasionally on multiple surfaces that may include gravel, rocks, vegetation, dirt, mud, grass, substandard structures, and wet or frozen ground for up to 1 hour at a time for up to 2 hours total in a work shift. Most commonly occurs while performing accident investigations, facility and park & ride walkthroughs which includes walking and standing while looking at various aspects of an accident or facility. The aforementioned activities of balancing occur approximately 4-6 times per month.

# Bending neck up

Health Care Provider initials if restricted\_

Rare on multiple surfaces that may include uneven or flat ground, cement, carpet, gravel, rocks, vegetation, dirt, mud, grass, and wet or frozen ground for up to 30 seconds at a time for up to 5 minutes total in a work shift. Most commonly occurs while making observations at a distance above head height, removing files from file cabinet, inserting paper in to copy machine, performing accident investigations, and inspecting low areas of facilities.

## Bending neck down

Health Care Provider initials if restricted\_

Frequently on for up to 10-20 minutes at a time for up to 4 hours total in a work shift. Most commonly occurs while making observations below waist level, removing files from file cabinet, inserting paper in to copy machine, performing accident investigations, and inspecting low areas of facilities. The employee also bends the neck down while looking at materials on desk surface.

## **Bending/Stooping**

Health Care Provider initials if restricted\_

Rare on multiple surfaces that may include uneven or flat ground, cement, carpet, gravel, rocks, vegetation, dirt, mud, grass, and wet or frozen ground for up to 30 seconds at a time for up to 5 minutes total in a work shift. Most commonly occurs while removing files from file cabinet, inserting paper in to copy machine, performing accident investigations, and inspecting low areas of facilities. The employee might be able to reduce bending/stooping by alternating with squatting or kneeling.

### Kneeling

Health Care Provider initials if restricted

Rarely on multiple surfaces that may include uneven or flat ground, concrete, carpet, gravel, rocks, vegetation, dirt, mud, grass, and wet or frozen ground for up to 3-5 minutes at a time for up to 15 minutes total in a work shift. Most commonly occurs while performing accident

investigations, removing files from file cabinet, making safety posters, inserting paper in to copy machine, and inspecting low areas. The employee might be able to reduce kneeling by alternating with squatting or bending/stooping.

Squatting

Health Care Provider initials if restricted\_

Rarely on multiple surfaces that may include uneven or flat surfaces, concrete, carpet, gravel, rocks, vegetation, dirt, mud, grass, and wet or frozen ground for up to 30 seconds at a time for up to 5 minutes total in a work shift. Most commonly occurs while performing accident investigations, removing files from file cabinet, inserting paper in to copy machine, and inspecting low areas. The employee might be able to reduce squatting by alternating with bending/stooping or kneeling.

Crawling

Rarely on flat surfaces for up to 5 minutes at a time for up to 15 minutes total in a work shift. Most commonly occurs while traversing small duct-ways/air shafts within the bus tunnel during inspections or drills. This activity occurs approximately three times annually.

**Operating Controls with Feet**

Frequently for up to 2 hours at a time for up to 4 hours total in a work shift while driving a County vehicle to meetings, accidents, and inspection sites within King County.

Reaching above shoulder height

Health Care Provider initials if restricted\_

Rarely for up to 5 seconds at a time for up to 30 seconds total in a work shift while obtaining training materials that may be stored above shoulder height or during an accident investigation.

Reaching at waist to shoulder height

Health Care Provider initials if restricted

Frequently to Continuously for up to 1 hour at a time for up to 6 hours total in a work shift while performing computer duties, inspections and investigations, attending meetings, writing on a clipboard and driving a County vehicle.

Reaching at knee to waist height

Health Care Provider initials if restricted\_

Occasionally for up to 1 minute at a time for up to 1 hour total in a work shift while moving training materials, performing CPR instruction, placing/removing objects on shelves, drawers and cabinets.

Reaching at floor to knee height

Health Care Provider initials if restricted

Rarely to occasionally for up to 1 minute at a time for up to 1 hour total in a work shift while moving training materials, performing CPR instruction, placing/removing objects on shelves, drawers and cabinets, performing accident investigations and facility inspections.

# Carrying 1-10 pounds

Health Care Provider initials if restricted\_

Occasionally for distances of up to 50 yards for up to 1 hour at a time for up to 3 hours total in a work shift. Most commonly occurs with weights of 3-9 pounds while carrying safety and training equipment, clipboard, and/or a camera while performing training, accident investigations and facility walkthroughs.

# Lifting 11-20 pounds

Health Care Provider initials if restricted

Rarely to occasionally for up to 30 seconds at a time for up to 5 minutes total in a work shift. Most commonly occurs with weights of 13-16 pounds while loading and unloading training equipment (audio/visual aids, brochures, handouts etc.) from a County vehicle.

# **Carrying 11-20 pounds**

Health Care Provider initials if restricted\_

Rarely to occasionally for distances of up to 50 yards for up to 5 minutes at a time for up to 20 minutes total in a work shift. Most commonly occurs with weights of 13-16 pounds while transporting training equipment (audio/visual aids, brochures, handouts etc.) to and from a County vehicle. The employee can use a cart to reduce carrying.

# Lifting 21-50 pounds

Health Care Provider initials if restricted\_

Rarely for up to 5 seconds at a time for up to 2 minutes total in a work shift. Most commonly occurs with weights of 25-30 pounds while setting up Rodeo equipment (timbers to simulate curbs). This is a two person lift with each person lifting 25-30 pounds.

## Carrying 21-50 pounds

Health Care Provider initials if restricted

Rarely to occasionally for distances of up to 10 yards for up to 1 minute at a time for up to 20 minutes total in a work shift. Most commonly occurs with weights of 25-30 pounds while transporting Rodeo equipment with the assistance of coworker.

## **Pushing and Pulling**

Health Care Provider initials if restricted\_

Occasionally for up to 30 seconds at a time with a force of up to 17 pounds for up to 10 minutes total in a work shift while transporting a projector on a cart for presentations as well as opening and closing doors (both interior, and exterior and tunnel fan doors).

# Handling

**Feeling** 

Health Care Provider initials if restricted\_

Rarely for up to 30 seconds at a time for up to 5 minutes total in a work shift while performing investigations and inspections. Sensory touch can be used to ensure proper operation of equipment as well as to identify fluids at accident scenes.

**Talking** 

Health Care Provider initials if restricted

Continuously for up to 2 hours at a time for up to 7 hours total in a work shift while conversing about duties and providing directions and instructions, as well as speaking with victims and witnesses and conducting presentations.

Hearing

Health Care Provider initials if restricted\_

Continuously for up to 2 hours at a time for up to 7 hours total in a work shift while conversing about duties and providing directions and instructions, as well as speaking with victims and witnesses and conducting presentations.

Seeing

Health Care Provider initials if restricted

Continuously for up to 1 hour at a time for up to 8 hours total in a work shift while performing computer duties, conducting investigations, driving a County vehicle, conducting inspections, as well as reading reports and federal, state and local regulations. The employee also utilizes vision when identifying hazard marking labels, investigating traffic control signals and investigating accidents and near misses.

**Working with Heightened Awareness** 

Health Care Provider initials if restricted

Rarely being particularly attentive to ones surroundings for the purpose of finding clues or sensing potential danger when performing investigations in an unstable environment ie., during protests/civil unrest, and being able to communicate during Homeland Security Training the concept. The employee may also need to inspect buildings after natural disasters (such as an earthquake).

## **ENVIRONMENTAL FACTORS**

Work is performed in a wide variety of areas that can range from substandard working conditions and structures to an office environment. The employee performs industrial and vehicular accident investigations. He/she investigates issues/complaints dealing with health and environmental hazards that may include substances such as automotive fluids, corrosive chemicals, solvents, petroleums and various chemicals. Substandard and/or improper working conditions may expose the worker to unsanitary or potentially harmful conditions that may include: trip hazards, animal bites, threat to bodily harm and exposure to potentially harmful dusts, fumes, or mists.
