JOB DESCRIPTION: Inspects residential and commercial plumbing and gas piping installations for compliance with codes and ordinances. Investigates public complaints regarding plumbing or gas piping installations as well as post plumbing and gas ordinance violation notices. Helps contractors and property owners solve installation problems and interpret codes, laws and regulations.

WORK ENVIRONMENT: Work is performed at various construction sites throughout King County and in an office setting. Worker may walk through construction areas with uneven ground that may include mud, dirt, rocks and broken cement. Worker may work in dark, damp and confined spaces when inspecting crawlspaces. The noise level ranges from quiet to loud.

ESSENTIAL FUNCTIONS: Inspects all residential and commercial plumbing and gas piping installations for compliance with various codes and ordinances. Prepares and maintains records of inspections, corrections, and approvals. Consults with superintendents, contractors, architects and the public to solve installation problems. Answers public questions; reviews blueprints and drawings; and informs people of regulations. Advises others performing sanitarian work on special problems in nursing homes, hospitals and restaurants. Investigates public complaints regarding unsanitary, illegal and hazardous plumbing or gas piping installations. Determines if a code violation has occurred; posts plumbing and gas ordinance violation notices and coordinates with supervision. Attends meetings and seminars on plumbing and piping. Inspects plumbing and gas installations, mechanical installations, venting and location of chimney linings. Performs cross connection inspection. Inspects for compliance with Washington State Energy Code. Inspects applicable codes, laws and ordinances, rules and regulations for contractors, and property owners.
