#### Who can register

To register to vote in Washington, you must be:

- A citizen of the United States;
- A legal resident of Washington State;
- At least 18 years old by Election Day;
- Not disqualified from voting due to a court order; and
- Not under Department of Corrections supervision for a Washington State felony conviction.

#### How to register

#### Online

You can register online at www.vote.wa.gov — you'll need a Washington State Driver License or ID. Make sure you register online by the October 28 deadline for the General Election.

#### By mail

Download and print a registration form from www.kingcounty.gov/elections and mail it to our office by the October 28 deadline for the General Election.

#### In person

You can register in person through November 5, Election Day at one of the vote centers listed on page 6.

#### Keep your voter registration current

Update your registration if you have moved or changed your name, or if your signature has changed. Simply update your information online or submit a new registration form by October 28 for the General Election or visit us in person through November 5, Election Day at one of the vote centers listed on page 6.

#### You can register to vote through Election Day!

You can now register to vote, update your address, or make other updates to your voter registration through 8 p.m. on November 5, Election Day.

See page 6 for a list of vote centers where you can register and vote in person.

## Registering to vote through the Department of Licensing or Health Benefit Exchange just got easier!

If you are getting an enhanced driver license, you will now be automatically registered to vote or have your address updated. Don't wish to register? You can opt out. If you are getting a non-enhanced license, you will still be asked if you would like to register to vote.

You can now register to vote while signing up for or renewing your health insurance through the Health Benefit Exchange.

#### Pre-registration for teens

16 and 17 year olds may now pre-register to vote. Registrations submitted online, by mail, or in person will be assigned a 'pending' status until they turn 18.

If the registrant turns 18 before the next scheduled Election Day, they will automatically be mailed a ballot at their registered address.

#### Access your ballot online

- Any registered voter can use the online ballot marking program.
- Voters with disabilities can mark their choices on the ballot online. The online ballot marking program has been designed specifically to enable voters who are blind or have low vision to cast a private ballot.
- If a voter's ballot is damaged or lost, the voter may mark their ballot on a computer and print it out. Return it at a ballot drop box or by mail before the 8 p.m. Election Day deadline.

**Statement:** It is a privilege to serve as your Elections Director. Each day I work hard to fulfill my commitment to removing barriers to voting while ensuring accurate, transparent and secure elections.

Voting in King County has never been more convenient. During my first term we added 60 ballot drop boxes; now 95% of voters live within 3 miles of a secure, 24-hour voting location. We implemented prepaid postage, because you shouldn't have to buy a stamp to vote, and added service in Spanish and Korean. We invested in culturally specific voter outreach through a first-in-the-country government/ philanthropic partnership. We've opened five new vote centers across the county to support same day registration.

*Voting in King County has also never been more secure.* As Elections Director I brought in the Department of Homeland Security and State Auditor's cyber security team to ensure our elections are protected. We've expanded our auditing practices and strengthened accountability. We implemented a new, state-of-the-art tabulation system that is not only more secure, but saving the county nearly \$500,000 per year. Most recently, I spoke out about issues with the state's new voter registration system because I believe that even one voter left behind is too many.

I've been a nonpartisan election administrator for 19 years, certified at the state and national level. At a time when elections are under threat, both from international interests leading us to question the integrity of our systems and domestically by those who would prevent rightful voters from having their voice heard, the 1.3 million voters of King County need and deserve an Elections Director with experience, integrity, and a commitment to making every vote count.

My site has the full extent of qualifying information about me. There's also a list of the election department's malfunctions, where currently the director gets a yearly salary of a tad shy of \$190,000 (I'll donate 10% every year to charities; send me some ideas).

I have a healthy distrust of vote tabulation machines, but they're in place, so I'll have hand counts of precincts & jurisdictions, broadly, randomly ... maybe, solely someday. With redistricting right around the corner, I'll be consulting with the Secretary of State's office, often, to ensure that the required changes are implemented & lawful.

I don't take voting orders from 20 folks at the Seattle Times and "The Stranger," I hope you don't either. Thanks!

During that time the average tax rates have been more than \$1.00 per thousand of assessed valuation. If the benefit charge is approved, the property tax rate will be capped at \$1.00 per thousand. The benefit charge will provide the necessary revenue to maintain services, but on a fairer and more logical basis than a property tax. Benefit charges cannot exceed 60% of the operating budget.

Approval of this proposition would allow the District to maintain the current level of services, while making the charges to citizens fairer.

#### Proposition No. 1 Formation of Public Hospital District

The King County Council adopted Ordinance No. 18929 concerning the proposition to form King County Public Hospital District No. 5. This proposition would authorize the formation of a new public hospital district having the powers and duties in RCW 70.44.060. The new public hospital district would encompass all territory of Vashon-Maury Island and would be governed by a board of commissioners composed of five positions, all of whom would be elected on an at-large basis.

The District will be a municipal corporation with all the powers enumerated in RCW 70.44.060, including, but not limited to, the authority to acquire, lease, maintain, operate, and develop property, equipment, and hospital and health care facilities; to exercise the power of eminent domain; to enter into contracts; to hire employees, including superintendents, attorneys, and other technical or professional employees; to sue and be sued; to contract indebtedness; to issue and sell revenue bonds; to levy an annual property tax of up to \$0.75 (75 cents) per \$1,000 of assessed valuation upon real property within the District; and to levy excess taxes when authorized to do so by the voters at a special election. The District will be governed by a board of commissioners consisting of five members elected at-large who are residents of the District.

We support access to quality health care for *All*, which this tax will not solve. The Hospital District will

not bring urgent care, new services, less expensive care, or increased access. Instead, it will be used to maintain Neighborcare, which is already heavily subsidized. There will be no changes to its operation, so those who cannot afford care will still be sent to collections for unpaid bills.

Without a vote of the people, the Hospital District will be able to levy 75 cents per \$1,000 of assessed home value (\$375 for a \$500,000 home). Although Neighborcare has a \$350,000 yearly deficit, the Hospital District will request a yearly minimum of \$1.3 million. Since each Commissioner can receive \$10,000 annually, plus health insurance, have an administrative staff and maintain an office, hundreds of thousands of tax dollars can be spent before any money is used for direct health care. This new tax will also decimate the Park District budget, and further contribute to the lack of affordable housing.

Health care is a human right which should be available to all, but a new tax on those who need help the most is not the way to solve it.

#### Rebuttal of statement in favor

Neighborcare already receives money from Seattle, King County, and Granny's (locally over \$100,000 a year), and they have no say in their daily operations. Because of their federal status, Neighborcare receives 106% of what they bill Medicaid, and higher Medicare reimbursements. We do not know how much money Neighborcare is losing, or how many patients they serve.

daily basis. Your vote keeps them open. Point Robinson, Village Green, Community Pool, VES and Agren Playing Fields, Ober Park, Paradise Ridge Park, Tramp Harbor Pier, Burton Adventure Recreation Center, etc. are each VPD properties forming the recreational heart and soul of the island.

Vashon voters approved the current levy at 50 cents per \$1,000 of assessed property value in 2015. This new levy will replace that at 45 cents – which is the equivalent of less than \$19 per month for a \$500,000 property. This levy is required to fund the Park District from 2020 – 2023. #### Full text of Ordinance No. 18931

AN ORDINANCE relating to the funding and provision of Medic One emergency medical services; providing for the submission to the qualified electors of King County, at special election on November 5, 2019, of a proposition to fund the countywide Medic One emergency medical services by authorizing the continuation of a regular property tax levy for a consecutive six year period, for collection beginning in 2020, at a rate of \$0.265 or less per \$1,000 of assessed valuation, to provide for Medic One emergency medical services.

#### PREAMBLE:

The Medic One Emergency Medical Services ("EMS") system of King County, publicly known as Medic One, is an integrated publicly funded partnership between the county, cities, fire districts, regional fire authorities, hospitals and the University of Washington.

Medic One/EMS is a tiered response system that is based on the regional medical model and collaborative partnerships. The services that EMS personnel provide are derived from the highest standards of medical training, practices and care, scientific evidence and close supervision by physicians experienced in EMS care. It includes basic life support by city, fire district and regional fire authority emergency medical technicians, advanced life support by University of Washington/Harborview Medical Center trained paramedics, and regional support programs that provide citizen and EMS personnel training, regional medical control and quality improvement.

The Medic One/EMS system of King County is recognized as one of the best emergency medical services program in the country. It saves thousands of lives every year, providing life-saving services on average every three minutes. Compared to other cities, cardiac arrest victims are two to three times more likely to survive. In 2017, it achieved a fiftysix-percent survival rate for cardiac arrest, which is among the highest reported rate in the nation.

The provision of Medic One emergency medical services on a countywide basis is a public purpose of King County. King County supports Medic One emergency medical services as a regional service that requires a continuing leadership role for the county. The county should continue to exercise its leadership and assume responsibility for assuring the orderly and comprehensive development and provision of Medic One emergency medical services throughout the county.

The concern for assuring the continuance of a countywide Medic One/ EMS program is shared by King County cities, fire protection districts, and regional fire authorities that participate in the Medic One emergency medical services programs.

Sustained funding for the regional Medic One/EMS system is needed to continue this essential service for the residents of King County.

#### BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Approval of cities over 50,000 in population. Pursuant to RCW 84.52.069, before submission to the electors of King County at a special election on November 5, 2019, approval to place this countywide levy proposal on the ballot will be obtained from the legislative authority of a majority of at least seventy-five percent of all cities in the county over 50,000 in population.

SECTION 2. Definitions. The definitions in this section apply throughout this ordinance unless the context clearly requires otherwise.

A. "County" means King County.

B. "Levy" means the levy of regular property taxes, for the specific purpose and term provided in this ordinance and authorized by the electorate in accordance with state law.

C. "Levy proceeds" means the principal amount of monies raised by the levy, any interest earnings on the funds and the proceeds of any interim financing following authorization of the levy.

SECTION 3. City of Seattle reimbursement. It is recognized that the city of Seattle operates and funds a Medic One emergency medical services program that is separate from the county program but part of the regional delivery system. All levy proceeds collected pursuant to the levy authorized in this ordinance from taxable property located within the legal boundaries of the city of Seattle shall be reimbursed and transferred to the city of Seattle and used solely for the Seattle Medic One emergency medical services program in accordance with RCW 84.52.069.

SECTION 4. Levy submittal to voters. To provide necessary funding for the Medic One/EMS system under the authority of RCW 84.52.069, the county council shall submit to the qualified electors of the county a proposition authorizing a regular property tax levy for six consecutive years, with collection commencing in 2020, at a rate not to exceed \$0.265 per one thousand dollars of assessed value. As provided under state law, this levy shall be exempt from the rate limitations under RCW 84.52.043, but subject in years two through six to the limitations imposed under chapter 84.55 RCW.

SECTION 5. Deposit of levy proceeds. Except for the levy proceeds transferred to the city of Seattle under section 3 of this ordinance, all levy proceeds shall be deposited into the county emergency medical services fund.

SECTION 6. Eligible expenditures. If approved by the qualified electors of the county, all proceeds of the levy authorized in this ordinance shall be used in accordance with RCW 84.52.069.

SECTION 7. Call for special election. In accordance with RCW 29A.04.321, a special election is called for November 5, 2019, to consider a proposition authorizing an additional regular property tax levy for the purposes described in this ordinance. The director of elections shall cause notice to be given of this ordinance in accordance with the state constitution and general law and to submit to the qualified electors of the county, at the said special election, the proposition hereinafter set forth. The clerk of the council shall certify that proposition to the director of elections, in substantially the following form:

<u>PROPOSITION ONE</u>: The King County Council passed Ordinance \_\_\_\_\_ concerning continuation of funding for the county-wide Medic One emergency medical services system. Should King County be authorized to replace an expiring levy by imposing regular property taxes of \$0.265 or less per thousand dollars of assessed valuation for each of six consecutive years, with collection beginning in 2020, as provided in King County Ordinance \_\_\_, to continue paying for Medic One emergency medical services:

SECTION 8. Interlocal agreement. The county executive is hereby authorized and directed to enter into an interlocal agreement with the city of Seattle relating to the Medic One program, to implement the provisions of section 3 of this ordinance.

SECTION 9. Local voters' pamphlet. The director of elections is hereby authorized and requested to prepare and distribute a local voters' pamphlet, pursuant to K.C.C. 1.10.010, for the special election called for in this ordinance, the cost of the pamphlet to be included as part of the cost of the election.

SECTION 10. Exemption. The additional regular property taxes authorized by this ordinance shall be included in any real property tax exemption authorized by RCW 84.36.381, if that statute is amended by the state legislature during the term of this levy.

SECTION 11. Ratification. Certification of the proposition by the clerk of the county council to the King County director of elections in accordance with law before the election on November 5, 2019, and any other act consistent with the authority and before the effective date of this ordinance are hereby ratified and confirmed.

SECTION 12. Severability. If any provision of this ordinance or its application to any person or circumstance is held invalid, the remainder of the ordinance or the application of the provision to other persons or circumstances is not affected.

#### Full text of Ordinance No. 18929

AN ORDINANCE establishing November 5, 2019, as the date of a special election on the question of creating a public hospital district on Vashon-Maury Island; establishing the boundary lines of the proposed public hospital district; and determining the number of commissioners of the proposed district and the manner of their election.

STATEMENT OF FACTS:

1. On April 22, 2019, a petition for the formation of a new public hospital district in King County encompassing all the territory of Vashon-Maury Island was filed with the King County director of elections. The director of elections has examined the signatures on the petition, compared them with the voter registration records of the King County department of elections and certified their sufficiency in compliance with RCW 70.44.020 and 70.44.030.

2. The date and time for a hearing on the petition, along with the text of the petition, without signatures, was published in the Vashon-Maury Island Beachcomber on June 6, 2019 and June 13, 2019, in compliance with RCW 70.44.030.

3. A public hearing on the properties to be included in the proposed hospital district was held by the committee of the whole on June 17, 2019, in compliance with RCW 70.44.030.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

<u>SECTION 1.</u> The proposed public hospital district shall be known as the King County Public Hospital District No. 5.

SECTION 2. The boundary lines of the King County Public Hospital District No. 5 shall be as follows:

All of the islands and line of extreme low tide surrounding the islands known as Vashon Maury Islands which lie in Township 21,22 and 23 N and Range 2 and 3E, W.M., King County, State of Washington. The boundaries of the proposed District follow existing precinct boundaries and do not divide any voting precinct, all required by RCW 70.44.030.

SECTION 3. In accordance with RCW 29A.04.321 and 70.44.020 a special election is called for November 5, 2019, within the subject area of the proposition in section 2 of this ordinance to consider the question of whether or not to form the King County Hospital District No. 5 and to elect commissioners. The director of elections shall cause notice to be given of this ordinance in accordance with the state constitution and general law and to submit to the qualified electors of the district, at the special election, the proposition hereinafter set forth. The clerk of the council shall certify that proposition to the director of elections, in substantially the following form:
