## From the Director

**Dear Friends,**

After 22 years in elections, the most rewarding feeling is still helping someone vote. Whether it's on a large scale like removing systemic barriers to voting or helping walk one person through the process of voting, I do this work because I believe everyone should have a voice. That's why I'm excited about two big changes to who can vote in our state.

This year, for the first time, 17-year-olds who will turn 18 by the General election can vote in the Primary. So, anyone who will turn 18 by November 8, 2022, can register, vote, and use their voice to help narrow down the candidates to the top two. They now get to help shape the General election ballot that will be before them in the fall.

We also saw voting rights restored for many with past felony convictions. Now, community supervision status or outstanding legal fines have no impact on your ability to vote. If you are not currently in jail for a felony conviction, you can vote. All you need to do is register – online, by mail, or in person.

Whether you're voting for the first time or the hundredth time, if you need help or have a question give us a call at 206-296-VOTE (8683). We are here to help.

Your vote is your voice. Make yourself heard and vote by August 2.

### Fill out your ballot

Use any color pen to fill in the oval next to your choices.

Skip any contests that you don't want to vote in.

### Sign your envelope

Your signature must match the signature on your voter registration record for your ballot to be counted.

### Return your ballot early

Whether returning your ballot by mail or drop box, vote early. Don't wait until Election Day!

Mailed ballots must be postmarked by Election Day, August 2. No stamp is needed.

## Vote centers

Vote centers are available for voters that need assistance. Each center has voting machines that offer audio or large print ballots, and other assistive devices. Elections staff are available to assist as needed. Voters can also register to vote and get their ballots through Election Day.

Free parking for voters is available at all locations, except Lumen Field Event Center.

Face masks are no longer required at Vote Centers. King County Elections supports those who wish to wear a mask.

## Access your ballot online

Lost and damaged ballots happen. There's an easy way to print your ballot right from home!

- Visit [kingcounty.gov/elections/obmp](http://kingcounty.gov/elections/obmp) and enter the required information to access your ballot.
- Make your selections on the computer or print out a blank ballot and fill it in by hand. If you choose to make your selections online, please double check those selections before and after printing your ballot.
- Return via mail or secure drop box, just like you normally would. No postage is required if using the included envelope cover sheet.

Any registered voter can use the online ballot marking program to access and print their ballot.

Voters with disabilities can mark their choices on the ballot online. The online ballot marking program has been designed specifically to enable voters who are blind or have low vision to cast a private ballot.

## Track your ballot online!

All voters are able to track their ballot online to make sure it was received by King County Elections and track it through the process to being counted.

If there is an issue with your signature, the ballot tracker will point you in the right direction to get that fixed so your vote can be counted. If there are no issues with your ballot, you'll be able to rest easy on Election Day knowing that your voice was heard.

## Keep your voter registration current

Update your registration if you have moved or changed your name. Simply update your information online at [VoteWA.gov](http://VoteWA.gov) or submit a new paper registration form by July 25 for the Primary election or visit us in person at one of our Vote Centers. If your signature has changed, please submit a new paper registration by July 25 or come see us in person – updates to signatures may not be done online.

## Who can register

To register to vote in Washington, you must be:

- A citizen of the United States
- A legal resident of Washington state
- At least 18 years old
  - If you are 16 or 17, you can sign up as a Future Voter and be automatically registered to vote when you qualify
- Not disqualified from voting due to a court order
- Not currently serving a sentence of total confinement under the jurisdiction of the Department of Corrections for a Washington felony conviction
- Not currently incarcerated for a federal or out-of-state felony conviction

## How to register to vote

### Online

You can register to vote online at [VoteWA.gov](http://VoteWA.gov) – all you need is two minutes and a Washington State Driver's License or ID. You can register online by July 25 for the Primary election.

### By mail

Download and print a registration form from [kce.wiki/VoterReg](http://kce.wiki/VoterReg) and mail it to our office address on page 4. It must be received by July 25 for the Primary election.

### In person

You can register in person through August 2, Election Day, at one of our Vote Centers. More information about Vote Center hours and locations can be found on page 4 and on our website at [kingcounty.gov/elections](http://kingcounty.gov/elections).



Effective January 1, 2022, if you were convicted of a felony, your right to vote will be automatically restored as long as you are not currently serving a sentence of total confinement in prison.

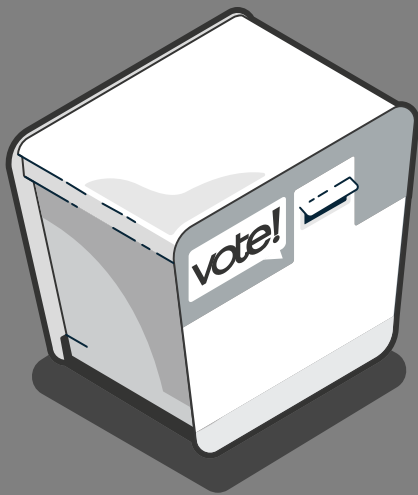
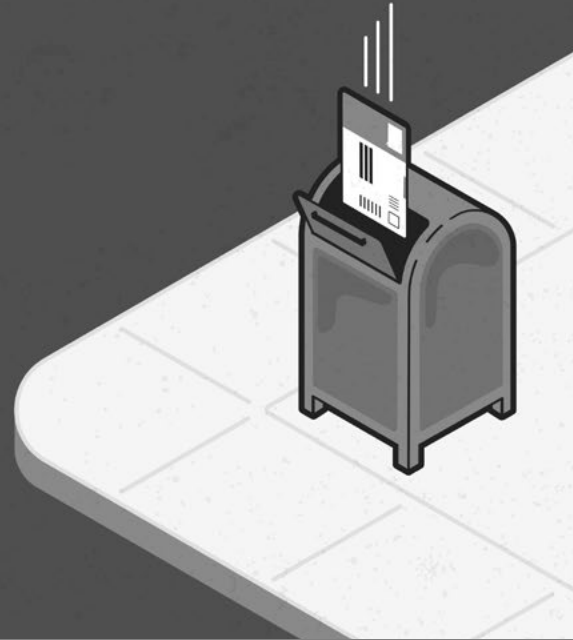
Community supervision status and legal fees and fines do not impact your right to vote. You can register to vote using any of the methods above.

# No Stamp Needed!

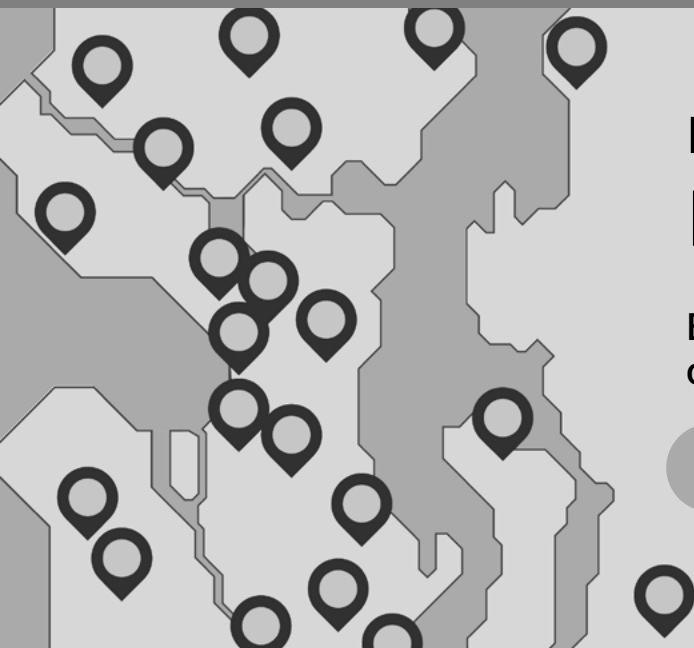
We recommend dropping your ballot in the mail by the Friday before Election Day to make sure it gets postmarked in time to be counted.

Mailed ballots must be postmarked by August 2.

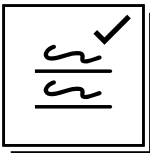
# How to sign your ballot so it counts.

Each election, about 1% of ballots are returned either without a signature or with a signature that doesn't quite match. Don't let that be you.

Here are a few tips to help make sure your signature passes the check and your ballot gets counted:



If you register online, we pull your signature from the Dept. of Licensing, so check the signature on your driver's license or state ID and try to match that as closely as you can.



Your signature does not need to be written in cursive or nicely or even legibly, it just needs to match the one that we already have on file. If you have a chicken scratch signature, that's okay! Just make sure you scratch it out the same way each time you vote.



Keep your signature current with us by updating it when you notice a change. Simply fill out and return a new voter registration form. You can download a registration form from [kce.wiki/VoterReg](http://kce.wiki/VoterReg).



Track your ballot to ensure that it gets counted. If there's an issue with your signature, you'll see it there on the online ballot tracker. You'll find the ballot tracker at [kce.wiki/TrackMyBallot](http://kce.wiki/TrackMyBallot)

If there is an issue with your signature not matching or if you just plain forgot to sign, we will send you a letter and, if we have it, we'll reach out by email and phone as well. To make sure your ballot is counted, you'll need to fill out and return a simple form before 4:30 p.m. on August 15.

Each candidate for partisan office may state the political party that they prefer. A candidate's preference does not mean that the candidate nominated or endorsed by the party, or that the party approves of or associates with that candidate. It is simply their preference.

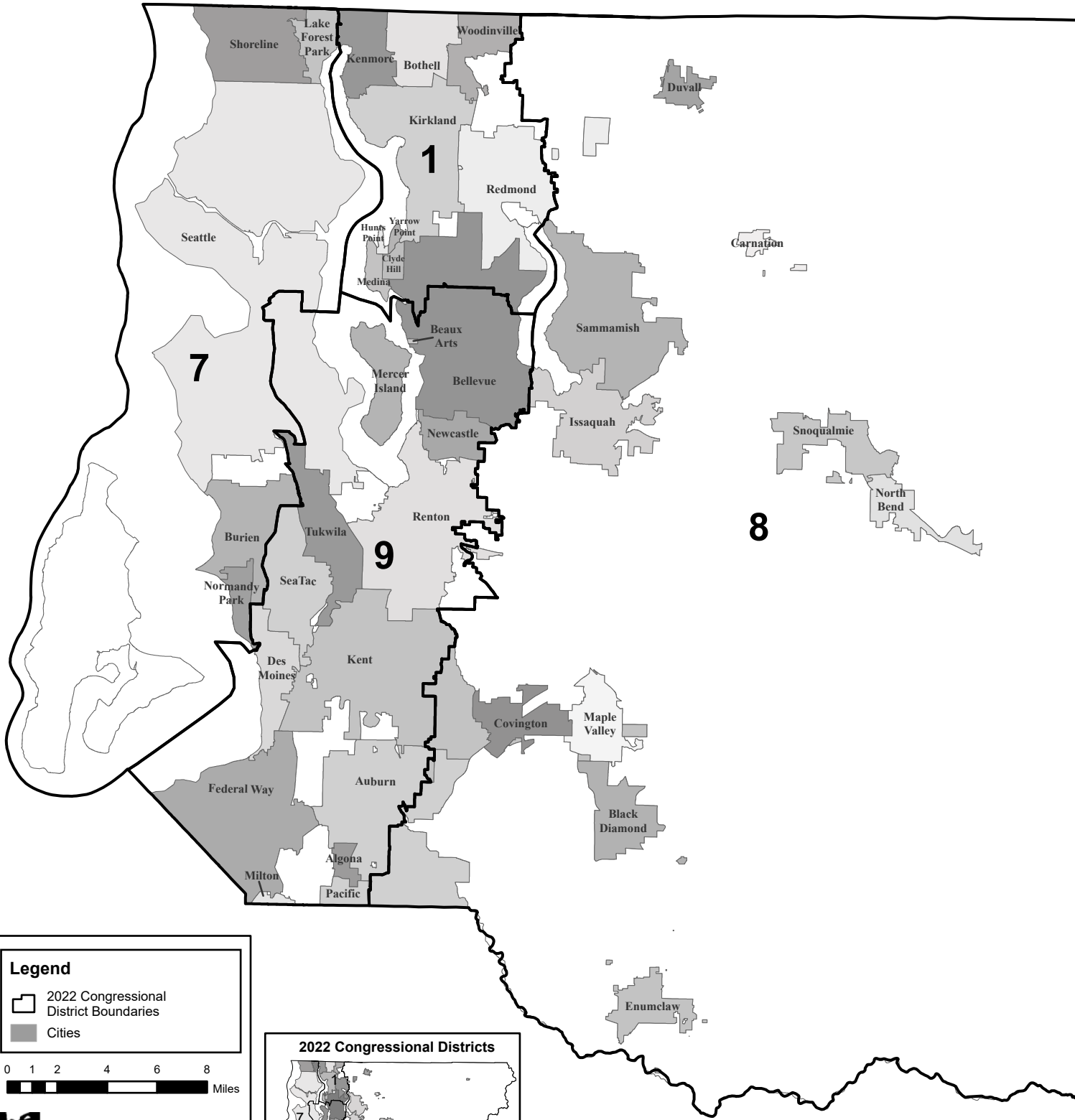

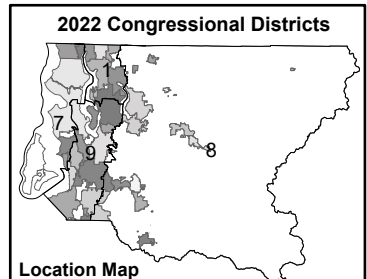
- 2022 Congressional District Boundaries

*Ranked choice voting preserves the peoples' voices* which is why we need it everywhere. Not having ranked choice voting allows election thieves to silence peoples' voices which is why they don't allow it everywhere.


*Ranked choice voting is necessary* to defend our elections because it protects against election thieves splitting an opponent's votes. It means voters rank election candidates in the voter's preferred order. If one candidate has more than half the votes after each voter's first ranked choice is counted, then that candidate would be the winner. However, if no one has a majority at that point, letting the person with the most votes but *less than a majority steal* the election is *avoidable* and, therefore, ridiculous. With ranked choice voting everyone's additional ranked choices are added to the count *until* someone has a majority. After all the ranks are added, if no one has a majority, only then will the nonmajority highest vote getter win.

Judiciary "opinions" changing same government level legislative or executive actions without, at least, *legislative panel approval* is insubordinate (towards legislature [judiciary's *superior*]) unconstitutionally illegal wrong.

Our elections are always under attack from rightwing and leftwing ideological extremists, foreign and domestic. These extremists lie to destroy America's democracy and silence America's voices. Both extremist wings tell misleading slogan lies to cover up their double standards.

Top 2 primary is a useful step in the correct governing direction. Ranked choice voting is an even more important step. A Washington previous ranked choice voting system was mistakenly ended instead of expanded. Mail in balloting *emphasizes* Election Day should be the *last day to vote, not the only day.*

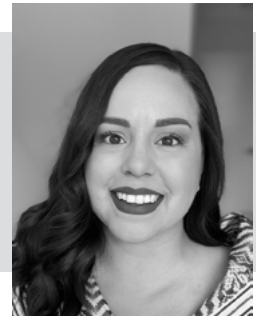

## Physical Security

King County Elections Headquarters was designed specifically for processing and securing vote-by-mail ballots.



Our facility is monitored by over 50 security cameras.



11 live webcams through which the public can watch us at work during the ballot processing period.



Staff and observers must badge into and out of the ballot processing area.



Ballot storage and tabulation areas require both a badge and biometric access.

## Cybersecurity

Cybersecurity is critical to protecting the security of our elections. As cyber attacks grow more frequent and complex, our team continues to improve our defenses.



Certified cybersecurity experts on staff at Elections and at King County IT.



All staff receive annual cybersecurity training.



Voter registration and tabulation systems are kept separate from one another for maximum security.



Tabulation system is on an entirely closed network, not connected to the internet.

## Audits and Quality Control

Our team conducts several tests before, during, and after each election to ensure your votes are being counted accurately.

### Logic & Accuracy Test

Conducted two weeks before the election, the Logic & Accuracy test uses test ballots and a set of expected results to ensure the tabulation equipment is reading votes correctly.


### Random Batch Audit

On the Thursday after Election Day, six batches are selected at random and hand counted to ensure the tabulation equipment continues to read votes as it should.

### Risk Limiting Audit

In 2021, our team began testing risk limiting audits. This auditing system checks a random sample of ballots to reach statistical confidence in the results of the election.

Where there is a huge anchorage and ready protection from our Army provided by mountains, deserts, and rivers. If this comes even close to happening, we will already have had a bad day. Long before then I want the Military to Recon the place hard and think about what to do with that much trouble.

Chinas' move is not so much new as next. Part and parcel to the happenings in Ukraine. You don't need ESP to see war clouds gathering. We must get our supply chain out of their country. That wont happen by itself.

Then there are the republicans. I think the free states should sue the slave states. To have a free and fair election in the United States, it must be free and fair in every state.

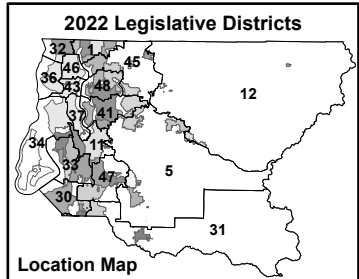
- 2022 Legislative District Boundaries

### Logic & Accuracy

- Conducted two weeks before each election, a public Logic & Accuracy test is conducted to ensure that voting equipment is ready for use and reading votes accurately.
- The Logic & Accuracy test is verified by independent observers and the Office of the Secretary of State. Media and candidates are also invited to observe.

### Random Batch Audit


- On the Thursday after Election Day, randomly selected batches are hand counted to ensure, once again, that the tabulation equipment is reading and counting votes accurately.
- Hand count totals are compared with the vote totals from the tabulation equipment to ensure a match.

### Risk Limiting Audit

- This is a post-election audit in which a random sample of voted ballots are examined in teams of two.
- A formula lays out the required number of ballots to be audited to reach statistical confidence in the election results.

Mountain View Fire and Rescue provides essential fire, medical, and emergency services for our community. The District's operating costs continue to rise due to increasing service demands and inflationary costs that are outpacing the property tax revenue to maintain essential emergency service levels and operational effectiveness.

The District is asking voters to restore their fire levy rate to the previously approved \$1.50 per \$1,000 of assessed property value. The current fire levy rate has fallen to \$1.31 per \$1,000 of assessed property value.

This is *not* a new tax. This simply allows the District to restore funding to the previously approved level. This amounts to \$102 per year or \$8.50 per month for the average home.

Washington State limits fire district tax revenue increases to 1% per year regardless of the increased property's assessed value. This means if a home increases 12% in assessed value, the District can still only collect 1% more overall than the previous year. We are challenged to meet the growing demand to maintain essential service levels and response times.

MVFR funds daily operations and most capital replacement needs through a regular operating levy. The fire levy pays for staffing, repairing and replacing equipment and ever-increasing operating expenses to provide fire suppression, emergency medical and other essential services to District citizens. With your *yes* vote, the District will have a more sustainable funding source to provide vital services.

Our firefighters have always been there for us, and now we have the opportunity to support their work in our community. We encourage and ask for your *yes* vote on this levy lid lift.

### Explanatory statement

Mountain View Fire and Rescue provides emergency fire protection and medical services to its citizens. The District's Board of Commissioners has determined that this proposition is necessary to maintain an effective level of service, fire fighter staffing, equipment and facilities in light of rising costs and increasing service demands. This taxes levied pursuant to this measure will allow the District to maintain the level of fire protection and emergency medical services provided to its citizens.

If approved by the voters, this proposition will authorize the District to restore its regular real property tax levy rate to \$1.50 per \$1,000 of assessed valuation in 2022 for collection in 2023 (the current levy is approximately \$1.31 per \$1,000 of assessed valuation). For the five subsequent years, the proposition authorizes annual adjustments by the greater of 1% or the annual CPI-W for Seattle-Tacoma-Bellevue as reported in June of each levy year. The amount levied in 2027 and collected in 2028 shall serve as the District's tax levy base and, in 2028, absent further voter approval, the tax levy will be subject to the statutory one percent limit.

## Physical Security

King County Elections Headquarters was designed specifically for processing and securing vote-by-mail ballots.



Our facility is monitored by over 50 security cameras.



11 live webcams through which the public can watch us at work during the ballot processing period.



Staff and observers must badge into and out of the ballot processing area.



Ballot storage and tabulation areas require both a badge and biometric access.

## Cybersecurity

Cybersecurity is critical to protecting the security of our elections. As cyber attacks grow more frequent and complex, our team continues to improve our defenses.



Certified cybersecurity experts on staff at Elections and at King County IT.



All staff receive annual cybersecurity training.



Voter registration and tabulation systems are kept separate from one another for maximum security.



Tabulation system is on an entirely closed network, not connected to the internet.

## Audits and Quality Control

Our team conducts several tests before, during, and after each election to ensure your votes are being counted accurately.

### Logic & Accuracy Test

Conducted two weeks before the election, the Logic & Accuracy test uses test ballots and a set of expected results to ensure the tabulation equipment is reading votes correctly.

### Random Batch Audit

On the Thursday after Election Day, six batches are selected at random and hand counted to ensure the tabulation equipment continues to read votes as it should.

### Risk Limiting Audit

In 2021, our team began testing risk limiting audits. This auditing system checks a random sample of ballots to reach statistical confidence in the results of the election.
