NOW, THEREFORE, I(we) agree and covenant that said owner(s), his/her (their) heirs, successors and assigns will not construct, maintain, or suffer to be constructed or maintained upon the said land of the owner(s) within 100 (one hundred) feet of the well herein described, any of the following: cesspools, sewers, building sewers or other sewer lines, privies, sewage holding tanks, septic tanks, drainfields, or any other receptacles for the storage, treatment and/or disposal of sewage, public roads or stormwater facilities, animal enclosures, houses and/or garages, garbage and manure piles, storage of chemicals (herbicides and insecticides), surface water, railroad tracks, power utility or gas lines, or underground storage tanks. The set back distance between the well and sanitary and/or abandoned landfills shall not be less than 1000 feet.

These covenants shall run with the land and shall be binding on all parties having or acquiring any right, title, or interest in the land described herein or any part thereof, as long as said well or waterworks is used for the purpose of supplying potable water.
