The meeting started at 10:08 AM

King County Director of Performance, Strategy and Budget, Dwight Dively chaired the meeting.

Welcome and Introductions

10:08 AM

• David Mendel welcomed the SAC and attendees to the meeting and introduced Dwight Dively as the chair of the meeting. Each SAC member (or delegate) introduced themselves.

Opening Remarks

10:11 AM

- Dwight Dively delivered opening remarks. He welcomed the SAC members and guests.
- Dwight remarked that tech security is important. The 2023-2024 budget was submitted to Council 2.5 weeks ago, with a vote planned the week before Thanksgiving. He mentioned that Council was particularly intrigued by the payment kiosks proposal.
- Technology is a critical part of how the County operates as about a half of the Council are working remotely. The County is going to be a hybrid organization.

Recap of March 2022 meeting

10:15 AM

- Zlata Kauzlaric provided a recap of the March 2022 meeting.
 - o Technology Awards recognition.
 - o Discussion about collaboration in the face of the pandemic, and continued prioritization and communication.
 - o Briefings were presented by Amazon, State of Washington, and Slalom.

Today's Topics

10:17 AM

- David provided an introduction to the three topics to be discussed during the meeting: Data Governance, Information Security and Privacy, and the 2020-2023 Strategic IT plan.
- He mentioned that data governance (presented by Priti Mody-Pan and Stephen Heard) and information security (Lorre Wijelath) are critical to King County. The SAC members will be asked to endorse the approach.
- The 2020-2023 strategic IT plan will be presented by John Klein.

Data Governance

10:25 AM

- As an introduction to this topic, a video was presented, in which the importance of data in the County was highlighted.
- Priti Mody-Pan presented the introduction to the mission of Data Governance at King County.
 - In 2020 a large group self-assessed that the County is at the low to medium level of maturity. Large departments own many data domains, but nothing is managed at a department level. This leads to silos.
 - For the last two years there has been a group from across the County working to identify focus areas. These are the strategic outcomes.
- Stephen Heard presented slides about the Data Governance Framework.

- He discussed the intersection of business and technology. This requires people, processes and technology. The intent is to mature the County to manage data and practice data intelligence.
- For future implementation, the County is looking for a Chief Data Officer to be hired after the new CIO is hired.
- The core working group feels that there will be an essential permanent subcommittee on equity and social justice within data governance.

• SAC Discussion

- o Bill Kehoe asked what the overall interest is in sharing data across departments.
 - Priti indicated that there is strong interest from analysts, stewards, and custodians.
- o Jason Weiss mentioned that Sound Transit rolled out something similar.
 - There was a discussion about where the Chief Data Officer would report. David Mendel indicated the current plan is for that position to report to the CIO. Jason was interested in knowing more as the CDO roll out occurs.
- Stephen Heard asked what does it mean to be "business led" but the practice living in IT? There needs to be a matrix into the business. The core working group wants to be included in hiring of the CDO. They want to do more than just implement tools, rather, see more engagement of the business.
- Julie Wise mentioned that KCIT had a data classification policy for security level, and wondered if it is in scope of the program to do the classification of the data.
 - Stephen responded that the requirements for data classification are part of information security policy. They will be engaging with every department and agency, and have estimated a four-year window to implement information security policy. This will fall under the domain of the CDO and data governance.
- Lisa Hillman mentioned that Snohomish County is in the infancy of their journey. With COVID, they have learned that there is a lot of information, but they don't necessarily know where all the data is. Change management is a big deal.
- o Bill Kehoe stated that data sharing is dependent on the culture and willingness of every department to share. Overcoming data sharing concerns is the biggest risk.
 - Priti indicated that this is one of the topics being addressed by the working group.
 Access management some departments are concerned that the data will not be adequately protected, so they are reluctant to share in the data catalog.
- Judge Oishi indicated that Superior Court and DJA have specific concerns and issues.
 Judicial branch is a separate branch. He indicated it needs to be discussed more.
- Michael Mattmiller loves the focus on change management. Cautioned the teams not to boil the ocean. Keep the compliance experience simple and straightforward. There needs to be a burning platform. Making social justice and inclusion the focus of the program is a great way to drive the program.
- Nicole Franklin mentioned there are special considerations for open data and community data.
 - Stephen replied there are a separate set of principles and work for engaging the community.
