• Jesse Benet led a brief grounding exercise based on a Dr. Hackman training.

Welcome and Introductions

9:05 a.m.

• Brook Buettner welcomed guests. Committee members and guests introduced themselves.

Legal Barriers 9:10 - 9:15 a.m.

- Brook Buettner drew attention to the legal barriers faced by King County Prosecuting Attorney's Office (KCPAO)
 - A document created by the Legal resource team and KCPAO was handed out for review
 - Further discussion on legal barriers tabled for future discourse
- Jesse Benet gave a broad strokes update on a small workgroup intended to cultivate better communication between LEAD and others in prosecutorial roles
- Hon. Donna Tucker underscored the need to reach out to outlying communities and townships outside of Seattle so as to build better bridges outside of the Seattle center

Waiver Update 9:15 -9:25 a.m.

- Travis Erickson outlined how there will be a funding change in the diversion and transitional programs currently in the pipeline
 - o The State of WA will provide less funding than originally anticipated
 - \$11 Million less for year 1 incentive payment (this number should not be taken as a de facto budgetary shortfall for years 2 through 5)

Revisiting Familiar Faces

9:25 - 10:20 a.m.

- Brook Buettner highlighted the Familiar Faces implementation strategies underway
- The Familiar Faces future state vision map was discussion
 - The future state vision map was used as a catalyst to stoke discussion on how
 Familiar Faces can continue to achieve its stated goals and improve in areas

Familiar Faces Improvement Thoughts/Strategies

- Familiar Faces may still be too crisis driven
 - How can steering committee members better invest resources upstream in order to prevent vulnerable community members from reaching jails, hospitals, courts...
 etc
- There is no consistent backing of capital
 - There needs to be a champion for programs like Familiar Faces (and others) in closed doors meetings that make budgetary decisions
- Has there been enough focus on the court/jail system
 - There are a lot of courts/jail in King County and to a layperson the current future state vision map may be too barebones
- There is a clear-cut disconnect between system reform champions and individuals who focus on the budget, this lack of communication and cooperation is an issue
- There are so many human service initiatives that are only focusing on their area of work
 → there is a lot of overlap, just not enough communication
- There needs to be a consensus effort to influence policymakers → show them how programs like Familiar Faces will save money and better ameliorate situations within their districts
- It may be a scale issue
 - Is there enough community resources already in place to divert individuals away from the courts/jail
 - Need more funding to scale the Familiar Faces program to the masses
- There are myriad community advocates and non-profits in the community with similar mission statements and goals → make sure that those networks are connected to the correct resources (and King County staff) in order to create a more sustainable and robust outreach nexus
- There is a need to create a network of places for individuals to be sent for help
 - o "Divert to what?"
 - o There is a need to scale our current diversion system in order to accommodate more individual

Meeting Themes

- The Familiar Faces program is ready to take a jump in its growth stage → the piece are in place to continue to move upstream
- "Divert to what?"
 - How can resources continued to be scaled in order to meet an increasing demand for diversion
- How can we begin to explore the next steps for the Familiar Faces program and how can those steps be met

- King County District Court hired a manager to further stoke community leaders and health care professionals to further talks regarding diversion
- Legal intervention and network of care program offered by community house is ready to start taking referrals
 - o Seattle, Kent and Renton are areas that the team has honed in on
- EMS system along with partners finished a 9 month sobering center project
 - o The data is currently being analyzed and reviewed
