Scaling Pockets of Excellence

9:20 -9:45 a.m.

- Healthcare for the Homeless Network
 - Ongoing topic of consideration: How can the Steering Committee leverage existing webs in a systems way in order to provide comprehensive resources
 - Recent HCHN RFQ elicited a lot of great work and areas for expansion in the system
- The HCHN delivery model requires a strong relationship and communication between community providers

- Outreach roles are important to engage with community members who need resources
 - Working in conjunction with outreach, a warm-handoff remains of paramount importance
- It is becoming abundantly important to glean quantitative information from both outreach efforts and the practical knowledge of managers
- It is important for different working groups to share data- shared data infrastructure and shared care plan
- Better communication and data sharing will lead to proper care coordination
- Ongoing issue of "where people will go;" appropriate respite, shelter and housing options
- Ongoing topic of consideration: How can the Familiar Faces Steering Committee team influence the trajectory of King County behavioral health integration discussions

Familiar Faces Future Vision

9:50 - 10:25 a.m.

- The scope of Familiar Faces and its initiatives needs to own a larger portion of public consciousness
- A lack of political pressure from the community to alter the criminal justice landscape
 - Moreover, the general public has a tenuous understanding of the criminal justice system and what happens when someone is booked. Messaging about individuals involved in CJ system.
- More data on homelessness and the criminal justice system and how they are fused →
 shift a larger spotlight on the issues Families Faces hopes to tackle
 - John reports HCHN has done training with JHS staff on how to ask about and record homeless status which should improve data quality

Strategizing Policy Advocacy

- Policy and budgetary priorities based on Familiar Faces issues
- Invite more fiscal and budgetary stakeholders into Familiar Faces conversations
- Underscore to decision makers the fact that there is significant amounts of money trapped in the criminal justice system → politically savvy to tackle these cost saving issues
- Steering Committee largely in agreement on key issues, question of who presents these issues to decision-makers
- Brook to follow up on the role of County employees in advocacy.
