- Brook Buettner welcomed guests. Committee members and guests introduced themselves.

Discussion: An Active and Effective Steering Committee

- Advisory Board, Sidney:
 - Center work on being accountable towards the population served or affected
 - Importance of community engagement
- Adrienne discussed how to harness collective impact. Reviewed how we have been effective and what we have accomplished so far as an Initiative.
- Action, rather than advocacy. Steering Committee is a work group, not an advisory group, created by DCHS (Department of Community and Human Services) and Public Health.
- Land on something together that we can actually fix
 - Create a collective action plan that has concrete solutions that can be showcased to Council, Executive's Office and decision-makers
 - Adrienne brought the example of jail release policies as a possible area of focus

- May need more DAJD (Department of Adult and Juvenile Detention) presence and SCORE at Steering Committee
- VITAL has created successful links- how do we bridge/ transitional care
- PAO struggles with not having a single liaison
- Community providers need a jail transition coordinator/ liaison to do things like med list, epic, benefits etc.
- MCO contractual obligations
- Challenges of getting access for outside providers
- Very silo'ed, disorganized, identify and address process issues
- For example, what is preventing people's clothes from being cleaned, what is the issue, is it process, legal etc.?
- Golden thread, warm handoff- learning from MCO pilot
- Over the next 4 months, create a document, then bring it to ACH, Exec, Council
- Trueblood opportunity- State is asking "What needs to be done?"
- Adrienne and Brook to sit down with Willie Hayes to seek participation
- Look at RBA outcomes and what are the barriers to reaching these outcomes
 - Trouble shoot, then make recommendations
 - Identify an issue, have a clear plan, bring it to Executive and Council
- Members are not constrained by positions, have powerful community voices and can take up opportunities that we are developing here
- Moving from menu of great practices to scale- need funding. Felt it was effective to have Susan McLaughlin from HealthierHere at Steering Committee last month
- Big questions, coming from and reflective of community groups, create some document to take to decision makers as recommendations
- Institutional behavioral changes challenging, stuck in the mindset of the people who *are* the structures
- Create an "Impact Plan," 10 recommendations, bring these 10 things to scale, some cost money, some don't, reflects the wisdom of this group
- Housing- often not enough support once people get in. Still need a mobile response
- Ongoing System-Connected Housing work and CEA reform
- Aligning pockets of excellence. Coordinating- having someone help figure out where a person would be best served, make it more person-centric
- Core value of Steering Committee is DIVERSION- not enough work in policy and talking with community partners- Federally-Qualified Health Centers about making them access points
- There is a lot of focus, effort and resources around Jail Transition right now, but no clear community-level governing body or workgroup on diversion. But still need the "Divert to What"
- Next 3-4 months- think about scope of what we want to target, bring in other players, move methodically through to make effective recommendations
- Process for getting on the same page, collective solutions, principles

- Dismantling criminal legal system, create other, better supports so we are not relying on criminal legal system, so we are holding that principle. Centering resources in community.
- Data on group this would affect
- Not enough of a quorum at the meeting to suggest a singular focus for the next few months of work.
- Create a list of 3-5 possible areas of focus for the next 12-18 months? Next forum to refine and figure out who gets involved and how does larger Steering Committee come together
 - Jail transition suggested by Adrienne
 - Focus on Diversion rather than in criminal legal system
 - Think through Vital- some of the issues, what will be its next iteration, provide recommendations to whomever make decisions about Vital
 - Take learnings from Vital, LEAD, LINC see what's working or not work, make some system changes based on that, what is the piece that is missing
 - Look at how behavioral health system can build supports in the community that can enhance diversion efforts
