#### Meeting Summary

  - Create a committee to write a letter on BESS (Patrice Barrentine, Leann Krainick, Stacey Smith, Jessi Bloom – before 9/24)

Meeting called to order by Chair Stacey Smith at 6:00 pm with quorum

Roll Call/Announcement of Staff & Public (Stacey Smith)

Roll call of Commissioners and announcement of staff and public guests was completed via Zoom's chat function.

### **ACTION: Approval of Meeting Agenda (Stacey Smith)**

Moved by Leann Krainick seconded by Henna Khan and passed unanimously.

### **ACTION: Approval of Meeting Minutes (Stacey Smith)**

This was approving meeting minutes from July. Moved by Janet Keller, seconded by Henna Khan, and passed, with Leann Krainick abstaining due to her absence from the July meeting.

Public Comment – Specific Agenda Item (Stacey Smith) There was no public comment at this time.

**MOTION: King Conservation District (Stacey Smith, Jessi Bloom, Matt Mega, Patrice Barrentine)** Every 5 years, KCD's rate renewal process comes through the executive branch, and then to council for approval.

A letter was made- changes made were:

- Added: members participating in FFF ag caucus, key member in LFI refresh.
- The partnership between KCD and the County will ensure investments and activities remain focused on our local food system and its overall long-term sustainability.

- Ag commission supports KCD's increase, KCD being a huge partner in the work being done for the local food system.

Leann Krainick wants to include something about both large and small farms in the letter (farms of all sizes). Patrice figured out how to add the sentence into the letter.

A motion was made by Jessi Bloom, seconded by Janet Keller, and passed unanimously, to send the letter.

### Old Business: DLS Permitting Update on Large Events in APD (Jim Chan)

#### Jim Chan

- Carnation farms withdrew more complex TUP for larger events, no longer pursuing that. Renewing current TUP for smaller ones, allowing several events that are of smaller venue sizes, which Paul ?? is putting together the pre-application that's required for that, and then they'll go from there.
- Brody (?) Nation: happened while under code enforcement- they appealed the permitting order, going in front of the examiner for a hearing which has yet to be scheduled.
- Remlinger Farms: wrapping up concert series (2-3 left), just had meeting with development, operations, and legal team. Hope that they will enter agreement to resolve their code enforcement cases (including expansion of stage, not using certain permits) should be resolved by the start of next season. The hope is to incentivize them into this, so they don't schedule/contract for anything else before this commitment. They will have to remove illegally permitted items within the disagreement period. In lieu of appealing and gong through the Hearing Examiner process and the potential legal struggles, they would just agree to this timeline and resolution, so DLS is working with them on that agreement. They're trying to figure out whether it is possible to legalize the expansion of the stage that is in channel migration. If not possible, they don't have an option to legalize the expansion, and will have to remove that portion of the stage. There continues to be traffic and noise complaints in that area with suggestions of additional flaggers and getting decibel readings. King County has the ability to reconsider the interpretation and impacts of this season moving into next season. If they are unable to meet the agreement, and if there continues to be impacts that they haven't been able to mitigate, King County can modify the interpretation. King County has given them a year to make changes that make things better for everyone.

Darron Marzolf asked about incentives being given- Jim Chan said if Remlinger Farms doesn't help, Chan will have to reconsider the interpretation of how many events, how large an event, and how often the event may occur. Stacey commented that the weather had an impact on the noise levels.

#### New Business: King County Strategic Climate Action Plan 2025 Update (Richard Martin)

Five years ago, most of the commissioners participated in developing the 2020 update of the SCAP, a blueprint on how the county can address climate change issues and sustainability. There is an update underway for this blueprint.

Richard gives an overview of the 2020 SCAP and current priorities and performance. He then describes criteria for 2025 SCAP actions, identifying agricultural strategies and actions being discussed that could be implemented in the SCAP, and then a discussion on all of these plus figuring out the next steps.

The 2020 update included Greenhouse Gas Reductions in forests and ag, transportation and land use, building/facility use. It also included a community's section (section 2 SRFC)

2020 SCAP Strategies for Ag: accelerate rate of farmland preservation, increase compost use, incorporate regenerative/climate smart practices, assess irrigation water needs, assess climate change impacts on ag production, and address issues that limit farmland access, especially for historically underserved communities.

2025 SCAP Update Priorities

- More strategic: focusing on implementing more impactful actions, carry forward 2020 actions, leverage/integrate with other KC plans, and effectively integrate climate actions.
- Focus on partnerships: engage implementation partners, strengthen frontline community leadership, and build stronger regional alignment.
- Engage community: provide in-person engagement opportunities to support community involvement in climate initiatives, engage frontline communities and youth in SCAP development, and set up survey for public feedback.

### **Overall Outcomes**

- Significant reduction of emissions across sectors countywide.
- Climate equity as a central focus throughout climate work
- Communities and partners are empowered to take climate action with adequate resources.

### **Discussion Questions**

- 1) Do the identified ag actions meet SCAP criteria? Strengths/Weaknesses?

- 3) Additional Considerations: what can the county do to most effectively help you achieve your goals for ag in KC?

### Discussion:

- Janet Keller says ag should be encouraged to do more of what they already do: by growing plants and whatever, they reduce temps. She was concerned when talking about reducing GHG in ag sector- which to her means not being able to operate machinery or having livestock. Farms sequester carbon and are a resource for reducing temp due to green growth. She thinks that a farm reducing GHGs is going to be detrimental to farming in KC in general. New tractors that come out (electric and whatnot)- are made with new construction/materials. New materials need to be considered for their emissions based on their own construction compared to older materials (life cycle assessment). Richard Martin agrees with her, looking for new approaches to reducing GHGs. The goal isn't to force farmers to change the way they do things, but to incentivize farmers through education.
- Leann Krainick: this isn't a mandate, but guidance. This needs to be at the very beginning of the plan. As time goes by, people take SCAP regulations and similar things as mandates rather than suggestions, and things can get lost in translation. Things to improve on: KC is great at preserving farmland, but not farmers. We don't know how to address this issue. This all has to be financially incentivized to do. For carbon reduction, farmers can use KC help in being involved in carbon markets. It can be hard to want to be involved in carbon markets if you don't fully understand it. Solar panels may be something to look into incentivize more... (listen to recording...)
- Patrice Barrentine adds- there are many farmers/farm employees but not many traditional farmworkers. Still with farmers/farm employees. Leann Krainick agrees- reference WA Dept of Labor and Industries. Richard will share a survey link with Patrice, and Patrice will release the survey later.
- Leann Krainick asks of stakeholder meetings that are coming up. Richard lists some upcoming ones and encourages sharing the survey link.
- Patrice said to consider the Snoqualmie Agriculture Strategic Plan in relation to heat on farms, particularly for livestock, emergency systems and planning, and more.
- Jessi Bloom discusses how water rights are discussed and the availability of water being a huge issue. KC needs to do better in creating water infrastructure. Farmers are competing with many different people on water.
- Patrice adds that meetings can be attended but Richard is also a good resource for discussing ideas/opinions on the SCAP update.

This was a field trip to Marzolf Meats grand opening in July. Most people from the ag commission, as well as other KC staff and politicians, were able to make it to the field trip. Patrice Barrentine shows some photos from the opening, which both Patrice and Darron Marzolf go through in detail.

Patrice asks the commission to start thinking about field trips for October. Janet Keller suggests somewhere with a pumpkin patch. Henna, Kevin, and Andrew of the Field Trip Committee will pull this together.

### MOTION: Updates (Patrice Barrentine, Richard Martin, Matt Mega, Alyssa Bowers/Jordan Jobe, Leann Krainick)

#### **Commission Admin, Policy and Legislation, Events and Funding Opportunities (Patrice Barrentine)** Commission Admin

- Selection committee/recruitment: adding supplemental questions, especially equity and social justice topics. Patrice needs commissioners to help clarify their own personal info to report how the ag commission is meeting county goals and so that they can have current info for recruitment needs. Survey will be sent out next Monday and will need to be received by the end of the month.
  - There are 12 questions, takes 20 minutes. Everyone must fill it out. Lyn Tampi will follow up if not received all 8.
  - Janet Keller asks if this was what the selection committee has been discussing (it is)

### Ordinance 2023-0263: BESS

- For 7/17, local services land use committee meet: a call came from council and exec to the commission the morning of the meeting. Jessi Bloom and Leann Krainick testified as private citizens regarding protecting the APD from BESS except as an accessory use. Janet Keller also tried to testify. Jessi Bloom's statement became part of a news story (both on the radio and in print). Jessi Bloom is wondering if they can write a letter to oppose BESS on ag land.
- Stacey Smith was wondering if local people in Carnation would be willing to testify for farmers too. There aren't many people from the land side of things.
- Leann Krainick adds that PSE is pushing hard. An amendment says that if these systems are to go in, there needs to be a public notice and meeting. Officials at PSE were asking for this amendment to be pulled. If a letter is written, it should be mentioned that farms hire a lot of people too. Leann Krainick would be willing to help Patrice Barrentine draft the letter.
- Patrice gives more context about this issue (see recording for more info). She says she will help out with commissioners who want to send a letter.
- Janet Keller comments that this another example of prioritizing farmland over farmers, as BESS would incentivize farmers financially. KC needs to be reminded to support farmers along with farmland.
- Leann Krainick would like to work with Patrice and a few other commissioners to write a letter. Stacey Smith will sign off on the letter, Jessi Bloom will read it. Leann Krainick makes a motion be made and the letter be submitted to council. Jessi Bloom seconds, and it is passed unanimously.
- Can send comments as representing their own business, if with a letter, can say on behalf of ag commission.

### Sunflower festivals

### King County Ag Program + Fish Farm Flood (Richard Martin)

Ordinance 19762 preamble: executive shall transmit a report providing recommendations to strengthen the county's commitment to sustainable farm-to-plate pipelines, advance equity, and support the ag sector in unincorporated KC as the ag sector complies with the hourly minimum wage rate as required by this ordinance. Council Member Perry identifies recommendations to consider, from farmland access to healthcare programs, to food banks- it is a bunch of programs that could benefit ag. A deep dive of the economic side of these things should be done.

There's a new member in the ag team replacing Eric Beach- helping with permitting issue and coordinating FFF. The new member is Bobbi Lindemulder, who has experience in farming and regulatory issues. She's worked in the Snohomish district.

### King Conservation District (Matt Mega)

- WSCC awarded the Farm Team \$100,000 from the Sustainable Farm and Fields Grant to support a dairy project on Keller Dairy
- KCD had their first ever Community Agriculture Farm Tour at City Soil Garden on composting with the support of the Education Team. It was a huge success, and 25 people turned out.
- Liz Stockton's Agricultural Drainage field season is firming up, and King County has submitted the permits.
- Jason Mirro applied for the Sustainable Farm and Fields Grant and is waiting to hear back on this \$8,500 project which will renovate a pasture for Jubilee Farm.
- Megan Weldon applied for the Sustainable Farm and Fields Grant and is waiting to hear back on this \$151,151.94 request. This grant will purchase a combination of cover crop seed, and/or pasture seed, and/or lime for Providence Dairy Farm, Wagon Box Farm, and Wallin Heifer Farm.
- We are in the process of applying for the Livestock Technical Assistance Grant for \$20,000.
- In 2025 to date, the farm team has approved 22 Cost Share projects.

- KPFB annual meeting Oct 28: in Sumner, needs two commissioners who aren't Farm Bureau members. She will send an invite if someone is available.
- CCA fuel rebate for farmers now available apply now.
- General election endorsements will be coming out shortly.



King County

Do you have a septic system in King County? King County is offering a **rebate of up to \$500 per property for regular septic system inspection, pumping, or riser installation.** 

The <u>septic system rebate program</u> is available throughout all of King County (not just unincorporated areas), however there is an income eligibility requirement\* for properties outside of Vashon-Maury Island and the <u>Poverty Bay Shellfish</u> <u>Protection District</u>. Businesses are eligible if they are a small business (the simple definition is in the application).

\*For 2023, the AMI for King County is approximately \$115,700<sup>1</sup>. Therefore, 80% of this amount would be around **\$92,560<sup>1</sup>**.

# Ag Commission Testimony before Council Sept 24

### Amendment was introduced and discussed Battery Energy Storage Systems (BESS) Ordinance 2023-0263.2



This ordinance advances these Strategic Climate Action Plan priorities by making **battery energy storage systems of all** scales an allowed use on nearly ninety-seven percent of the county's unincorporated land area.

E. The remaining three percent of the county's unincorporated land area is made up of agricultural lands. Being the most urban county in the state, King County has very little agricultural land, nearly all of which is protected as agricultural land of long-term significance for the commercial production of food or other agricultural products under the Growth Management Act and RCW 36.70A.170. That land contains rich agricultural soils, which are a precious and finite resource.

F. In order to maintain consistency with the Growth Management Act and protect agricultural lands for present and future generations, this ordinance only allows battery energy storage systems in agricultural zones as an accessory use, up to 2 megawatts. The 2-megawatt allowance leaves flexibility for farmers to store energy for their own use and to participate in energy sharing with their neighbors through microgrid applications, while maintaining a small footprint, which is likely less than four-hundred square feet. If there is no feasible alternative to constructing battery energy storage systems on agricultural lands, King County can consider granting special use permit authority for these systems in the next code update to address reliability issues at any substation proximate to agricultural lands.
