JOB DESCRIPTION

This is a temporary employee position. Lifeguards are responsible for the supervision and safety of the public at an aquatic facility. Duties include educating the public to promote habits and attitudes that lead to safe recreation, enforcing safety rules and responding to emergencies in an appropriate manner. Duties also include staging facilities for events and take down and cleaning.

Individuals must be able to work as part of an overall staff team and independently, without direct supervision. Employees need to be responsible, trustworthy, able to deal appropriately with the public and difficult situations. Lifeguards may be required to work special events, evenings, weekends and split shifts at any King County Park System location. The employee is subject to one or more written evaluations annually. A background check is a condition of employment.

Continuously on concrete, hard non-skid surfaces, tile, carpet runners, carpeted areas and waxed vinyl floor (some surfaces may be wet) for distances of up to ½ mile for up to 1 hour at a time for up to 8 hours total in a work shift. Most commonly occurs while cleaning the facility, staging facility for events, performing take down duties and performing Lifeguard rotations.

Sitting

Climbing

Bending neck up

Most commonly occurs while lifeguarding, cleaning on elevated areas, cleaning overhead, cleaning on stairs, moving equipment, placing or removing event equipment and performing rescues.

Bending neck down

Continuously & Highly Repetitive for up to 90 minutes at a time for up to 7-8 hours total in a work shift. Most commonly occurs while, lifeguarding, cleaning, moving equipment, placing or removing event equipment, performing rescues and administering first aid/CPR.

Bending/Stooping

Occasionally for up to 15-20 minutes at a time for up to 2.5 hours total in a work shift. Most commonly occurs while lifeguarding, teaching swimming lessons, cleaning, moving equipment, placing or removing event equipment and performing rescues, first aid and CPR. The employee can alternate with squatting or kneeling in most situations, in accordance with preference.

Frequently for up to 5-10 minutes at a time for up to 3-4 hours total in a work shift. Most commonly occurs while cleaning tile, moving carpet runners, performing rescues and administering CPR/first aid. The employee can alternate with squatting or bending/stooping in most situations, in accordance with preference.

Squatting

Health Care Provider initials if restricted_

Frequently for up to 5-10 minutes at a time for up to 3-4 hours total in a work shift. Most commonly occurs while cleaning tile, moving carpet runners, performing rescues and administering CPR/first aid. The employee can alternate with kneeling or bending/stooping in most situations, in accordance with preference.

Crawling

Occasionally for up to 5 minutes at a time for up to 1 hour total in a work shift. Most commonly occurs while scrubbing floors, cleaning baseboards and cleaning tile.

Operating Controls with Feet

Reaching above shoulder height

Occasionally for up to 5 minutes at a time for up to 1 hour total in a work shift while cleaning surfaces above shoulders, stocking shelves and putting garbage into dumpsters as well as climbing guard towers and diving platform steps.

Reaching at waist to shoulder height

Frequently to Continuously for up to 10-15 minutes at a time for up to 5-6 hours total in a work shift while stacking chairs, stocking shelves, keyboarding, teaching swim lessons, manipulating carts, emptying garbage cans into rolling bins, tipping portable bleachers and performing rescues.

Reaching at knee to waist height

Most commonly occurs with weights of 3-10 pounds while moving light equipment, diving brick, rescue tube, touch pads, supplies, lost and found items and some garbage.

Lifting 11-20 pounds

Most commonly occurs with weights of 12-17 pounds while moving light equipment, supplies, chairs, lost and found items and some garbage. Lifting 21-50 pounds

Occasionally for up to 10 seconds at a time for up to 30 minutes total in a work shift. Most commonly occurs with weights of 25-45 pounds while picking up & tipping heavier equipment, manipulating tables and bags of chemicals as well as performing rescues.
