Ensure contract, permit, and regulatory compliance for equipment and machinery installed under King County's construction contracts with an emphasis on mechanical systems such as large rotating assemblies (pumps, centrifuges, blowers, etc.), HVAC systems, process piping, and odor control systems. May perform specialized inspection of construction activity in the areas of instrumentation and control systems.
- 2. Review submittals and shop drawings from contractors and subcontractors for conformance with contract plans and specifications. Review contract plans and specifications to become familiar with specific areas that may require particularly close attention. Prepare a schedule which will allow for special examination of these areas during construction.

- 4. Prepare filed notes and submit daily written and telephone reports regarding the projects in progress. Prepare other written reports as requested.

Most commonly occurs while conversing with contractors, performing start up duties, performing inspections, surveying/reviewing job sites, verifying equipment alignment/calibration, coordinating special inspections and coordination with operations and maintenance.

Walking

Health Care Provider initials if restricted

Frequently on all conceivable surfaces for up to 30 minutes at a time for up to 4 hours total in a work shift. Most commonly occurs while inspecting job sites, taking measurements and traversing to and from job sites.

Sitting

Health Care Provider initials if restricted_

Continuously on an office chair, automobile seat or conference room chair for up to 2 hours at a time for up to 8 hours total in a work shift. Most commonly occurs while attending meetings and trainings as well as driving to and from job sites. The employee also sits when performing office duties which could include writing reports, reviewing documents, reviewing codes, reviewing submittals, talking on the telephone and performing photo log updates. On a rare occasion the employee may need to drive or fly to various distant locations for equipment verification/inspection or to look at other similar building projects. On most occasions the employee can alternate sitting and standing as needed.

Occasionally while climbing up to six flights at a time for up to 1-2 hours total in a work shift. Most commonly occurs while inspecting job sites that may not elevators installed yet.

Occasionally on a ladder to heights of up to 20 feet for up to 2 minutes at a time for up to 30 minutes total in a work shift. Most commonly occurs while climbing ladders to perform inspections.

Balancing

Health Care Provider initials if restricted_

Continuously on uneven ground and slick surfaces for up to 2.5 hours at a time for up to 8 hours total in a work shift. Most commonly occurs while traversing construction sites that may have drop-offs or uneven ground. Uneven ground could include rebar, mud, pipes, lumber ect. The employee also balances on ladders up to 20 feet tall.

Bending neck up

Health Care Provider initials if restricted_

Frequently for up to 5-10 minutes at a time for up to 4 hours total in a work shift. Most commonly occurs while inspecting upper areas of construction sites such as wiring, scaffolding, plumbing, joists and ventilation systems.

Bending neck down

Continuously & Highly Repetitive for up to 30 minutes at a time for up to 7 hours total in a work shift. Most commonly occurs while writing, reviewing plans, writing reports, taking pictures, measuring, utilizing reference materials, inspecting lower areas of job sites such as rebar, footings, pipes, foundations etc.

Bending/Stooping

Health Care Provider initials if restricted

Frequently & Highly Repetitive on all conceivable surfaces for up to 20 minutes at a time for up to 4 hours total in a work shift. Most commonly occurs while traversing areas with low ceilings (such as a utility room) or obstructions such as pipes or ventilation systems. The employee can alternate bending/stooping with kneeling or squatting on most occasions in accordance with personal preference.

Kneeling

Health Care Provider initials if restricted

Frequently & Highly Repetitive on all conceivable surfaces for up to 20 minutes at a time for up to 4 hours total in a work shift. Most commonly occurs while traversing areas with low ceilings (such as a utility room) or obstructions such as pipes or ventilation systems. The employee can alternate kneeling with bending/stooping or squatting on most occasions, in accordance with personal preference.

Squatting

Health Care Provider initials if restricted_

Frequently & Highly Repetitive on all conceivable surfaces for up to 20 minutes at a time for up to 4 hours total in a work shift. Most commonly occurs while traversing areas with low ceilings (such as a utility room) or obstructions such as pipes or ventilation systems. The employee can alternate squatting with kneeling or bending/stooping on most occasions, in accordance with personal preference.

Crawling

Health Care Provider initials if restricted

Occasionally on all conceivable surfaces for up to 5-10 minutes at a time for up to 1 hour total in a work shift. Most commonly occurs while inspecting the interior of pipes to make sure the joints were completed accordingly as well as when inspecting the interior of equipment or utility rooms.

Frequently & Highly Repetitive for up to 1 hour at a time for up to 4 hours total in a work shift while driving various County vehicles. Emergency eye wash stations have foot controls. On a rare occasion the employee may need to drive as far as Bellingham or Portland.

Reaching above shoulder height

Health Care Provider initials if restricted_

Occasionally for up to 2 minutes at a time for up to 30 minutes total in a work shift while measuring, climbing, securing a ladder and taking pictures.

Reaching at waist to shoulder height

Health Care Provider initials if restricted

Continuously & Highly Repetitive for up to 30 minutes at a time for up to 8 hours total in a work shift while reviewing plans, manipulating documents, driving and completing reports.

Reaching at knee to waist height

Health Care Provider initials if restricted

Occasionally for up to 5 minutes at a time for up to 15 minutes total in a work shift while removing materials from boxes or trunk of car, using utility locator and using paint sprayer.

Reaching at floor to knee height

Frequently & Highly Repetitive on all conceivable surfaces for up to 20 minutes at a time for up to 4 hours total in a work shift. Most commonly occurs while traversing areas with low ceilings and obstructions to inspect low construction areas such as pipes, wiring or ventilation systems.

Hearing
