JOB DESCRIPTION

Perform surface preparation and painting using low (VOC) coatings to a variety of transit vehicles and equipment, including buses wreckers, trucks, and streetcars. Paint Transit-related signs using basic silk-screen methods. Over 50% of the time the Painter at CSC (Component Supply Center) performs computer work, however the North Base Painters spend more time painting as silk screening/signage duties are only performed at CSC.

JOB SPECIFIC REQUIREMENTS

- Completion of an automotive equipment painter apprenticeship program or two years of vocational training and two years of automotive equipment painting experience or any equivalent combination of experience and training that provides the applicant with the necessary skills to perform the work of the position. Additional qualifications include:
- Journey-level knowledge of automotive equipment painting techniques, tools, and related equipment.
- Ability to work indoors and outdoors and withstand exposure to paint fumes, dust and other particles, and noisy operating equipment.
- The employee must be able to work at any base as work location is chosen based on seniority.

ESSENTIAL FUNCTIONS

1. Prepare a variety of substrates for vehicles, transit coaches, signs, equipment, and apply protective coatings.
2. Operate, clean, and maintain spray painting equipment, materials, and supplies.
3. Work in a potentially hazardous environment using protective clothing, equipment, and materials.
4. Create graphics and apply decals to vehicles.
5. Produce all Transit-related signage using silk-screen and vinyl cut and applied methods.
6. Apply custom paint and graphics to special advertising related coaches.
7. Ensure proper use, storage, handling, and disposal of all hazardous materials.
8. Maintain supply inventory and records as necessary.
9. Perform various tasks to prepare Metro buses, vehicles and signage for paint or decal application.
10. Sand, tape and mask surfaces for painting.
11. Clean, cut and prepare materials for signage.
12. Apply, remove and replace decals.
13. Strip vehicles and vehicle parts using various methods.
14. Clean painting equipment and work area.
15. May perform basic sign making techniques and tasks.
16. Work in a potentially hazardous environment using protective clothing, equipment, and materials.
17. Ensure proper use, storage, handling, and disposal of all hazardous materials.
18. Operate Metro vehicles as needed.

PERSONAL PROTECTIVE EQUIPMENT USED

Fall protection, full and partial face shields, reflective vests, goggles, respirators, impermeable body suits, hearing protection, steel toe boots, air-fed hood, knee pads, gloves (latex, chemical, etc.) and dust masks.

OTHER TOOLS & EQUIPMENT USED

Stencils, masking tape, sprayer, paint gun, computer, copy machine, fax machine, portable sandblaster, pressure washer, pen, paper, telephone, various platform lifts, power tools, ladders, putty, grinders, sanders, air compressor, scrapers, airlines/hoses, utility knives and razor blades, taping knives, propane, butane torch, hoist, spray shield, drop cloths, fans, blowers, vents, various hand, pneumatic and power tools. Computer programs used in this position include Microsoft Windows, Word and Excel. The employee also uses Macintosh Apple, FlexiSign (sign artwork program) and Adobe Illustrator. Over 50% of the time the Painter at CSC performs computer work, however the North Base Painters spend more time painting as silk screening/signage duties are only performed at CSC.

The paints and chemicals used in this position may include: latex's siliconized alkyds, lacquers, shellac's and varnishes, synthetic enamel, urethanes, primers-oil and latex, rust inhibitors, myratic acids, epoxies, metal etches, denatured alcohol, paint thinner, lacquer thinner, zylene, toluene, paint stripper, paint putties, detergents and degreasers.

PHYSICAL DEMANDS AS JOB IS TYPICALLY PERFORMED

Continuously = occurs 66-100% of the time

Frequently = occurs 33-66% of the time

Occasionally = occurs 1-33% of the time

Rarely = may occur less than 1% of the time

Standing

Health Care Provider initials if restricted_____

Occasionally on all cement and asphalt for 10-30 minutes at a time for up to 2 hours total in a work shift. Most commonly occurs while silk screening for signs as well as painting, priming, applying decals, striping, pressure washing, grinding, sanding, masking, scraping and cleaning surfaces. Standing varies daily according to duties performed.

Walking

Health Care Provider initials if restricted_____

Frequently on flat cement and asphalt surfaces for distances of up to 10 minutes at a time for up to 5 hours total in a work shift. Most commonly occurs while obtaining materials and parts as well as traversing between separate shops. The employee also needs to be able to walk out to the yard to obtain a coach and occasionally work on coaches in the yard.

Sitting

Health Care Provider initials if restricted_____

Frequently on a stool, rolling stool (creeper) or floor for up to 1 hour at a time for up to 4 hours total in a work shift. Most commonly occurs while performing computer duties and silk screening for

signs as well as painting, priming, striping, grinding, sanding, masking, scraping and cleaning surfaces. On a rare occasion the employee may need to drive a County vehicle to another base which requires sitting for up to 1 hour at a time for up to 2 hours total in a shift.

Climbing stairs

Health Care Provider initials if restricted _____

Occasionally for up to 1 minute at a time while climbing one flight for up to 15 minutes total in a work shift. Most commonly occurs while traversing within the facility in order to obtain supplies or to/from the break room as well as when applying decals to upper areas of the coaches.

Climbing

Health Care Provider initials if restricted _____

Rarely on a ladder to heights of up to 8 feet for up to 10 seconds at a time for up to 5 minutes total in a work shift. Most commonly occurs while painting, sanding, masking, priming, applying anti-skid and cleaning upper surfaces as well as applying decals to upper areas of the coaches.

Balancing

Health Care Provider initials if restricted _____

Rarely on a ladder to heights of up to 8 feet for up to 5 minutes at a time for up to 10 minutes total in a work shift. Most commonly occurs while caulking, priming, painting, applying decals or performing spot work. The employee may also work on the top of a bus; fall protection is used when performing those duties. At CSC the employee has the ability to use a drop lift to reduce the amount of time spent in an elevated area.

Bending neck up

Health Care Provider initials if restricted _____

Occasionally for up to 15 minutes at a time for up to 1 hour total in a work shift while priming, painting, applying decals, taping, sanding, pressure washing, cleaning and scraping upper areas. Employees also bend the neck up when looking at upper areas that need work.

Bending neck down

Health Care Provider initials if restricted _____

Frequently for up to 15 minutes at a time for up to 4 hours total in a work shift while performing computer work, priming, painting, applying decals, pressure washing, taping, sanding, cleaning and scraping lower areas. Employees also bend the neck down when looking at areas that need work.

Bending/Stooping

Health Care Provider initials if restricted _____

Occasionally on flat cement surfaces repetitively for up to 5-10 minutes at a time for up to 1 hour total in a work shift. Most commonly occurs while priming, pressure washing, painting, applying decals, cleaning, glazing, scraping and masking low sections of a coach. On most occasions the employee can alternate bending/stooping with kneeling or squatting in accordance with preference. A rolling stool is available as well to reduce bending/stooping.

Kneeling

Health Care Provider initials if restricted _____

Occasionally on flat cement surfaces repetitively for up to 5-10 minutes at a time for up to 1 hour total in a work shift. Most commonly occurs while priming, painting, applying decals, pressure washing, cleaning, glazing, scraping and masking low sections of a coach. On most occasions the employee can alternate kneeling with bending/stooping or squatting in accordance with preference. A rolling stool is available as well to reduce kneeling.

Squatting

Health Care Provider initials if restricted _____

Occasionally on flat cement surfaces repetitively for up to 5-10 minutes at a time for up to 1 hour total in a work shift. Most commonly occurs while priming, painting, applying decals, cleaning, glazing, pressure washing, scraping and masking low sections of a coach. On most occasions the employee can alternate squatting with bending/stooping or kneeling in accordance with preference. A rolling stool is available as well to reduce squatting.

Crawling

Health Care Provider initials if restricted _____

Rarely on concrete and asphalt surfaces for up to 1 minute at a time for up to 5 minutes total in a work shift. Most commonly occurs while accessing lower, hard to reach areas on the coach when a lift is not available.

Operating Controls with Feet

Health Care Provider initials if restricted _____

Occasionally for up to 5 minutes at a time for up to 15-20 minutes total in a work shift while operating a truck, forklift or coach. On a rare occasion the employee may need to drive a County vehicle to another base which requires operating controls with the feet for up to 1 hour at a time for up to 2 hours total in a shift.

Reaching above shoulder height

Health Care Provider initials if restricted _____

Occasionally and highly repetitive for up to 1-2 minutes at a time for up to 2.5 hours total in a work shift while priming, painting, applying decals, sanding, prepping, pressure washing, cleaning, glazing and masking high sections of a coach. When working at CSC (Component Supply Center) the employee can utilize a drop lift to reduce the amount of time of reaching above the shoulder.

Reaching at waist to shoulder height

Health Care Provider initials if restricted _____

Frequently for up to 30 minutes at a time for up to 4 hours total in a work shift while performing computer duties, priming, painting, applying decals, sanding, prepping, pressure washing, scraping, cleaning, glazing, silk screening and masking.

Reaching at knee to waist height

Health Care Provider initials if restricted _____

Occasionally for up to 5 minutes at a time for up to 15 minutes total in a work shift while priming, painting, applying decals, sanding, prepping, cleaning, scraping, pressure washing, glazing, silk screening and masking. The employee can use a rolling stool to reduce amount of time reaching downward.

Reaching at floor to knee height

Health Care Provider initials if restricted _____

Occasionally on flat cement surfaces repetitively for up to 5-10 minutes at a time for up to 1 hour total in a work shift. Most commonly occurs while priming, painting, pressure washing, applying decals, cleaning, glazing, scraping, sanding and masking low sections of a coach. A rolling stool is available to reduce amount of time reaching downward.

Lifting 1-10 pounds

Health Care Provider initials if restricted_____

Frequently for up to 1-2 hours at a time for up to 4 hours total in a work shift. Most commonly occurs with weights of 1-5 pounds while holding/manipulating full paint guns, pressure washing handle, vinyl rolls, hand tools, scrapers, sanders, grinders and hoses.

Carrying 1-10 pounds

Health Care Provider initials if restricted_____

Occasionally for distances of 100 feet for up to 2 minutes at a time for up to 15 minutes total in a work shift. Most commonly occurs with weights of 5-10 pounds while carrying hand tools, paint cans, scrapers, vinyl rolls, paper, various supplies and compressor hoses as well as loading/unloading the truck.

Lifting 11-20 pounds

Health Care Provider initials if restricted_____

Occasionally for up to 2 minutes at a time for up to 15 minutes total in a work shift. Most commonly occurs with weights of 11-15 pounds while manipulating 1-gallon paint cans, power tools, panels, and compressor hoses as well as when manipulating various coach parts. Overhead cranes are available to reduce lifting.

Carrying 11-20 pounds

Health Care Provider initials if restricted_____

Occasionally for up to 100 feet for up to 2 minutes at a time for up to 15 minutes total in a work shift. Most commonly occurs with weights of 11-15 pounds while transporting 1-gallon paint cans, power tools, panels, and compressor hoses as well as when manipulating various coach parts. Overhead cranes and carts are available to reduce carrying.

Lifting 21-50 pounds

Health Care Provider initials if restricted_____

Rarely for up to 1 minute at a time for up to 5 minutes total in a work shift. Most commonly occurs with weights of 25-50 pounds while loading and unloading 5-gallon cleaning solvent cans and rolls of paper.

Carrying 21-50 pounds

Health Care Provider initials if restricted_____

Rarely for up to 1 minute at a time for up to 5 minutes total in a work shift. Most commonly occurs with weights of 25-50 pounds while loading and unloading 5-gallon cleaning solvent cans and rolls of paper. A cart can be used to reduce the amount of carrying.

Pushing and Pulling

Health Care Provider initials if restricted_____

Frequently of carts, dolly, sanders, grinders and scrapers with a force of 1-5 pounds for up to 30 minutes at a time for up to 4 hours total in a work shift while sanding, grinding, pressure washing, cleaning and scraping coaches in preparation for painting.

Handling

Health Care Provider initials if restricted_____

Continuously for up to 1 hour at a time for up to 6 hours total in a work shift while using paint guns, dolly, sanders, pressure washer handle, grinders, and various power and hand tools as well as when driving.

Operating Controls with Hands

Health Care Provider initials if restricted_____

Continuously & Highly Repetitive for up to 1 hour at a time for up to 7 hours total in a work shift while using spray guns, driving, operating overhead lifts and operating the platform lift as well as

operating vinyl plotters, computer mouse, pressure washer handle, grinders, sanders, scrapers etc. On a rare occasion the employee may need to drive to another base which requires operating controls with hands for up to 1 hour at a time for up to 2 hours total in a shift.

Fingering

Health Care Provider initials if restricted _____

Continuously & Highly Repetitive for up to 1 hour at a time for up to 6 hours total in a work shift while performing computer work (keyboarding), painting, priming, masking, caulking, manipulating paper, scotch brightening and sanding.

Feeling

Health Care Provider initials if restricted _____

Continuously & Highly Repetitive for up to 1 hour at a time for up to 6 hours total in a shift while hand sanding as well as when feeling textures (for sanding and painting purposes), applying decals and identifying wet surfaces. The employee needs to be able to feel the flow of the paint guns and also feel the amount of pressure on the sander when preparing surfaces for paint.

Talking

Health Care Provider initials if restricted _____

Frequently for up to 10 minutes at a time for up to 3 hours total in a work shift while conversing about duties, receiving directions and instructions, and communicating with co-workers in person and telephone. The employee also talks with supervisors and vendors.

Hearing

Health Care Provider initials if restricted _____

Continuously for up to 2.5 hours at a time for up to 7 hours total in a work shift while working in an area with moving equipment (such as coaches, lifts, power tools and cranes) and safety hazards (such as exhaust and diesel fumes). The employee also utilizes hearing when conversing about duties, receiving directions and instructions, and communicating with co-workers in person and telephone. The employee also communicates with supervisors and vendors.

Seeing

Health Care Provider initials if restricted _____

Continuously for up to 2.5 hours at a time for up to 7 hours total in a work shift while inspecting quality of painting, cleaning, pressure washing, and scraping of surfaces. The painter also uses vision when writing, reading, performing computer duties, applying decals, inspecting projects for work quality, operating an automobile and identifying appropriate color of paints. Vision is also utilized while working in an area with moving equipment (such as coaches, lifts, power tools and cranes) and various safety hazards.

Working with Heightened Awareness

Health Care Provider initials if restricted _____

Continuously for up to 2.5 hours at a time for up to 7 hours total in a work shift while working in elevated and recessed areas, working around moving machinery and working around potentially hazardous and toxic chemicals.

ENVIRONMENTAL FACTORS

Work is performed in outside weather conditions, indoors, in an office setting, and multiple types of buildings that may have poor ventilation. Workers are continuously exposed to paint and solvent fumes as well as toxic chemicals. The employee is occasionally exposed to vehicle exhaust, cleaning

chemicals, oils, gasoline, diesel fuel, and hydraulic fluid. The employee also works around 600-volt electrical power lines for the trolleys; they do not work on the lines but are around them in the shop.

Approximately 90-110 decibels. The noise is caused by diesel engines and impact tools.
