1                   A MOTION acknowledging receipt of the local services  
2                   equity impact analysis report and feasibility study for a  
3                   community center as appendices to the Skyway-West Hill  
4                   Community Services Area Subarea Plan, which was  
5                   transmitted with the 2020 update to the 2016 King County  
6                   Comprehensive Plan in response to the 2019-2020 Biennial  
7                   Budget, Ordinance 18835, Section 84, Proviso P5, as  
8                   amended.

9                   WHEREAS, the 2019-2020 Biennial Budget, Ordinance 18835, Section 84,  
10                  Proviso P5, as amended, states that \$250,000 of that appropriation shall not be expended  
11                  or encumbered until the executive transmits the Skyway-West Hill Community Service  
12                  Area Subarea Plan that includes an equity impact report and a feasibility study for a  
13                  community center as appendices to the subarea plan and a motion acknowledging receipt  
14                  of the equity impact analysis and the feasibility study and the motion is passed by the  
15                  council; and

16                  WHEREAS, the 2019-2020 Supplemental Budget Ordinance 18930, Section 52,  
17                  P5 amended the date for receipt of the Subarea Plan and its appendices to be transmitted  
18                  by September 30, 2019; and

19                  WHEREAS, on September 30, 2019, the King County executive transmitted to

the council the 2020 update to the 2016 King County Comprehensive Plan of which the Skyway-West Hill Community Service Area Subarea Plan was included with the equity impact report and feasibility study for a community center as appendices;

WHEREAS, on September 30, 2019, the King County executive transmitted to the council this motion that acknowledges the receipt of the equity impact analysis report and feasibility study; and

WHEREAS, the two transmittals were submitted in satisfaction of the requirements in the proviso.

NOW, THEREFORE, BE IT MOVED by the Council of King County:

The council hereby acknowledges receipt of the equity impact analysis report and a feasibility study for a community center as appendices to the Skyway-West Hill Community Service Area Subarea Plan, which is Attachment F to the executive recommended 2020 update to the 2016 King County Comprehensive Plan, required by Ordinance 18835, Section 84, and Proviso P5, as amended.
