II. FINDINGS

The Court FINDS:

- 2.1 Reasonable efforts have been have not been made to reunify the family and make it possible for the child to return home.
- 2.2 Out-of-home placement should be terminated because:
- The Court believes that the parents have made reasonable efforts to utilize services and resolve the conflict, and the Court has reason to believe that the child's refusal to return home is capricious.

- It is not feasible for the department to provide services due to one or more of the following circumstances:
 - The child has been absent from court approved placement for thirty consecutive days or more.
 - The parents or the child, or all of them, refuse to cooperate with available, appropriate intervention aimed at reunifying the family.
 - The department has exhausted all available and appropriate resources that would result in reunification.
 - Family is reunified.

2.3 Court supervision should continue.

2.4 Out-of-home placement should be continued because reconciliation is not possible at this point in time.

2.4 Court supervision should not continue, and this proceeding should be dismissed because:

- The child is the subject of a Court proceeding under Chapter 13.34 RCW.
- The child's behavior has improved so that the child is no longer a Child-In Need-of-Services.
- Jurisdiction has expired.
