INTRODUCTION

The Petitioner, through its authorized representative, requests that this Court set a Show Cause Hearing in the above captioned matter and orders the Student to personally appear at the hearing.

Pursuant to RCW 28A.225.090 and RCW 7.21.030 this Court may enter an Order of Contempt against a party if the Court should find that the party has failed to comply with an order of this Court.

MOTION

The Student, having had notice of the court order, *willfully* refused to abide by the court order, has no lawful excuse for failing to obey the Court's order and has the *ability* to comply with the order and is in contempt of this Court.

The moving party requests that the Court issue an Order to Show Cause which directs the Student to appear before this Court and show why an Order of Contempt should not issue.

FACTS

This Court entered an Order to Compel School Attendance dated ____/____/____, which ordered the Student to attend school with no unexcused absences, tardies, suspensions, expulsions or behavioral referrals.
