- 4. Unless a party to the stipulation has stated in writing that he does not want a copy of the records, the professional copying service shall make one additional copy of the records and distribute the document as follows:
- a. The documents received from the health care facility custodian shall be delivered to defendant's counsel, who shall pay one-half (1/2) of the costs incurred.
- b. The newly made copies shall be delivered to plaintiff's counsel, who shall pay one-half of the costs incurred.
- c. If plaintiff's counsel does not desire a copy of the records, as indicated below, then defendant shall pay the entire cost of obtaining the documents.
- C. <u>Authenticity of Accuracy</u>. The parties stipulate that the documents produced by the above procedure shall be prima facie evidence of authenticity, accuracy, and completeness of business records regarding the subject plaintiff at that place of employment or other work-related facility. No other objections are waived.
 - D. Counsel for the parties to this stipulation shall promptly pay the costs incurred.
