Restitution ♦ Victim Penalty Assessment (VAP) ♦ Fines

Make sure your payment gets to the correct place, *and you get credit for making your payment*

PAYING IN PERSON

Paying with cash is easy and cheaper, because there are no money order fees. However, you can also pay in person using a money order or cashier's check payable to:

Bring payment, Monday through Friday (except legal holidays), 8:30 am-12:15 pm and 1:15 pm-4:30 pm, to one of these three locations:

NO PERSONAL CHECKS ACCEPTED

MONEY ORDERS are like “guaranteed” checks and can be purchased from a bank, post office, grocery store or convenience store (like a 7-11), in amounts up to \$500.00. The fee they charge you may vary. CASHIER'S CHECKS, for amounts over \$500.00, are only available through a bank.

PAYING BY MAIL: if you want a receipt returned to you include a self-addressed, stamped envelope. **DO NOT MAIL CASH!**

Use MONEY ORDERS or CASHIER'S CHECKS ONLY, made payable to: “KING COUNTY SUPERIOR COURT CLERK”

On the front of the money order or cashier's check, include:

- YOUR NAME as it appears on the court order
- EACH CASE NUMBER* (Number format is XX-X-XXXXX-X) that you are making a payment on
- The dollar amount to be applied to EACH CASE NUMBER*
