SUBJECT:	Follow-up on Capital Projects Oversight 2014 Review of Brightwater Close Out Report

This memo updates the status of the two recommendations made by the Capital Projects Oversight team in the 2014 review:

- The Central Tunnel litigation is continuing, with the contractor disputing \$15.4 million in legal fees awarded to King County.
- The Wastewater Treatment Division (WTD) completed the recommendation to close out all Brightwater mitigation obligations, which came in approximately \$800,000 under budget.

1	PROGRESS	We recommend that the County Executive provide timely notice to the County Council when final resolution of the Central Tunnel Litigation occurs and that WTD quantify the resultant changes, if any, to their estimated lifetime project cost-to-complete from the 2013 Trend Report.	Recovery of the \$15.4 million awarded to King County for legal fees in the court decision against the Central Tunnel contractor is still being litigated. If the county prevails, the final amount awarded by the court will further reduce the total cost of the project, which was \$1.844 billion when last summarized by WTD in September 2016. This amount includes all costs recovered to date. It is less than the \$1.859 billion forecast in the 2013 Trend Report but higher than the \$1.790 billion established in the 2004 baseline budget. To complete this recommendation, all litigation involving Brightwater must be resolved and WTD must report the final total cost of the project to the County Council. To confirm this is completed, the Auditor's Office will follow- up again during 2017.
2	DONE	We recommend that WTD proceed with close out of all mitigation obligations before the end of 2015, working to keep expenditures at or below current forecasts and realize potential savings.	WTD has completed all mitigation work and processed all payments. The total mitigation cost for the Brightwater project was \$147.9 million. This represents a \$0.8 million savings from the \$148.7 million mitigation budget.
