



## Pinepinen Katowow Pungun Taropwe ren Chon imweimw

King County's Eviction Prevention and Rent Assistance Program (EPRAP, Pinepinen Katowow me Programen Aninisin Rent) ii iei a kan fofori angangen aninisi engon ngorewen chon imweimw me non ei Fonu ir ra kan sap ngeni weiresin moni me pwan napengawen imweimw pokiten seni ewe COVID-19 semwauter.

Nge iei pwe an ewe Kepina we unusenapen state we Eviction Bridge Proclamation (Apion Birisen Katowow) epwene kan sopweno won October 31, chon imweimw kena ra kan wetwit ren ar rent epwe kan momo seni ewe program repwene kan sapngeni napenon ngawen ar repwene katowow. Sakopaten awukukun tumun kena ra kan katonong me pwan ew sakkun fofor mi fakkun watte epwene kan fis ren ew katowow pokiten ren ese wor momo rent epwene kan poputa.

**Iei minnei ekkena chon rent kena non King County ra kan tonong non EPRAP repwe mochen sinei usun ewe ngaw ren katowow me pwan pwonupwon kena mi kawor:**

**Met noum we Landlord mi nom non an EPRAP we Watten Landlord program?** Aninis iei epwene etto—chon imweimw kena ra kan naf repwene kan angei. Ekkewe 314 watten landlords ra kan tipweni 1,300 neni kena non ewe program ra saini ew tipeewin pwe resapw atowowu emon chon imweimw mi tonong non EPRAP ren ese momo ar rent torawow non December. Nge ika chok momo a kan fofor fan itan emon chon imweimw, iwe ena chon imweimw a kan pwonupwon seni katowow ren onu maram murin ewe fansoun momo (ewe nasenon maram rent a kan momotiw). Landlords kena repwe kan kapas ngeni chon imweimw pwe ir ra kan tonong non EPRAP.

**Met en ka tonong non ewe Poolen Chon imweimw?** Aninis iei epwene etto—chon imweimw kena ra kan naf repwene kan angei. Ei program iei a kan moni millionen chena non rent ren epwukuwen chon imw ew wik. Nge ew chok, angangen aninisin chon imweimw kena ra naf non ewe Poolen Chon imweimw epwene uwanong non 2022.

Tumunun pinepinen katowow kena ra wor ikenai ra kan kono seni sakkun nenien nemenem.

- **Seattle, Burien me Kenmore:** Ekkei city ra kan atamano ar we keukunon katowow ren tumunun chon rent tori January 15, 2022.
- **Meinisin ekkoch King County nenien nemenem kena:** Ewe ngawen napenon foforun katowow poputa seni Nov. 1, 2021, nge tumun mi kan kawor. Ika pwe noum we landlord a kan ngonuk ew arongen katowow, Housing Justice Project (Fofor Ren Pungun Imweimw) epwene kan awora ngonuk aninis ren annuk nge kosapw pwan moni. Akapachenong, non King County, mi wor ei ew order seni kapung iei pwe ekkena katowow repwene kan amangeno seni napeta ngeni 60 ran ren emon aramas a kan

tonong non ewe EPRAP program ren an epwe mut ngeni fansoun an ewe program epwe moni ewe rent.

**Angei aninisin Pinepinen Katowow ese wor momon seni ewe Fofor Ren Pungun Imweimw (Housing Justice Project):** *Nge ika mo pwe ka kan wetiwit ren aninisin rent non ewe Poolen Chon imweimw ika Watten Landlord program, nonom non Seattle ika Neni ewe pachengeni King County, ika pwe noumwe landlord a kan ngonuk ew arongen katowow, aninis mi kan kawor.*

EPRAP a kan rukanong \$24 million ngeni ewe Housing Justice Project me Dispute Resolution Centers (Nenien Fofori Angingi) ren an epwe awora aninisin annuk ren ar repwe awukano katowow kena.

Me mwan eom kopwene fori eom finata usun nikiti imwomuwe ika tipeew ngeni ew amonen momo, kori HJP ren eom kopwe kuna met sakkun tumun seni federal, state me nenieom ra kan aeoeo ngonuk. Tumun kena ra kan anongonong won an emon chon rent sokusokun me pwan nemenien ewe neni.
