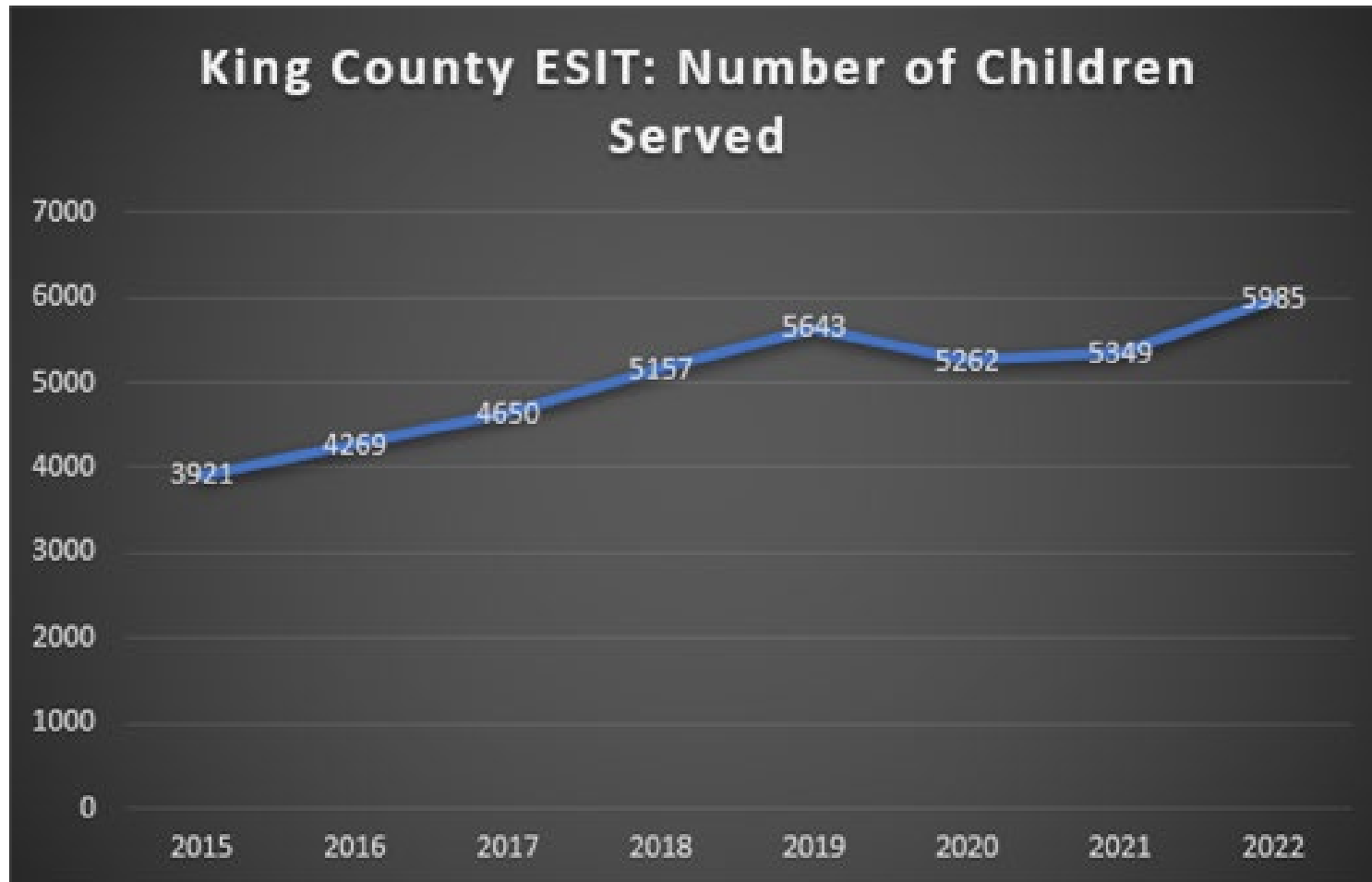
What's going on?

What's going on?



Early Support for Infants and Toddlers (ESIT) served a record 5,985 children with delays or disabilities and their families in King County during 2022. This was a 12% increase over the number served in 2021 and a 53% increase over the number of children served in 2015!

What's going on?

The ESIT Provider Request for Applications (RFA) is open!

- This RFA is seeking responses from current ESIT provider agencies to access funding to support their efforts, progress, and plans to strengthen Racial Equity and disability justice, in alignment with Best Starts values.
- ESIT will be seeking community members to participate in the RFA review panel, in particular parents and caregivers whose child(ren) recently received ESIT services, and community members who represent the cultural, linguistic, ethnic, and geographic diversity of King County. We will share more information when the review panel dates are finalized.

What's going on?

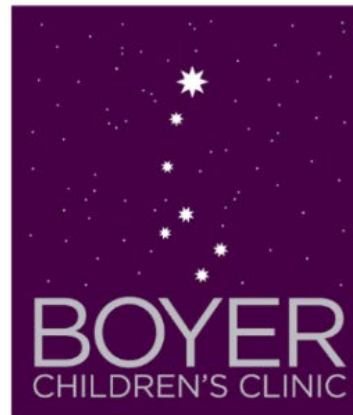
The Seattle Developmental Bridge Program, serving children ages 0-4 to help them connect to their next early learning opportunity, served 195 families in 2022. Over 92% of families served reported that they were very satisfied or extremely satisfied with the services they received.

 - Supervisor hired (Sung Park)
 - Next Step: hire first team of Case Resource Managers (CRMs); expected caseloads of 1:300
 - Update: 2 Case Resource Managers have been hired; 6 additional positions have been established across the region
 - 4,906 clients currently assigned to R2's "No Paid Services"

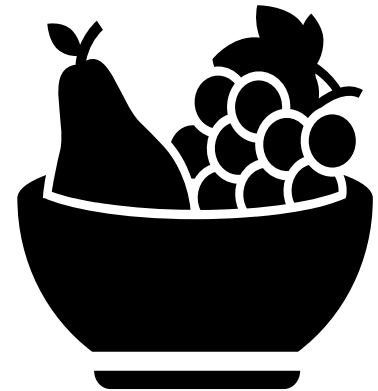

ANNUAL BOARD ELECTIONS

The process outlined below will be used for the annual Board elections. A reminder, current officers may serve two consecutive one-year terms in office. The Chair will begin elections by calling for nomination for the office of Vice-Chair.

- Board Members may nominate and vote for themselves.
- Nominees will be asked to share their goal(s) for the upcoming year.
- Sharing of goals to not exceed three minutes.
- Once all nominees share their goals, the Chair will call for a vote.
- The Chair will call on each Board Member individually for their vote.
- Board Members are asked to not abstain from voting.
- The candidates receiving most votes will begin their one-year term in office on April 1, 2023.
- If the vote is tied, the Board will vote again.

The same process will be repeated for the position of Chair. Please note that the newly elected Vice-Chair may not run for the position of Chair during this election.
