To explore behaviors and attitudes about household waste disposal, recycling, and waste reduction among its residents, King County commissioned a telephone study of households located in incorporated and unincorporated areas of the county, excluding the City of Seattle. The study was conducted on behalf of the King County Solid Waste Division in January 2003. The survey followed the same basic methodology as the previous King County Residential Waste Reduction and Recycling Surveys, which have been conducted annually since 1994. Those surveyed claimed primary or shared responsibility for handling the garbage and recyclables in their household.

A key goal of the study is to track changes over time in attitudes and behaviors. Accordingly, this study compares the 2003 findings with the results of the previous surveys. When examining trends among the studies, it is important to note that the 1994 study was conducted in unincorporated King County only. In addition, starting in 1999, the satisfaction rating scales were changed; therefore, 1999 serves as a baseline for the satisfaction questions.

The 2003 study focused on nine major areas of investigation, listed below, and covered in more detail in Chapter 4.

- **4.1 Curbside Garbage Service** This section examines the use of and satisfaction with curbside garbage service.
- **4.2 Transfer Stations** This section analyzes the use of and satisfaction with garbage and recycling at transfer stations.
- **4.3** Curbside and Multi-family Building Recycling Services This section examines participation in recycling as well as satisfaction levels of those who participate.
- **4.4 King County Services** This section assesses the number of residents who have had contact with King County Solid Waste Division staff and their satisfaction with the customer service received.
- **4.5** Yard Maintenance and Waste Handling This section analyzes management of grass clippings and yard waste, compost bin use, and food waste composting.
- **4.6 Computer and Television Recycling** This section covers methods that residents would use to dispose of unwanted computers and televisions.
- **4.7** Internet Use This section examines use of the King County website, particularly to obtain information about garbage and recycling.
- **4.8 Demographic Comparisons** This section summarizes differences in findings among four broad geographic areas in which King County residents are grouped: Eastside, North King County, South King County, and Rural East King County.
- **4.9 Comments from Participants** This section summarizes comments that respondents provided at the conclusion of the survey.

To obtain information on each of these major areas, the King County Solid Waste Division staff, Cascadia Consulting Group, and PRR developed a survey questionnaire, and Market Trends conducted a telephone survey in January 2003. The phone survey included a total of 601 interviews. Of the respondents, 432 (72%) resided in a city or town in King County and 169 (28%) lived in unincorporated King County.

This document presents the results of the 2003 study and is organized into four main sections. Chapter 1 provides an overview of the study, while Chapter 2 summarizes the methodology used. Chapter 3 summarizes key findings, and Chapter 4 describes the survey results in more detail. Appendices follow the main body of this report and include a graphical summary, the detailed study methodology, and a topline report from the current study.

Chapter 2. Summary of Methodology

This chapter briefly summarizes key elements of the survey methodology. Appendix B describes the methodology in more detail.

Sample Size & Survey Population

A total of 601 Computer Assisted Telephone Interviews (CATI) were completed among residents of King County, outside of the City of Seattle. The survey respondents were adults 18 years of age or older. The respondents included 432 residents of a city or town in King County and 169 residents of unincorporated King County.

Survey Sampling, Inc. (SSI) provided a random-digit sample of telephone numbers. Phone numbers were drawn randomly throughout King County, proportionate to population, excluding those who reside in the City of Seattle.

Survey Design

The 2003 survey questionnaire was adapted from previous Waste Reduction and Recycling surveys conducted by GMA Research in conjunction with the King County Solid Waste Division, PRR, and Cascadia Consulting Group. Changes from the 2002 questionnaire were made in concert with King County Solid Waste Division staff and are discussed in Appendix B.

Satisfaction scales measure residents' overall satisfaction with their garbage service, curbside recycling service, building recycling services, and level of customer service received from King County Solid Waste Division staff. The satisfaction scale used in the survey follows:

- "very satisfied" (a rating of 7);
- "satisfied" (6);
- "somewhat satisfied" (5);
- "neither satisfied nor dissatisfied" (4);
- "somewhat dissatisfied" (3);
- "dissatisfied" (2); and
- "very dissatisfied" (1).

Fielding Dates

Market Trends conducted the telephone study from January 9 to January 27, 2003

Chapter 3. Summary of Key Findings

This chapter presents a brief summary of the King County Solid Waste Division's 2003 Residential Waste Reduction and Recycling Survey.¹ Chapter 4 describes these findings in more detail.

Curbside Garbage Service

- Consistent with last year (89%), the majority (91%) of residents reported that a garbage service collects their garbage at their home or building.
- Nearly all of those residents living in both single-family homes (91%) and multi-family buildings (91%) used garbage service.
- A majority of residents in all geographic areas reported using garbage service: Eastside, 96%; North King County, 97%; South King County, 86%; and Rural East King County, 85%.
- Significantly more residents living in incorporated King County (93%) used garbage service than those living in unincorporated King County (85%).
- A majority of the areas studied (Eastside, North King County, Rural East King County) reported higher percentages (5-11 percentage points) of garbage service use than in 2002.
- Overall, residents across all geographic areas and dwelling types reported being satisfied with their garbage service (averages range from 6.0 to 6.3 on a seven-point scale). Among those with garbage service, 86% reported they were either "very satisfied" (7) or "satisfied" (6) with their service.

Transfer Stations

- The proportion of residents self-hauling their garbage to a transfer station at least once annually has increased slightly this year (47%) compared to 2002 (44%).
- Residents living in single-family homes were more likely to self-haul garbage (52%) to a transfer station in the past year than those residents of multi-family buildings (13%).
- Residents stated that having large quantities of items for disposal (41%) was the primary reason for self-hauling garbage to a transfer station or landfill. Mentioned next was disposing of items that the garbage service refused to take because they were too big (26%).
- Most residents (73%) reported that no one from their household took materials to the recycling areas at the transfer station in the past year. This figure is consistent with the 2002 study, in which 71% did not use the recycling areas at the transfer station.
- The percentage of residents in unincorporated King County (33%) who used the recycling services at the transfer station at least once in the past year decreased from 2002 (40%).
- Incorporated King County residents who used the recycling services at the transfer station in the past year increased slightly (24%) from the 2002 study (22%).

¹ References to statistical significance made in the body of the report are based on the use of *two-tailed t-tests* and a 95 percent confidence level.

Curbside and Multi-family Recycling Services

- Showing a slight decrease from last year (88%), more than eight in ten (84%) residents who live in single-family homes or buildings with four units or less participate in recycling programs where recyclable materials are picked up at their residence.
- In terms of location, little difference exists between the percentages of single-family residents of incorporated (85%) and unincorporated (81%) King County who participate in curbside recycling.
- Residents in single-family dwellings who do not participate in curbside recycling (16%) reported two primary reasons for such a decision: one, the preference to deliver their own recyclables to a collection center (23%), and two, the cost of the service (22%). Last year, residents cited service not being available in their area (26%) as the primary reason for not participating, while this year it was the third most common reason (16%). The percentage of residents living in single-family dwellings who did not participate in curbside recycling this year (16%) increased slightly from last year (12%).
- Those living in single-family dwellings who do not participate in curbside recycling are more likely to be living in unincorporated (19%) than incorporated (14%) King County.
- Single-family residents across all geographic areas and dwelling types reported being satisfied (6.1 to 6.4 on a seven-point scale) with their curbside recycling services. Total satisfaction levels with curbside recycling services were between "satisfied" (35% with a rating of 6) and "very satisfied" (51% with a rating of 7). About half the residents of both incorporated (52%) and unincorporated (49%) areas were "very satisfied" with their curbside recycling service.
- With a small increase from last year (72%), a majority (76%) of those residing in multi-family buildings report having recycling services at their building. Among those who report receiving such service, 93% say they actually use it. This figure represents a drop from 2002 when all respondents surveyed reported using this service.
- Junk mail (91%) was the most common item recognized as being recyclable in the residential recycling program. Last year, cardboard (95%) was noted most as being accepted. Consistent with the 2002 survey (76%), participants mentioned paper plates and napkins most (65%) as being unacceptable in curbside recycling programs.

King County Services

- More than one quarter (28%) of survey respondents reported having had contact with King County Solid Waste Division staff, down slightly from 2002 (31%).
- Residents from Rural East King County (35%) were most likely to have had contact with King County staff, followed by Eastside residents (29%).
- Overall satisfaction levels with King County Solid Waste Division customer service were high. Primarily, residents reported being "very satisfied" (49% with a rating of 7 on a sevenpoint scale) or "satisfied" (33% with a rating of 6 on a seven-point scale) with the service they received. Residents of Rural East King County (85%) reported the highest ratings for the service they received.
- Residents of unincorporated King County (85%) reported higher satisfaction levels (rating of "satisfied" or "very satisfied") than residents living in incorporated King County (80%).

Yard Maintenance and Waste Handling

- Curbside yard waste recycling is the disposal method used most for grass clippings (34%) and yard waste consisting of brush trimmings, leaves, and other yard waste besides grass (46%). These levels remain consistent with last year (34% and 45%, respectively).
- In North King County, 45% of residents reported curbside yard waste recycling as their method for handling grass clippings, while only 21% of residents of Rural East King County reported using this method.
- Using a compost bin or pile is the second most common method for managing grass clippings (26%) and other yard waste (26%), similar to last year's findings (27% and 30%, respectively).
- Down from last year (59%), about half (52%) of the respondents said they would be willing to separate their food waste from other garbage, if it could be collected for recycling at no additional cost. Reported willingness was similar for residents living in incorporated (52%) and unincorporated (55%) King County.

Computer and Television Recycling

- Most respondents reported that they did not have a home computer (75%) or television (84%) they no longer used and were currently storing. Those living in single-family homes were more likely to store non-working computers (26%) or televisions (17%) than those residents living in multi-family buildings (computers, 11%; televisions, 5%).
- The option most preferred for disposing of unwanted computers in the past year was donation (29%), similar to last year (33%). The second most preferred option was giving the computer away to friends or family (14%), as was the case in 2002 (14%).
- When asked their preference of recycling options for broken computers, 42% reported that taking it to a local transfer station would be most convenient, and 41% preferred taking it to a local computer or electronics store.
- Similar to computer recycling, donation was the preferred option for television recycling (28%), similar to last year (33%). The second choice was taking the television to a transfer station (25%).
- When asked who should pay for the proper disposal of computers, televisions, or other harmful electronic items, the consumer was cited most often (47%), followed by the manufacturer (28%) and the government (10%). In 2002, the figures were 48%, 18%, and 15%, respectively.
- Most respondents stated that they preferred to pay a recycling fee when they were ready to recycle the equipment (77%) rather than when they purchased the equipment (19%).

Internet Use

- Less than one-third of residents (31%) have visited the King County website, down from 2002 (38%) but equal to year 2000 results.
- The King County website has received a similar amount of traffic among the four geographic areas defined for this study (between 29% and 33%). However, significantly more residents from unincorporated King County (39%) reported visiting the website than those in incorporated King County (28%).
- About one third (33%) of those respondents visiting the King County website sought information about garbage service and recycling. Only a slight difference existed between

incorporated (32%) and unincorporated (35%) King County residents visiting the website for this information.

 When comparing the four geographic areas, considerably more residents of North King County (45%) reported visiting the King County website for information regarding garbage and recycling than residents of the other three areas (between 30% and 33%).

Demographic Comparisons

- Characteristics of the typical respondent varied considerably, and no single characteristic clearly correlated with waste disposal preferences.
- Most residents reported current annual household income being between \$50,000 and \$74,999 (25% of those providing this information) and residing at their current address for less than three years (28%).
- The Eastside had the largest percentage of residents (31%) who resided in their current home for less than three years, followed by Rural East King County residents (28%).

Additional Comments

Nearly one-third of those surveyed, or 174 of 601 residents (29%), provided additional comments. The two comments mentioned most often (4%) were positive: one, encouraging King County to "keep up the good work", and two, thanking the County and commending them on doing a good job. However, comments regarding cost and price concerns (4%) also surfaced, such as the rates being too high and the lack of free recycling services.

Chapter 4. Key Findings

The following are the key findings of the study by the nine major areas of investigation mentioned previously.

4.1 CURBSIDE GARBAGE SERVICE

Use of Household Garbage Service

Overall, in the past two years, the majority of residents have used curbside garbage services. Approximately nine in ten residents both years (2003: 91%; 2002: 89%) had their garbage picked up at their home or building by a garbage service.

As illustrated in Table 4-1, significantly more residents living within incorporated King County reported taking advantage of curbside garbage service (93%) versus unincorporated King County residents (85%).

As shown in Table 4-2, curbside garbage service use appeared to increase among geographic areas since 2002, with the exception of South King County. Considerable change took place in Rural East King County (85%) where use of this service increased by 11 percentage points. However, among geographic areas, Rural East King County showed the lowest percentage of residents using curbside garbage service. In addition, South King County (86%) residents were significantly less likely to use curbside garbage service than North King County (97%) and the Eastside (96%).

Also important to note is that all residents who use yard waste services (100%) and almost all who use curbside recycling services (98%) opted for curbside garbage service.

Of residents in both single-family homes (91%) and in multi-family buildings with more than four units (91%), nine in ten choose to have their garbage picked up by a garbage service. Even though dwelling type did not appear to influence curbside garbage service use, differences appear among salary and length of residency categories. Those who reported annual household incomes of \$50,000 or more (\$50K to \$100K: 91%; \$100K or more: 96%) were significantly more likely to use curbside garbage service versus those making between \$30,000 and \$50,000 (82%).

Those residing in one location between six and twenty years (92%) were significantly more likely to use curbside garbage service than those living in a certain location for twenty years or more (82%).

Satisfaction Level with Garbage Service

Overall satisfaction levels with curbside garbage service remained the same as last year, with 86% of residents agreeing the service provided was satisfactory (rating of seven or six on a seven-point scale) (please view Table 4-3).

High satisfaction (rating of six or seven on a seven-point scale) was also expressed across all four geographic areas: South King County (89%), Rural East King County (88%), Eastside (86%), and North King County (75%). In terms of those who were satisfied (rating of six) with their curbside garbage service, significantly more Rural East King County residents (55%) were satisfied than residents of the other three geographic areas: Eastside (35%), North King County (33%), South King County (41%). It is important to note that sample sizes for Rural East King County (n=66) and North King County (n=33) are very small.

Residents in incorporated and unincorporated King County had similar levels of satisfaction: over eight in ten (86% for both) residents were consistently satisfied (rating of seven or six on a seven-point scale) with their curbside garbage service this year and last year.

Satisfaction levels with curbside garbage service were high among all housing types and geographic areas with over eight in ten residents expressing satisfaction (rating of seven or six on a seven-point scale) as well as among residents whether they also preferred curbside recycling (87%) or curbside yard waste (88%) services or using the transfer station for such items: garbage (83%), recycling (87%), and composting (88%).

Respondents holding residency in one home for more than six years were significantly more likely to report satisfaction (rating of seven or six on a seven-point scale) with their curbside garbage service (90%) than those living in one home for five years or less (82%).

Higher satisfaction not only appeared with respondents who held longer residences, but also those who were 65 years of age or older. These older residents were more likely to be satisfied (97% rated seven or six on a seven-point scale) with their curbside garbage service than those respondents between 18 and 64 years of age (81%).

4.2 TRANSFER STATIONS

Garbage Disposal at Transfer Stations

FREQUENCY OF VISITS TO TRANSFER STATION

Overall, half of King County residents (53%) reported never taking their garbage to a transfer station in the past year (please see Table 4-4). As in 2002, residents living in unincorporated King County (56%) continue to be more likely to have taken garbage to the transfer station within the past year than those residing in incorporated King County (43%). These figures show a decrease in the gap between the two areas from 2002: 59% for unincorporated and 38% for incorporated. Use of transfer stations (46%) has increased slightly from last year (44%).

About half the residents from each geographic area reported never disposing of garbage at transfer stations in the past year (Eastside at 56%, North King County at 53%, South King County at 52%, and Rural East King County at 49%). In terms of those who did use transfer station services, it is important to note that South King County (48%) and Rural East King County residents (51%) were more likely to deliver garbage to transfer stations than those from the Eastside (44%) and North King County (47%). Compared to last year, more Eastside (37% in 2002) and South King County (47% in 2002) residents reported using a transfer station. However, the percentage of North King County (58% in 2002) and Rural East King County (57% in 2002) residents who visited their transfer station declined since the previous year. North King County's usage rate dropped considerably, by 11 percentage points.

This past year, the majority of residents living in multi-family buildings (87%) reported never using a transfer station for garbage disposal. Residents of single-family homes (48%), on the other hand, were significantly less likely to have never taken garbage to a transfer station in 2003. In fact, residents of single-family homes (52%) outnumbered multi-family building residents (13%) by nearly 40% for taking garbage to a transfer station at least once in the past year.

In addition residents 65 and older were significantly more likely to never use transfer station facilities (73%) than those between 18 and 64 years of age (50%). Similarly, renters (79%) were significantly less likely to visit transfer stations for garbage disposal than homeowners (48%).

REASONS FOR DISPOSAL OF GARBAGE AT A TRANSFER STATION OR LANDFILL*

The primary reason residents reported using transfer stations was to dispose of large volumes of garbage (41%), or garbage that was not accepted by garbage services because it was too large(26%) (please view Table 4-5). Therefore, transfer station use appears to be substantial due to garbage limitations and not for reasons such as price or convenience. Price (6%) and convenience (5%) were mentioned as reasons by a relatively small number of respondents for visiting transfer stations for garbage disposal.

Recycling at Transfer Stations

As with garbage, the majority of residents (73%) in the past year chose not to haul recyclables to transfer stations, as seen in Table 4-6. This figure is consistent with 2002 responses (71%). Less than 10% of those surveyed reported recycling at the transfer station more than four times over the past year.

Significantly more residents in incorporated King County (75%) than in unincorporated King County (67%) reported not visiting a transfer station for recycling in the past year. Compared to last year, about the same percentage of residents in incorporated King County reported never using transfer stations for recycling (76% in 2002 and 75% in 2003). Though transfer station usage for recycling for unincorporated King County was greater this year (67%) than last (58%).

Residents living on the Eastside (22%) and in North King County (18%) were significantly less likely to use a transfer station for recycling than residents living in South King County (32%) and Rural East King County (35%). (Data from 2002 regarding the four geographic areas and recycling at transfer stations is not available.)

Residents living in multi-family buildings were significantly more likely to avoid transfer stations for recycling (85%) than residents of single-family homes (71%).

The two aspects that may have influenced decisions regarding the disposal of recyclables were gender and ownership. Significantly more females (77%) than males (68%) and significantly more renters (81%) than homeowners (71%) decided not to take recyclables to a transfer station.

The majority of residents who used curbside garbage (77%), recycling (78%), and yard waste (76%) services did not take their recyclables to a transfer station in the past year. Interestingly, over half the residents who take their garbage (56%) to a transfer station and participate in composting (65%) did not dispose of their recyclables at a transfer station.

4.3 CURBSIDE AND MULTI-FAMILY RECYCLING SERVICES

Single-family Recycling Services

Among residents living in single-family homes or buildings with four units or less, over threequarters (84%) participated in curbside recycling services. This amount shows a slight decrease from last year (88%). As shown in Table 4-7, of the 16% who did not participate in curbside recycling, their reasons primarily consisted of wanting to haul their own recyclables (23%), perceiving the service as too expensive (22%), and reporting the service as unavailable in their area (16%). Seven percent more residents mentioned cost -- a larger concern than in any of the preceding years -- this year (22%) than last year (15%).

Based on Q22: Why do you choose not to participate in curbside recycling services?

The overall decision to haul their own recyclables this year was mentioned by 53% of Rural East King County residents as compared to only 20% of Eastside and 15% of South King County residents. However, the decision to participate in curbside recycling at all was made by significantly more Eastside (92%) and North King County (93%) residents than South King County (76%) and Rural East King County (77%) residents. Rural East King County on the other hand, was the only location where more residents this year (77%) than last (75%) decided to participate in curbside recycling. Residents in the other three geographic areas reported less participation, particularly those in South King County, where participation decreased from 86% in 2002 to 76% in 2003 (please see Table 4-8). However, due to small sample sizes, statistically significant conclusions cannot be drawn regarding geographic regions.

Based on Q.21: Do you participate in recycling service at your home?

As expected, residents who did participate in curbside recycling (84%) also participated in curbside garbage (92%) and yard waste (95%) services. However, a high percentage of those who participated in curbside recycling also participated in transfer station garbage (80%) services as well as recycling services (68%). Only 32% of respondents not participating in curbside recycling reported using the recycling services at a transfer station in the past year. Composting was also conducted by a large majority (81%) of curbside recycling residents.

SATISFACTION LEVEL WITH CURBSIDE RECYCLING SERVICES

Respondents living in single-family homes or buildings with four units or less and who participated in curbside recycling were asked to rate their overall satisfaction with their curbside recycling service on a scale of 1 to 7, where 1 represented "very dissatisfied" and 7 represented "very satisfied."

As shown in Table 4-9, curbside recycling was rated as satisfactory (a rating of seven or six) by over eight in ten respondents (86%), which represents a large increase from last year (78%).

In accordance with overall ratings, incorporated and unincorporated King County residents' satisfaction levels also increased. Incorporated King County Residents were more satisfied this year (86%) than last (80%), as were those in unincorporated King County (87% in 2003 and 74% in 2002) (please see Table 4-10).

Among the four geographic areas, Rural East King County (93%) residents appeared to be the most satisfied (rating of seven or six) with their curbside recycling service, though the three other areas, Eastside (86%), North King County (85%), South King County (85%), also reported high satisfaction (please see Table 4-11).

A larger percentage of very satisfied (rating of seven) ratings were given by females and those who were 65 years old or older. Females were significantly more likely to say they are very satisfied with their curbside recycling service (58%) than males (44%), while residents 65 years old or older were significantly more impressed with their curbside recycling service (64%) than those between ages 25 and 44 (45%).

Multi-family Recycling Services

Approximately three-quarters (76%) of those living in buildings with more than four units are being provided with recycling service at their building, a slight increase from last year (72%). Among those who receive this service, 93% participate. As seen in Table 4-12, reported participation has decreased from 100% in two geographic areas compared to last year: Eastside at 90% and South King County at 95%. All respondents living in North King County (100%) and Rural East King County (100%) reported that they participate in their building recycling service if it is offered.

Recycling and Disposal Knowledge

Among those who participated in curbside recycling, 91% reported junk mail as the number one item being accepted by their recycling program (please view Table 4-14). Following far behind were pizza boxes (43%), plastic bags (30%), plastic trays from frozen foods (28%), used paper plates and napkins (27%) and window glass (17%).

Junk mail, the most commonly recognized recyclable item this year at 91%, was slightly greater than last year (89%). Similar to previous years, window glass and used paper plates and napkins were both mentioned least as recyclable by residents this year (27% and 17%, respectively).

4.4 KING COUNTY SERVICES

Contact with King County's Solid Waste Division Staff

Contact with King County Solid Waste Division staff in the past year (28%) has decreased slightly from last year (31%) (please see Table 4-15). Among those residents who have had contact with King County staff, residents in unincorporated King County had the most contact (32%) compared with residents of incorporated King County (27%). Of the four geographic areas, Rural East King County residents (35%) reported more contact with the County staff. South King County residents reported considerably less contact (26%).

Those who reported having contact with Solid Waste Division staff were more likely to have used the transfer station than curbside service for garbage (39%) and recycling (46%).

In terms of demographics, males (33%) were significantly more likely than females (24%) to have had contact with King County Solid Waste Division staff in the past year. In addition, residents living in one home for eleven years or more (36%) were significantly more likely to have had communication with County staff than those holding a residency for up to five years (22%).

Satisfaction Level with Customer Service from Solid Waste Division

All respondents who have had contact with the King County Solid Waste Division staff were asked to rate their overall satisfaction with the level of customer service received from the staff on a scale of 1 to 7, where 1 represented "very dissatisfied" and 7 represented "very satisfied."

A total of 82% of respondents reported being "very satisfied" or "satisfied" with the customer service received from the King County Solid Waste Division staff (rating of seven or six). The percentage of respondents reporting satisfaction ratings of a seven or six (82%) decreased slightly from last year (84%). These results are displayed in Table 4-16.

Unincorporated King County respondents (85%) expressed satisfaction (rating of seven or six) with the customer service provided more frequently than the incorporated King County respondents (81%). Rural East King County (85%) and South King County (84%) areas showed more satisfied residents than North King County (75%) and the Eastside (79%) areas. Interestingly, over half of the residents who were very satisfied (rating of seven) with the customer service they received from the King County Solid Waste Division staff, reported not receiving curbside garbage service (68%). Additionally, those who held residency for 20 years or more (69%) were significantly more likely to give a very satisfied rating (rating of seven) than those living in one location for either three to five years (39%) or 11 to 20 years (37%).

Awareness of 'Waste-Free Holidays' Program

A new question added for the 2003 study was used to measure residents' awareness of King County's 'Waste-Free Holiday' program. Overall, a total of 16% of respondents indicated they have heard of this program (please see Table 4-17).

4.5 YARD MAINTENANCE AND WASTE HANDLING

Management of Grass and Yard Waste

Respondents living in single-family homes were asked what methods they use to dispose of grass clippings, brush trimmings, leaves and other yard waste

The two primary methods residents used to discard grass clippings and other yard waste this year and in 2002 were curbside yard waste recycling and use of a compost bin or pile. Grass clippings were also likely to be left on the lawn, although slightly less likely this year (21%) than in 2002 (26%) (please see Table 4-18).

Incorporated King County residents were significantly more likely to choose curbside yard waste recycling for both grass clippings (37%) and other yard waste (51%) than unincorporated King County residents (27% for grass clippings -; 35% for other yard waste). However when considering the use of compost bins or piles for both materials, more unincorporated King County residents selected that method (29% for grass clippings; 37% for other yard waste) than residents living in incorporated King County (25% for grass clippings; 21% for other yard waste).

Compared to last year (23%), compost bin or pile usage for grass clippings by incorporated King County residents changed minimally (25%), but for unincorporated residents there was a decrease from 35% to 29%. Conversely, using a compost bin or pile for other yard waste by incorporated King County residents (21% in 2003; 27% in 2002) decreased yet increased for unincorporated residents (2003: 37%, 2002: 35%).

While curbside yard waste recycling was the method preferred for grass clippings by significantly more North King County residents (45%) than Eastside residents (41%) for disposal of grass clippings, this same method was selected by significantly more Eastside

residents (55%) than South King County (40%) and Rural East King County residents when it came to other yard wastes (30%).

Even though the method of using a compost bin or pile for discarding grass clippings was not mentioned by a significant percentage of residents in the four geographic areas, it was mentioned for disposal of brush trimmings, leaves and other yard waste by significantly more Rural East King County residents (36%) than Eastside residents (21%).

Length of residency may have had an influence on residents' decisions to use a compost bin or pile for grass clippings. Residents who had lived in the same location for 20 years or more were significantly more likely to indicate using this method (42%) as compared to those living at the same location between three and ten years (21%). Compost bin or pile use for other yard waste was also chosen by significantly more residents living in one home between three to five years (28%) and 11 to 20 years (34%) than those residing in their home for less than three years (17%).

Composting Yard and Food Waste at Home

Respondents living in single-family homes or buildings with four units or less who did not mention using a compost bin or pile for grass clippings or yard waste were asked whether they compost their yard and food waste at home, and if they would be willing to separate their food waste from other garbage for composting. Table 4-19 displays the results of this question.

Although composting of yard waste (20%) decreased since last year (36%), composting of food waste (20%) increased slightly (19%). Resident willingness to separate food waste from other garbage decreased considerably from 59% in 2002 to 50% in 2003.

Composting of both food and yard waste was done by significantly more Rural East King County residents (29% and 43%, respectively) than South King County (16% and 18%, respectively) and Eastside (16% and 17%, respectively) residents. With regards to composting yard waste, Rural East King County residents significantly outnumbered North King County residents (16%).

Significantly more respondents holding residency for more than three years (24%) were more likely to compost yard waste at home than those owning or renting for less than three years (10%). Food waste was composted by significantly more residents who had been living in their

current home for 20 years or more (36%) than those holding occupancy for less than 20 years (15%).

4.6 COMPUTER AND TELEVISION RECYCLING

Over three-quarters of residents reported not having a home computer (75%) or television (84%) that was being currently unused and stored. The remaining residents who did own at least one of those items (25% for computers; 16% for televisions) were more likely to be living in single-family homes (27% for computers; 17% for televisions) than in multi-family buildings (11% for computers; 5% for televisions).

Among those who did store a computer(s) or television(s) that were no longer in use, donation appeared to be the primary choice both this year (computer, 29%; television, 28%) and in 2002 (33% for both) for disposal of such products (see Table 4-20). However, this year, slightly fewer residents selected this method. Also, both this year and last year almost one-quarter of residents surveyed did not know what to do with their unwanted computer(s) or television(s) (23% and 15%, respectively, in 2003 -; 17% and 16%, respectively, in 2002).

It appears the preferred methods for computer recycling is split between transporting computers to the transfer station (42%) or a local computer/electronics store (41%), since a very small segment of residents chose other methods (send back to manufacturer - 3%, Donate - 2%, etc.) (please see Table 4-21).

Assuming a fee was charged to the consumer for proper recycling or disposal of televisions and computers, an overwhelming number of residents preferred to pay the fee when the equipment is recycled (77%) rather than when it was purchased (19%).

As illustrated in Table 4-22, each year, about half of all respondents thought the consumer should pay the fee needed to ensure products are safely recycled or disposed. The next most common responses were manufacturer (28%) and the government (10%). Those 25 years old or older were significantly more likely (49%) than those 18 to 24 years old (26%) to say it is the consumer who should pay the fee to ensure safe recycling or disposal.

4.7 INTERNET USE

As seen in Table 4-23, nearly one-third of residents have visited the King County website this year (31%) and a third of these respondents visited the website for information on garbage service and recycling (33%). The rate of general visits to the website decreased from last year (38%), to a level consistent with 2000 (31%).

Last year (71%) and in 2000 (65%), the majority of residents stated they had visited the King County website to obtain information about garbage service and recycling.

Residents of unincorporated King County were significantly more likely (39%) than incorporated King County residents (28%) to visit the King County website for general information. For garbage and recycling service information, 35% of residents in unincorporated King County visited the website compared to 31% in incorporated King County.

Those living in single-family homes (34%) were significantly more likely than residents of multifamily buildings (16%) to visit the King County website for information on garbage and recycling services. Because multi-family sample sizes were small, conclusions are not statistically significant.

4.9 COMMENTS FROM PARTICIPANTS

Overall, only 174 of 601 residents made final comments. Each final comment made was only cited by less than five percent of residents (please see Table 4-24). Residents mainly thanked the staff members and encouraged them to keep up the good work (4%). However, residents also voiced cost and price concerns, such as rates being too high and that recycling should be offered for free (4%).





Q10. Do you have garbage picked up at your home or building by a garbage service? (Incorporated versus Unincorporated areas)




Curbside Garbage Service Q10. Do you have garbage picked up at your home or building by a garbage service? (Geographic areas within King County)



Q11. How satisfied are you with your garbage service? Would you say you are . . . (Incorporated areas)







Q11. How satisfied are you with your garbage service? Would you say you are . . . (Geographic areas within King County)





Q12. How many times in the past year did you or someone from your household take your garbage to a transfer station? (Incorporated versus Unincorporated areas)





Q12. How many times in the past year did you or someone from your household take your garbage to a transfer station? (Geographic areas within King County)



Q13. What is the main reason you take household garbage yourselves to a transfer station or landfill? (Incorporated versus Unincorporated areas)




Transfer Stations Q13. What is the main reason you take household garbage yourselves to a transfer station or landfill? (Geographic areas within King County)



Q15. How many times in the past year did you or someone from your household take materials to the recycling areas at the transfer station? (Incorporated areas)




Transfer Stations Q15. How many times in the past year did you or someone from your household take materials to the recycling areas at the transfer station? (Unincorporated areas)



Q15. How many times in the past year did you or someone from your household take materials to the recycling areas at the transfer station? (Geographic areas within King County)



















Q102. How many years have you lived at your present residence? (Geographic areas within King County)

APPENDIX B METHODOLOGY

The overall purpose of this research is to:

Explore behaviors and attitudes about household waste disposal, recycling and waste reduction among residents of King County for the King County Solid Waste Division.

In order to explore behaviors and attitudes about household waste disposal, recycling and waste reduction among residents of King County for the King County Solid Waste Division, Market Trends, Inc. of Seattle, Washington, conducted a telephone study of 601 adult residents of King County. Respondents resided in both incorporated and unincorporated areas of the county, but excluded those who live in the City of Seattle. The study was conducted from January 9 to January 27, 2003.

The 2003 study focused on nine major areas of investigation. These are listed below.

- **4.1 Curbside Garbage Service** This section examines the use of and satisfaction with curbside garbage service.
- **4.2 Transfer Stations** This section analyzes the usage of and satisfaction with garbage and recycling at transfer stations.
- **4.3 Curbside and Multi-Family Building Recycling Services** This section examines the decision to participate or not participate in curbside recycling, and the satisfaction levels of those who do participate.
- **4.4 King County Services** This section assesses the number of residents who have had contact with King County's Solid Waste Division staff and their satisfaction with the customer service received.
- **4.5 Yard Maintenance and Waste Handling** This section analyzes compost use in lawn and gardens, management of grass clipping and yard waste, compost bin use, and food waste composting.
- **4.6 Computer and Television Recycling** This section assesses methods residents would use to dispose of unwanted computers and televisions.
- **4.7 Internet Use** This section examines usage of the King County website, particularly to obtain information about garbage and recycling.
- **4.8 Demographic Comparisons -** This section summarizes differences in findings among the four broad geographic areas in which King County residents are grouped: south, eastside, north, and rural east.
- **4.9 Additional Comments** This section covers final comments that were commonly provided by survey respondents.

From January 9 to January 27, 2003, Market Trends, Inc. conducted a telephone study consisting of the following.

- 1. A total of 601 Computer Assisted Telephone Interviews (CATI) were conducted among 432 residents of a city or town in King County and 169 residents of unincorporated King County.
- 2. Adults 18 years of age or older who reside in unincorporated King County or in incorporated areas of King County with the exception of City of Seattle residents.
- 3. Survey Sampling, Inc. (SSI) provided a random-digit sample of telephone numbers. Phone numbers were drawn randomly over all of King County, proportionate to population, excluding those who reside in the City of Seattle.
- 4. Questionnaire design is adapted from previous Waste Reduction and Recycling questionnaires by GMA Research in conjunction with staff from the King County Solid Waste Division, PRR, and Cascadia Consulting Group.
- Definition of scale used: Satisfaction scales measure residents' overall satisfaction with their garbage service, curbside recycling service, building recycling services, and level of customer service received from King County's Solid Waste Division staff. 7=Very satisfied, 6=Satisfied, 5=Somewhat satisfied, 4=Neither satisfied nor dissatisfied, 3=Somewhat dissatisfied, 2=Dissatisfied, 1=Very dissatisfied.
- 6. A total of 7,976 contacts were made to collect 601 completed interviews among 432 residents of a city or town in King County and 169 residents of unincorporated King County. A summary of calls made and their outcome is outlined in the following table.

The overall sample size of 601 yields a confidence interval of +/-4.0 percent, which means that the results have a 95 percent chance of coming within +/-4.0 percentage points of the results that would have been obtained if a census of all qualified individuals had been taken.

7. Changes made to the 2002 questionnaire are outlined in the following table. The table is organized so changes can be tracked since the 1997 study to 2003 and is based on questions as reported in the final report documents for each study. The first column lists the question number. To the right is the question. Each of the following columns shows which questions, those marked with an "x," were included in each year's survey.
