


NERTS Project Overview



Role of transfer stations

- Receive & prepare waste and recycling materials for transport
- Provide local drop-off locations for consolidation and transfer of materials to regional facilities
 Provide more efficient transport of waste and recycling materials



Why is King County siting a new transfer station?

Existing Houghton Station is outdated

Lacks adequate queuing space
 Lacks space for recycling services
 Lacks ability to compact waste
 Lacks space for waste storage in the event of a major regional disaster



Role of SAG in Siting Process

Advise King County staff from a community perspective
 Identify community criteria for screening sites
 Review potential sites and provide feedback
 Share information with their community and share feedback about concerns, impacts and aspirations
 Provide input on criteria weighting
 Provide King County staff with outreach advice such as reviewing materials and identifying additional groups to contact



Community Criteria Process

Step	Description	When
P Community values	Gather input on community values from SAG and community	Oct 5 – Nov 20 (SAG kickoff & survey)
P Community criteria	Turn values into community criteria	SAG 2 and 3
P Weight criteria	Validate, prioritize & weight community criteria	SAG 3 and 4
P Scoring sites	Apply community criteria to top 4 Sites using measurement scales	Between SAG 3 and 4
ü Evaluation discussion	Review results and adjust weighting as needed	SAG 5
ü Site ranking	Confirm ranking of 4 Sites based on community criteria	SAG 5
Environmental review	Up to 3 top-ranked sites go into environmental review	Spring 2021




16111 Woodinville Redmond Rd NE, Woodinville




Rationale to advance site to environmental review: 16111 Woodinville-Redmond Rd NE, Woodinville

- Suitable size and shape
- Located in close proximity to transportation corridors and other transfer facilities
- Good sloping for ease of building







7024 116th Ave NE, Kirkland

- Park and Ride is underutilized
- Property is minimally developed
- In a good location
- Close to the transfer station corridor and major freeways

State Environmental Policy Act (SEPA)


- SEPA provides information to agencies, applicants, and the public
- Identification and evaluation of probable environmental impacts, and the development of mitigation measures to reduce impact
- Environmental review is just one part of the decision-making process

Utilizing a six-step process to identify a range of sites and narrow it down to a preferred site.





SEPA Public Participation - Scoping

- Community and agencies will comment on:
 - The range of alternatives
 - Areas of impact or benefit
 - Possible mitigation measures that should be evaluated within the EIS
- S King County will:
 - Formalize the alternatives
 - Narrow elements of the built and natural environment evaluated in the EIS to just those that may be significantly impacted



Preparation of draft environmental impact statement

S King County and consultant team will:

- Analyze selected alternatives for built and natural environmental impacts
- Identify significant adverse environmental impacts of each alternative
- Identify potential reasonable mitigation measures to address unavoidable significant adverse environmental impacts of each alternative
- Document findings of analyses in a draft environmental impact statement




Public Participation – Draft EIS

Sommunity and agencies will review document and comment on:

- Adequacy of the environmental analysis
- Proposed potential mitigation measures
- Sking County will:
 - Review comments
 - Consider additional analyses or modifications to project proposal
 - Make factual corrections
 - Explain why a comment does not warrant further response
 - Prepare final EIS



Input in Decision-Making Process



Next Steps in Environmental Review

Threshold Determination and Scoping
Initiation of Technical Documentation to Support DEIS, such as:

- Air quality
- Cultural Resources
- Hazardous Materials
- Noise

- Critical Areas
- Water Resources
- Visual Quality
- Transportation



Community involvement in EIS



Goals of community involvement

1. <u>Ensure potentially affected communities understand</u> what a transfer station is and the need for a new station in Northeast King County.

2. <u>Ensure community members understand, feel welcomed, and know how</u> <u>to engage</u> in King County's public process to site a new transfer station.

3. <u>Engage residents, businesses, and property owners</u> in the core cities (Sammamish, Woodinville, Kirkland, Redmond) and unincorporated King County in the process to find a facility location that best suits community and County needs.

Goals of community involvement

4. <u>Proactively engage communities and affinity groups that are</u> <u>traditionally underrepresented and/or underserved</u> and ensure their perspectives, interests, concerns, and aspirations are understood, considered, and responded to in the decision-making process in accordance with King County's Equity and Social Justice Action Plan.

5. <u>Build and cultivate relationships with key community</u> stakeholders to ensure communities maintain interest and participation throughout the site selection and facility design process.
