
Juanita Bay Pump Station Replacement Project CONSTRUCTION UPDATE

February 2008

To ensure safe, reliable wastewater services for a growing population, the King County Wastewater Treatment Division is replacing the Juanita Bay Pump Station. The new pump station will protect public health in your community for the next 40 years.

Pump Station Foundation Complete, Walls Going Up

King County's contractor is now building the above ground pump station structure. Crews will continue electrical work and will install the pump station's heavy machinery (pumps, motors, generators and odor control equipment) through the winter. Restoration, testing and the station's connection to the regional wastewater conveyance system will occur later.



Landscaping Update

To protect safety and prevent property damage, King County will remove four Leyland Cypress trees at the southeast corner of the new pump station site. The trees received increased sunlight after pre-existing structures on the construction site were demolished and became too large for the confined space between the pump station fence and the neighboring condominium. The trees' rapid growth makes maintaining them difficult and potentially dangerous. King County is working with the condominium residents and the City of Kirkland to revise the landscaping plan.

Safety First

King County urges pedestrians to obey sidewalk closures and use extreme caution when passing by the worksite. Park users are urged to avoid entering the construction staging area or the park west of Juanita Creek for the duration of the project.

Drivers: please heed speed limits and be aware of pedestrians, bicyclists, and construction activities around the intersection of Northeast Juanita Drive and 93rd Avenue Northeast. Driving sight distances are limited near the site, especially heading eastbound on Northeast Juanita Drive. Please drive safely!

Juanita Bay Pump Station Replacement Project

What to Expect

Crews will build the ground level of the pump station and continue work inside the structure

- Work will generally occur 7 a.m. 5 p.m. on weekdays, and occasionally on Saturdays from 9 a.m.
 6 p.m.
- Some night work in spring and summer 2008 when crews connect the new pump station to existing wastewater pipelines and to Puget Sound Energy's power line.
- Trucks will continue to deliver concrete and other materials to the work site. Please use extra caution when passing near the work area.
- A moderate increase in noise level will occur with ongoing construction at ground level.
- The new pump station is scheduled for completion in Summer 2008.
